21	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23	SECTION 1. Arkansas Code § 5-13-213 is amended to read as follows:
24	5-13-213. Aggravated assault against first responder or public transit
25	employee.
26	(a) A person commits aggravated assault against a first responder <u>or</u>
27	<pre>public transit employee if:</pre>
28	(1) The person knowingly causes physical contact with a first
29	responder or public transit employee by spitting, throwing, or otherwise
30	transferring bodily fluids, pathogens, or human waste onto the person of the
31	first responder <u>or public transit employee</u> or by throwing an object such as a
32	brick, rock, bottle, projectile, firework, chemical agent, or explosive
33	device that a reasonable person knows or should know could cause physical
34	injury if the object struck the first responder or public transit employee;
35	and
36	(2) The physical contact:

1	(A) Results in serious physical injury to the first
2	responder or public transit employee;
3	(B) Involves the use of a deadly weapon;
4	(C) Involves the display of a firearm in such a manner
5	that the display of the firearm creates a substantial danger of death or
6	serious physical injury to another person; or
7	(D) Involves strangulation or attempted strangulation.
8	(b) Aggravated assault against a first responder or public transit
9	employee is a Class C felony with a mandatory fine of ten thousand dollars
10	(\$10,000) and a mandatory minimum sentence of at least ninety (90) days'
11	imprisonment for which the defendant is required to serve at least ninety
12	(90) days before being released from imprisonment.
