3	REQUESTING THAT THE HOUSE COMMITTEE ON JUDICIARY STUDY THE
4	RESPONSIBILITY FOR AND ALLOCATION OF FUNDING FOR TRAVEL EXPENSES
5	FOR PUBLIC DEFENDERS IN RURAL COUNTIES OR PUBLIC DEFENDERS WHO
6	ARE ASSIGNED TO MULTICOUNTY JUDICIAL DISTRICTS.
7	
8	WHEREAS, many public defenders who are assigned to rural counties or
9	public defenders who are assigned to a multicounty judicial district are
10	required to travel a great deal and can incur large travel expenses; and
11	
12	WHEREAS, under § 16-87-302 the Arkansas Public Defender Commission is
13	required to pay for certain expenses of public defenders and rural counties
14	or multicounty judicial districts are required to pay for certain expenses
15	"necessary to the effective and efficient operation of the public defender's
16	office". However, travel is not explicitly referenced; and
17	
18	WHEREAS, oftentimes, a public defender's travel expenses exceed what
19	the county is able to pay, especially for a public defender assigned to a
20	rural county or a multicounty judicial district; and
21	
22	WHEREAS, the nature of being a public defender requires travel to see
23	clients, many of whom are incarcerated in county jails and are unable to
24	travel to see their assigned public defenders; and
25	
26	WHEREAS, currently, in order to provide the very best and effective
27	defense to a client, a public defender assigned to a rural county or a
28	multicounty judicial district is forced to make difficult choices regarding
29	travel and travel expenses, oftentimes putting the public defender or his or
30	her client, or both the public defender and client, in a disadvantaged
31	position; and
32	
33	WHEREAS, the interests of fairness and justice should require that a
34	public defender not be forced to compromise his or her effective
35	representation of an indigent client due to underfunding of the public
36	defender's travel expenses,

2	NOW THEREFORE,
3	BE IT PROPOSED BY THE HOUSE COMMITTEE ON JUDICIARY OF THE NINETY-FIRST
4	GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
5	
6	THAT the House Committee on Judiciary study the funding responsibility,
7	allocation, obligations, mechanisms, and possible solutions to the
8	underfunding of public defender travel expenses.
