Act 1494 Energy Efficiency and Natural Resource Conservation in Public Buildings



"Lead by Example"

Implements ASHRAE 90.1 2007 and

Develops an Energy Management Program

April 14, 2009 – Act 1494 signed into law

January 1, 2011 – Rules for Act 1494 became effective

April 1, 2011 – Amended Act with Act 803 of 2011

October 31, 2011- First Data Call for Energy Usage and Costs

December 1, 2011-Annual report due to the Legislative Council

June 30, 2014 – 20% reduction target deadline

(1) Costs of implementing energy efficient and water-efficient building standards

- (2) Operating savings attributable to the implementation of energy-efficient and water-efficient building standards
- (3) Impact on employee productivity from the application of the standards
- (4) An evaluation of the effectiveness of the application of the standards

(1) **Costs of implementing** energy efficient and water-efficient building standards

- ASHRAE 90.1 2007 estimated to increase costs less than 1% of total building costs.
- Training costs for Design Engineers and Architects on the new standard
 - Training classes, \$25,000 (8 classes regionally)
 - Travel instate to speak about the Act

(2) **Operating savings** attributable to the implementation of energy-efficient and water-efficient building standards

- Study by the University of Arkansas shows the payback for ASHRAE 90.1 2007 to be from startup to about 6 years depending on building type.
- Act 1494 is 10% more stringent than this standard.
- No designs submitted so far.

(3) **Impact on employee productivity** from the application of the standards.

- Agencies and Institutions are forming energy management teams to monitor energy efficiency and increase awareness
- Metrics for measuring the impact of energy efficiency programs on consumers/employees are available. A study for Act 1494 would need to be funded.

(4) An **evaluation of the effectiveness** of the application of the standards.

- It will take a long time to see the effect of the code changes.
- Both State Agencies and Higher Education are participating in developing the **Energy Management Program**.

 - About \$200,000 for training classes
- Establish baseline and track energy usage and costs with Energy Star Portfolio Manager (ESPM) for over 22 million square feet and over 2500 buildings
 - Almost \$700,000 so far for training, developing and auditing

Recommendations

Recommendation: Establish an **Energy Manager position** at the Arkansas Energy Office to continue implementation of Act 1494. Current funding ends March, 2012.

ABKANS

Recommendation: Continue working with agencies and institutions to implement **StEPs** and **ESPM**.

Recommendation: Work with **AASIS and major utilities** to make collection of data for Energy Star Portfolio Manager easier.



Recommendation: Begin to **work with the other 98 agencies** to develop Strategic Energy Plans (StEPs) and tracking of energy usage using Energy Star Portfolio Manager (ESPM).

Recommendation: Engage the **Arkansas Energy Efficient State Government Working Group** in expanding StEPs to other agencies.

Recommendation: Work with ABA to develop wording for **lease agreements** that require ESPM accounts to qualify for contracts by State Agencies.
