HIGHLIGHTS OF THE MONTH AND YEAR-TO-DATE COLLECTIONS

Collections of Gross General Revenues year-to-date of approximately \$2,253.2 million have increased \$82.3 million, or 3.8%, above the \$2,170.9 million collected last fiscal year-to-date. Net General Revenue Available for distribution this month of \$470.9 million increased \$35.5 million, or 8.2%, from the \$435.4 million available for distribution in October 2018. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$3,016,615.92 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$12,066,463.68.

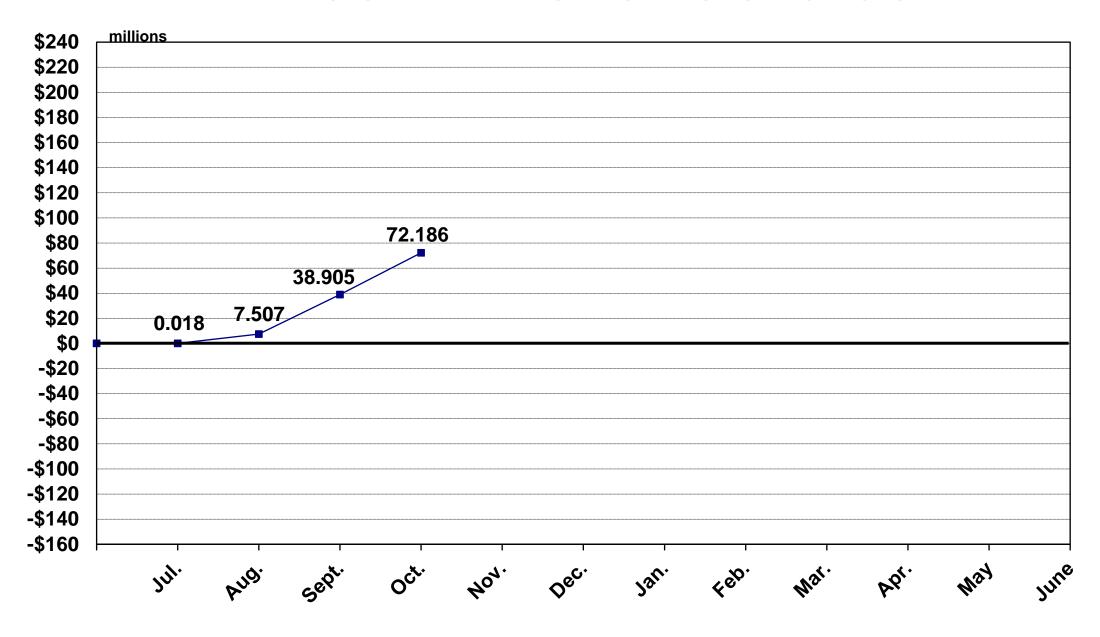
