HIGHLIGHTS OF THE MONTH AND YEAR-TO-DATE COLLECTIONS

Collections of Gross General Revenues year-to-date of approximately \$3,383.4 million have increased \$112.5 million, or 3.4%, above the \$3,270.9 million collected last fiscal year-to-date. Net General Revenue Available for distribution this month of \$547.6 million increased \$6.1 million, or 1.1%, from the \$541.5 million available for distribution in December 2018. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$3,016,615.92 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$18,099,695.52.

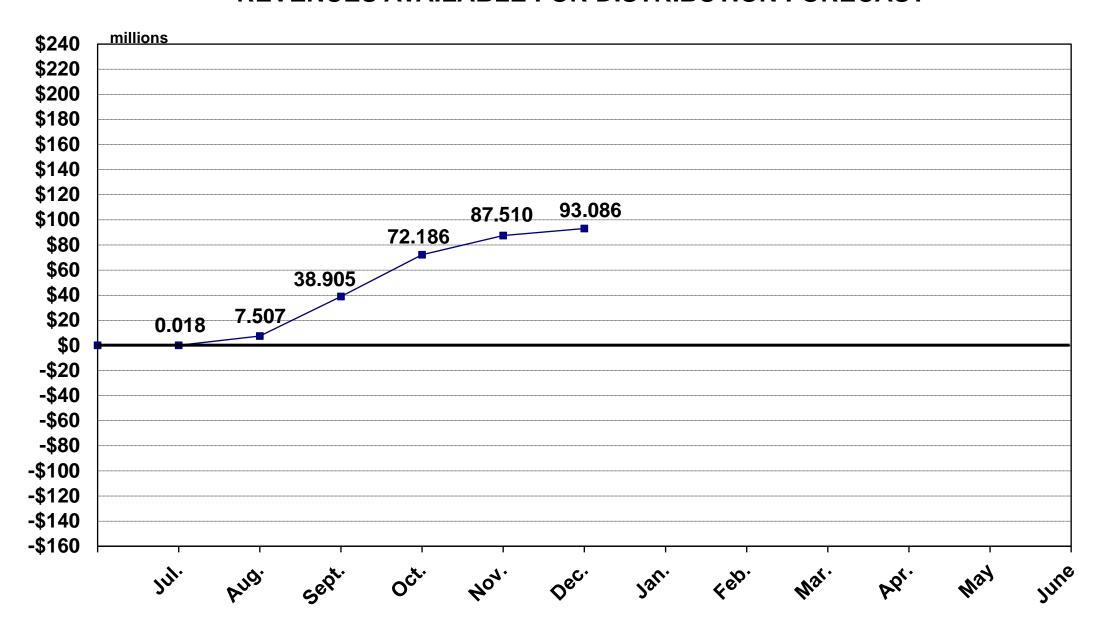
