HIGHLIGHTS OF THE MONTH AND YEAR-TO-DATE COLLECTIONS

Collections of Gross General Revenues year-to-date of approximately \$5,803.7 million have decreased \$194.2 million, or 3.2%, below the \$5,997.9 million collected last fiscal year-to-date. Net General Revenue Available for distribution this month of \$537.2 million decreased \$213.8 million, or 28.5%, from the \$751 million available for distribution in April 2019. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$3,016,615.92 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$30,166,159.20.

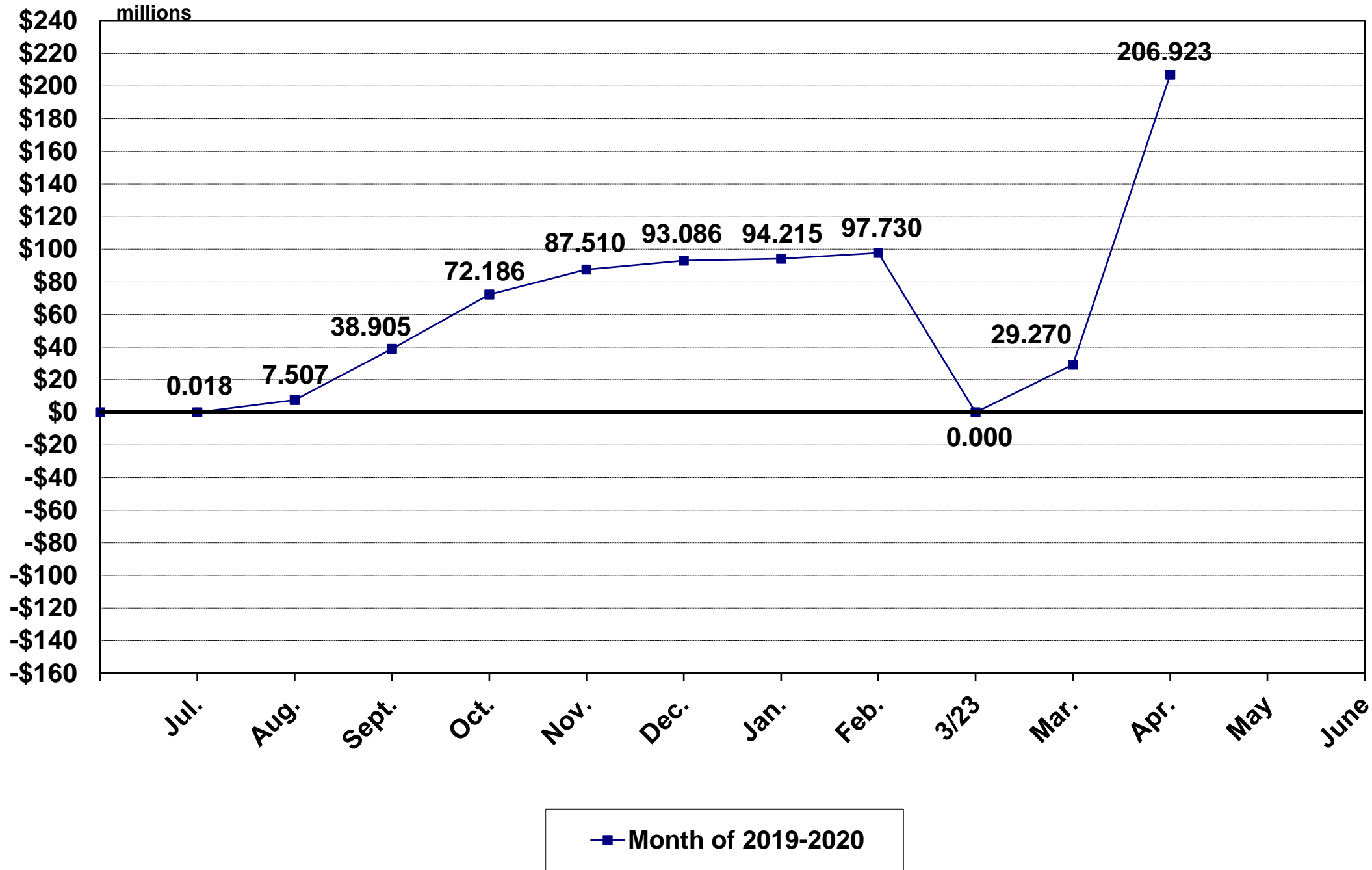
