HIGHLIGHTS OF THE MONTH AND YEAR-TO-DATE COLLECTIONS

Collections of Gross General Revenues year-to-date of approximately \$5,496.8 million have increased \$382.4 million, or 7.5%, above the \$5,114.5 million collected last fiscal year-to-date. Net General Revenue Available for distribution this month of \$372.9 million increased \$16.2 million, or 4.5%, from the \$356.7 million available for distribution in March 2020. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$2,650,012.30 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$23,850,110.70.


