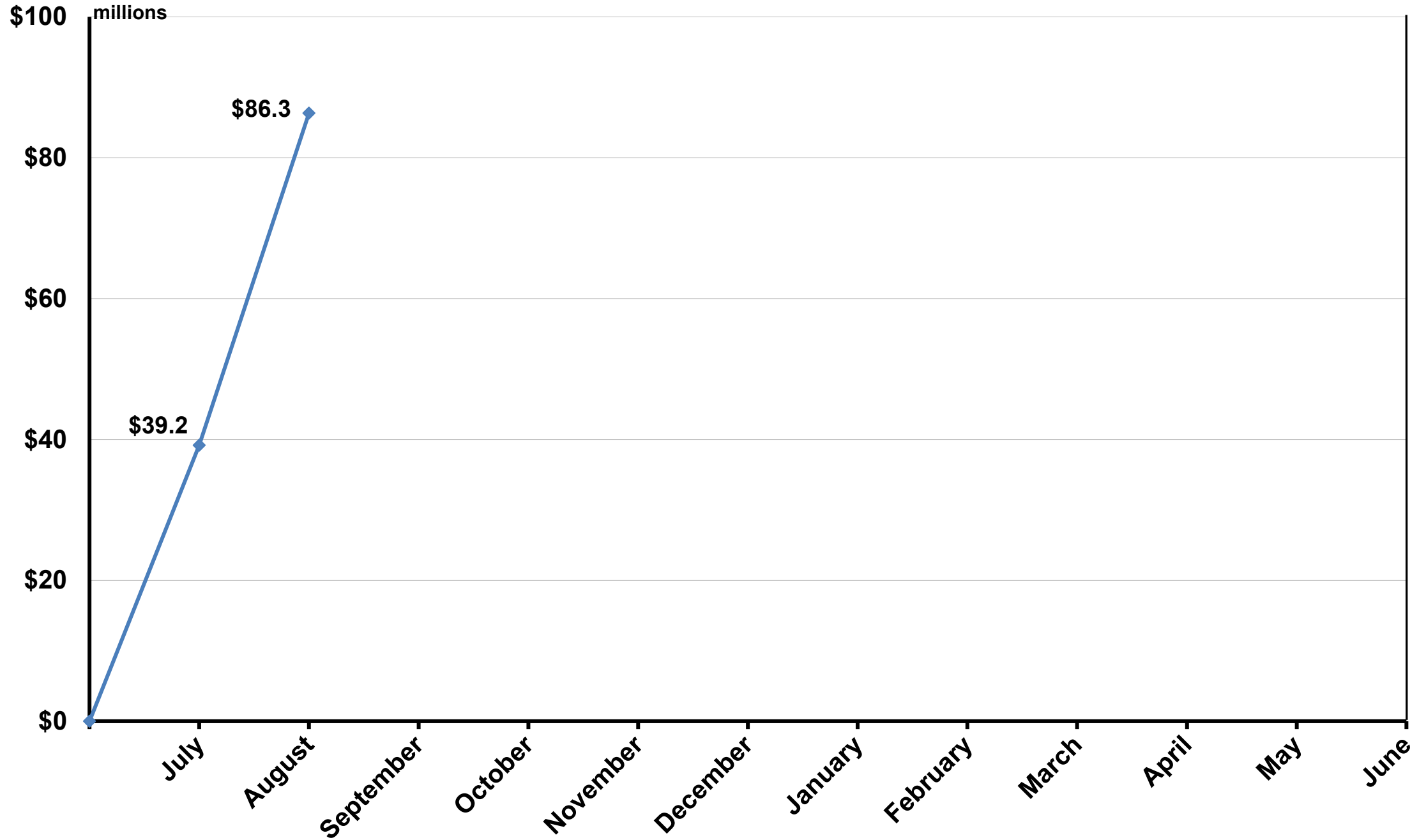

Collections of Gross General Revenues year-to-date of approximately \$1,190.7 million have decreased \$147.7 million, or 11.0% below the \$1,338.4 million collected last fiscal year-to-date. Net General Revenue Available for distribution this month of \$518.9 million increased \$33.4 million, or 6.9% from the \$485.5 million available for distribution in August 2020.
