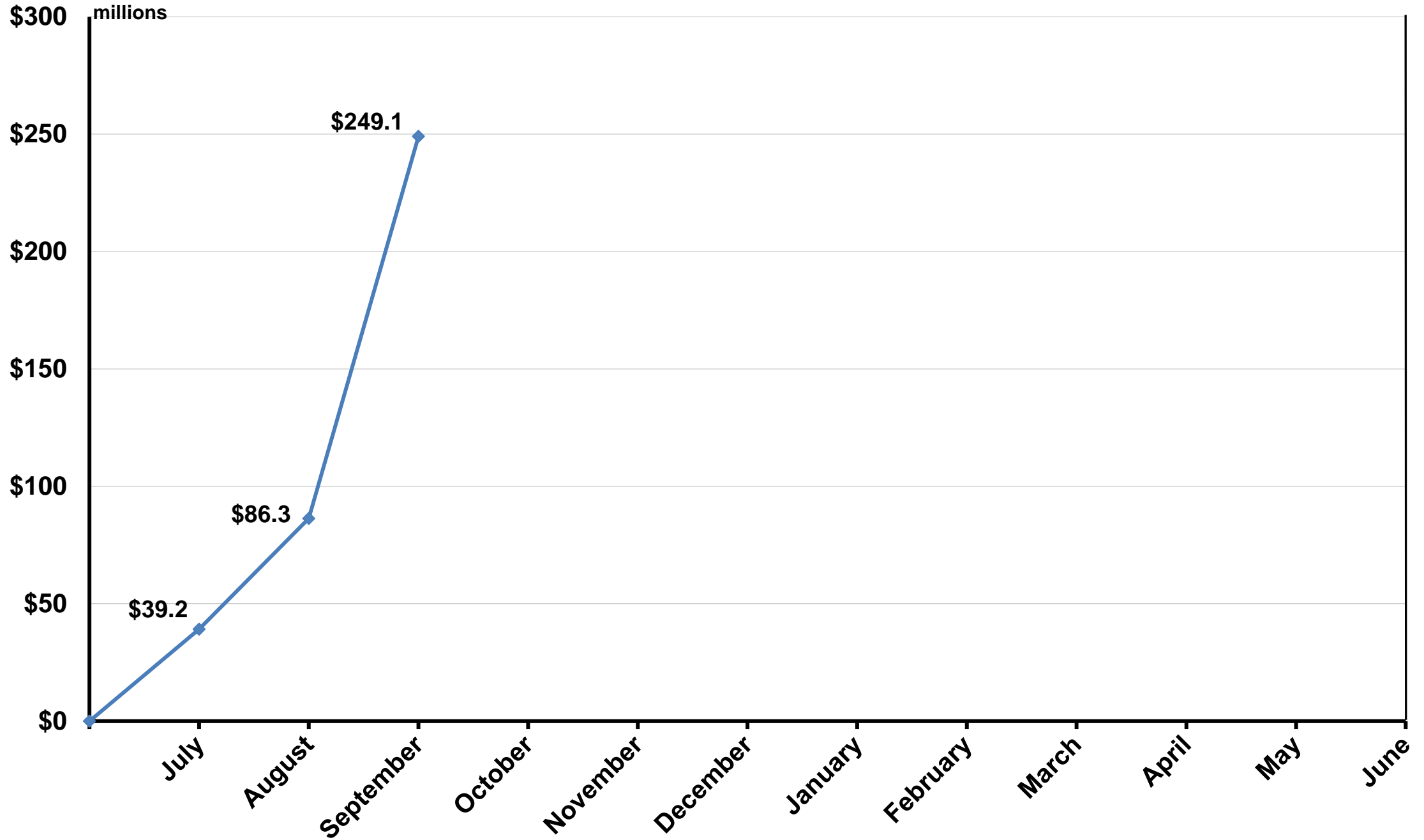

Collections of Gross General Revenues year-to-date of approximately \$1,956.8 million have decreased \$43.8 million, or 2.2% below the \$2,000.6 million collected last fiscal year-to-date. Net General Revenue Available for distribution this month of \$690.3 million increased \$98.4 million, or 16.6% from the \$591.9 million available for distribution in September 2020.
