

### COMPARISON OF THE FIRST TEN MONTHS OF THE 2021-2022 FISCAL YEAR DISTRIBUTION OF GROSS GENERAL REVENUES WITH THE SAME PERIOD OF THE 2020-2021 FISCAL YEAR

State Fiscal Year is July 1, 2021 through June 30, 2022

Collections of Gross General Revenues year-to-date of approximately \$7,224.5 million have increased \$794.0 million, or 12.3% above the \$6,430.6 million collected last fiscal year-to-date. Net General Revenue Available for distribution of \$1,125.3 million increased \$345.7 million, or 44.3% from the \$779.6 million available for distribution in April 2021.
