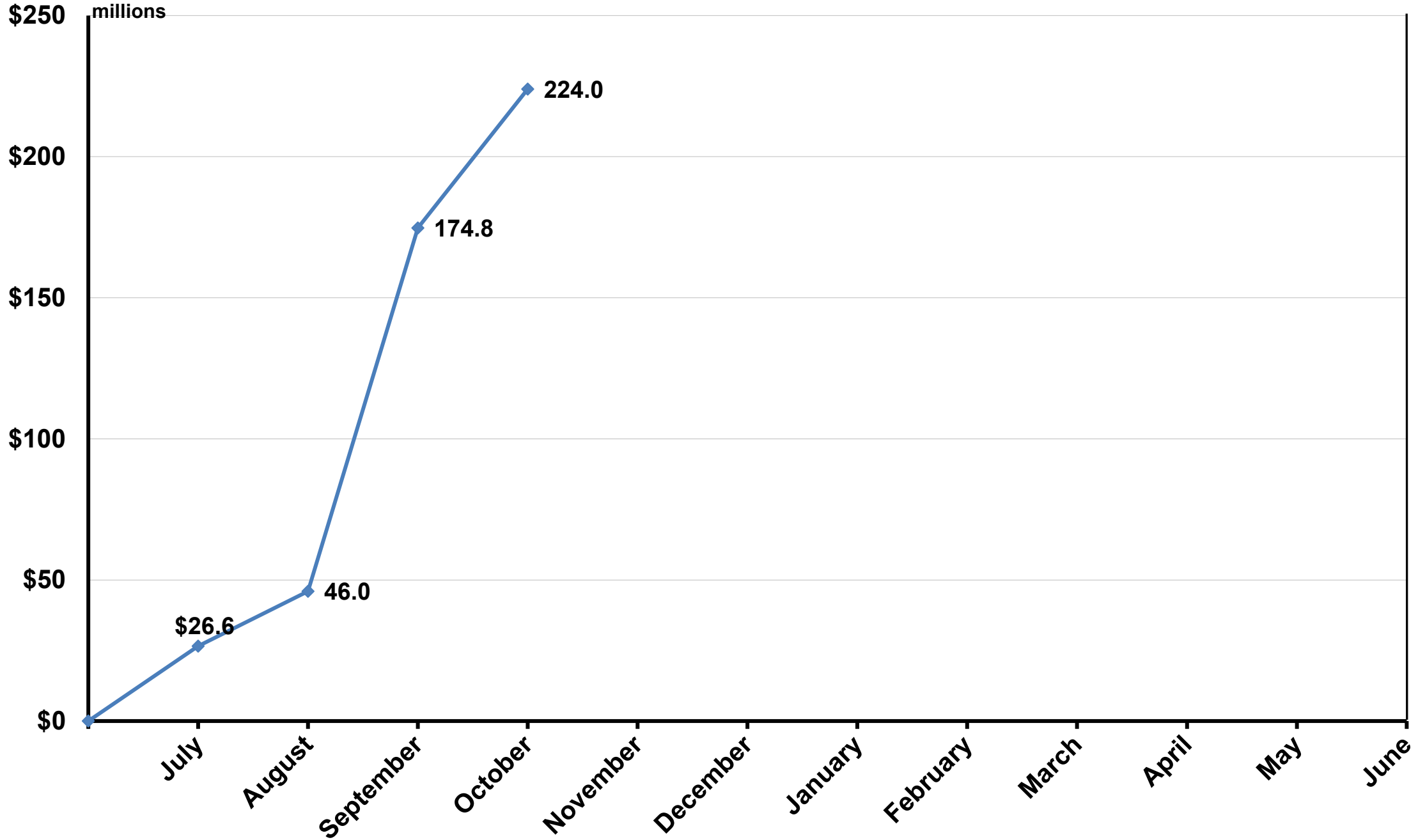

State Fiscal Year is July 1, 2022 through June 30, 2023

Collections of Gross General Revenues year-to-date of approximately \$2,790.8 million have increased \$201.7 million, or 7.8% above the \$2,589.2 million collected last fiscal year-to-date. Net General Revenue Available for distribution of \$2,455.0 million increased \$182.0 million, or 8.0% from the \$2,273.0 million available for distribution in October 2021.
