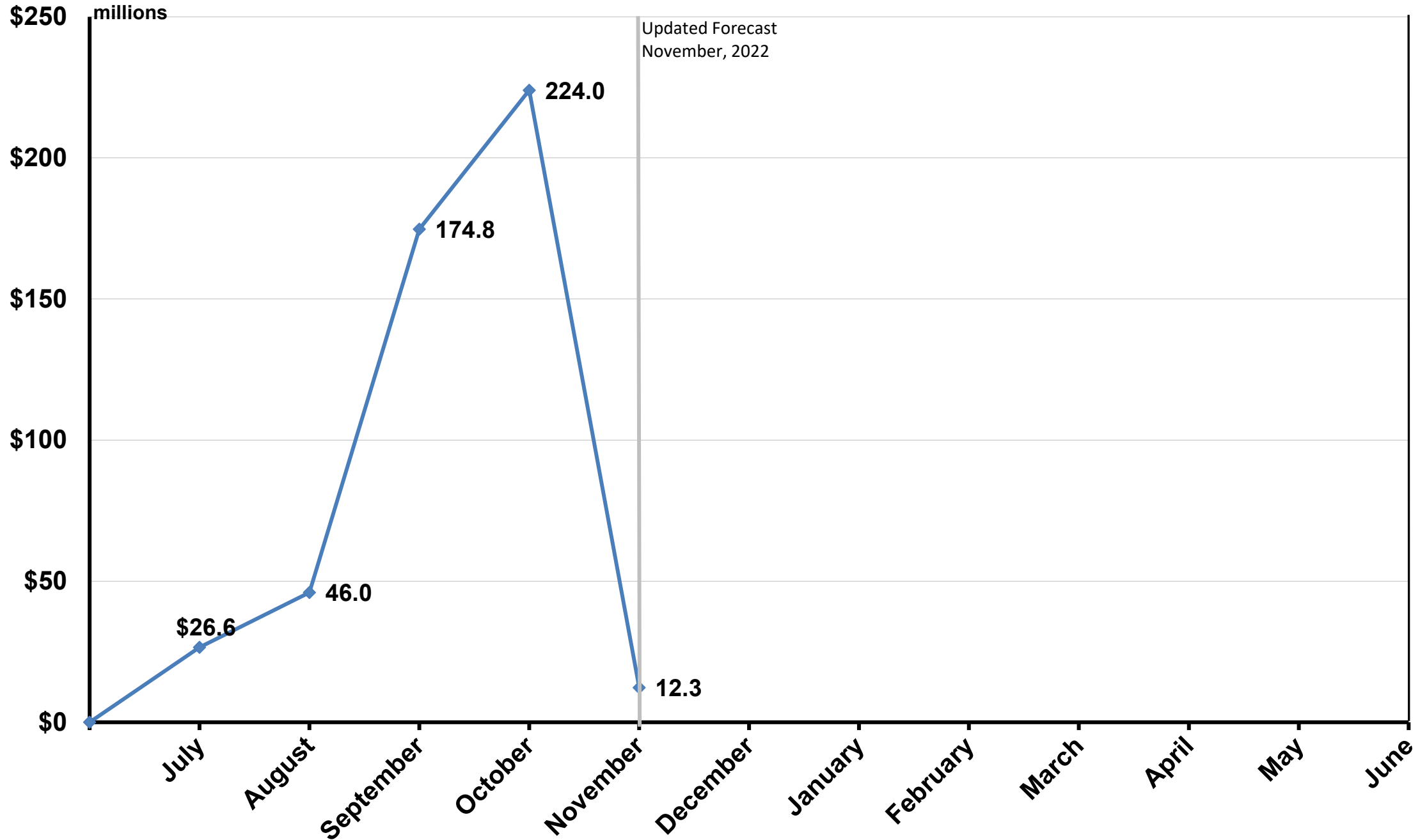
COMPARISON OF THE FIRST FIVE MONTHS OF THE 2022-2023 FISCAL YEAR

State Fiscal Year is July 1, 2022 through June 30, 2023

Collections of Gross General Revenues year-to-date of approximately \$3,372.0 million have increased \$195.6 million, or 6.2% above the \$3,176.4 million collected last fiscal year-to-date. Net General Revenue Available for distribution of \$2,927.1 million increased \$154.2 million, or 5.6% from the \$2,773.0 million available for distribution in November 2021.
