

## COMPARISON OF THE FIRST TEN MONTHS OF THE 2022-2023 FISCAL YEAR DISTRIBUTION OF GROSS GENERAL REVENUES WITH THE SAME PERIOD OF THE 2021-2022 FISCAL YEAR State Fiscal Year is July 1, 2022 through June 30, 2023

Collections of Gross General Revenues year-to-date of approximately \$7,313.1 million have increased \$88.6 million, or 1.2% above the \$7,224.5 million collected last fiscal year-to-date. Net General Revenue Available for distribution of \$6,022.5 million decreased \$163.1 million, or 2.6% from the \$6,185.6 million available for distribution in April 2022.
