
COMPARISON OF THE FIRST EIGHT MONTHS OF THE 2023-2024 FISCAL YEAR DISTRIBUTION OF GROSS GENERAL REVENUES WITH THE SAME PERIOD OF THE 2022-2023 FISCAL YEAR

State Fiscal Year is July 1, 2023 through June 30, 2024

Collections of Gross General Revenues year-to-date of approximately \$5,411.69 million have decreased \$113.0 million, or 2.0% below the \$5,524.64 million collected last fiscal year-to-date. Net General Revenue Available for distribution of \$4,419.4 million decreased \$323.1 million, or 6.8% from the \$4,742.53 million available for distribution in February 2023.
