than the average of states with a large vehicle fleet (\$30). At \$2.00, Texas has the lowest duplicate title fee in the country, 93 percent lower than the average of the large states.

- Service Providers and Compensation. States use a variety of service providers to collect vehicle registration and title fees. Providers include the state governments, county and local governments, the private sector, or some combination of the public and private sectors. While 22 states use a privatesector provider for some functions, Oklahoma is the only State in which the private sector is the only service provider.
- Payment Options. All states allow payments to be made by mail or in person. On-line transactions are possible in most states. Only Delaware, Nebraska, South Dakota, West Virginia, and Wyoming do not support online transactions. For those states supporting online transactions, typically only a limited set of transactions (i.e., registration renewals) may be processed online.
