Attached is the 2005-2006 Annual Revenue Report, which includes various schedules reflecting the collection and distribution of General and Special Revenues for the 2005-2006 fiscal year. In summary, Gross General Revenue collections of approximately \$5,180.1 million increased \$423.3 million or 8.90% over the \$4,756.7 million collected in fiscal year 2004-05. Adjusted Net General Revenues available for distribution of \$4,227.8 million increased \$290.7 million or 7.4% over the \$3,937.1 million available for distribution in fiscal year 2004-05. Gross Special Revenues of \$1,656.7 million increased \$95.8 million, or 6.14% more than the \$1,560.9 million collected in fiscal year 2004-05.
