FOR AN ACT TO BE Entitled
"AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES AND
OPERATING EXPENSES OF THE DEPARTMENT OF EDUCATION EDUCATIONAL TELEVISION DIVISION FOR THE BIENNIAL PERIOD
ENDING JUNE 30, 1991; AND FOR OTHER PURPOSES."

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. REGULAR SALARIES. There is hereby established for the Department of Education - Educational Television Division for the 1989-91 biennium, the following maximum number of regular employees whose salaries shall be governed by the provisions of the Uniform Classification and Compensation Act, or its successor, and all laws amendatory thereto. Provided, however, that any position to which a specific maximum annual salary is set out herein in dollars, shall be exempt from the provisions of said Uniform Classification and Compensation Act. All persons occupying positions authorized herein are hereby governed by the provisions of the Regular Salaries Procedures and Restrictions Act, or its successor.

SECTION 2. EXTRA HELP - STATE. There is hereby authorized, for the Department of Education - Educational Television Division for the 1989-91 biennium, the following maximum number of part-time or temporary employees, to be known as "Extra Help", payable from funds appropriated herein for such purposes: Ten (10) temporary or part-time employees, when needed, at rates of pay not to exceed those provided in the Uniform Classification and Compensation Act, or its successor, for the appropriate classification.

SECTION 3. EXTRA HELP - CASH. There is hereby authorized, for the Department of Education - Educational Television Division for the 1989-91 biennium, the following maximum number of part-time or temporary employees, to be known as "Extra Help", payable from funds appropriated herein for such purposes: Ten (10) temporary or part-time employees, when needed, at rates of pay not to exceed those provided in the Uniform Classification and Compensation Act, or its successor, for the appropriate classification.

SECTION 4. APPROPRIATIONS - STATE. There is hereby appropriated, to the Department of Education - Educational Television Division, to be payable from the Educational Television Fund Account, for personal services and operating expenses of the Department of Education - Educational Television Division - State for the biennial period ending June 30, 1991, the following:

SECTION 5. APPROPRIATIONS - CASH. There is hereby appropriated, to the Department of Education - Educational Television Division, to be payable from cash funds of the Department of Education - Educational Television Division, for personal services and operating expenses of the Department of Education - Educational Television Division - Cash for the biennial period ending June 30, 1991, the following:

SECTION 6. No appropriation made available to the Educational Television Commission or the Division of Educational Television of the Department of Education shall be available until such time as the chairman of the Educational Television Commission certifies, in writing, to the

Legislative Joint Auditing Committee that an audit is being conducted of the Arkansas Educational Telecommunications Network Foundation for the previous fiscal year and has promptly been made available to that committee.

At the end of each fiscal year, the Chairman of that Commission shall initiate an audit of the AETN Foundation by a recognized and certified public accounting firm acceptable to the Legislative Auditor with such audit standards and schedules that may be promulgated by the Legislative Auditor; such audit to be paid for by the AETN Foundation.

No person employed by the Arkansas ETV Commission and paid from state funds shall receive supplemental compensation or remuneration from funds not appropriated by the state.

State employees of the Division of Arkansas Educational Television, in fulfilling their day-to-day responsibilities, are to be supervised only by appropriate state employees and to that end, no privately funded or auxiliary funded employee or person not on the Arkansas Educational Television state payroll nor the Department of Education payroll shall supervise any state employee herein provided.

SECTION 7. The Director of the Educational Television Division of the Department of Education shall submit budget requests of the Educational Television Division to the State Board of Education and the Director of the Department of Education - General Education Division, for their review and approval, before such budget submissions are forwarded to the Governor and the Arkansas Legislative Council.

SECTION 8. Arkansas Code 6-3-102(c) is hereby amended to read as follows:

"(c) Each member shall be entitled to receive fifty dollars (\$50.00) for each day actually in attendance at commission meetings, plus reimbursement for actual, reasonable, and necessary expenses for meals, lodging, and related expenses in attending Board meetings, or other official travel in behalf of the commission, and shall be entitled to mileage at the rate provided by law or regulation for travel by State employees for official travel."

SECTION 9. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this Act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and the restrictions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied

with in disbursement of said funds.

SECTION 10. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this Act shall be in compliance with the stated reasons for which this Act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 11. All provisions of this Act of a general and permanent nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code Revision Commission shall incorporate the same in the Code. Act 919 of 1989 is hereby repealed.

SECTION 12. EMERGENCY CLAUSE. It is hereby found and determined by the Seventy-Seventh General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a two (2) year period; that the effectiveness of this Act on July 1, 1989 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the Regular Session, the delay in the effective date of this Act beyond July 1, 1989 could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 1989.
