HOUSE BILL

For An Act To Be Entitled

8 "AN ACT TO AMEND ARK. CODE ANN. §14-229-101(a) AND (b) TO
9 INCREASE THE NUMBER OF MEMBERS ON THE INDIVIDUAL SEWAGE
10 DISPOSAL SYSTEMS ADVISORY COMMITTEE TO TWELVE; TO PROVIDE
11 THAT THE ADDITIONAL MEMBERS BE REPRESENTATIVES OF THE
12 ARKANSAS DEPARTMENT OF POLLUTION CONTROL AND ECOLOGY, THE
13 SOIL AND WATER CONSERVATION COMMISSION, AND THE ARKANSAS
14 GEOLOGICAL COMMISSION; AND FOR OTHER PURPOSES."

16 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

18 SECTION 1. Ark. Code Ann. §14-229-101(a) and (b) are hereby amended to
19 read as follows:

20 "(a) There is established an advisory committee, to be known as the
21 'Individual Sewage Disposal Systems Advisory Committee,' for the purpose of
22 making recommendations, advising, and providing assistance to the Division of
23 Sanitarian Services of the Department of Health concerning the utilization and
24 application of alternate and experimental individual sewage disposal systems.

25 (b) The advisory committee shall consist of twelve (12) members, to be
26 appointed as follows:

27 (1) A member of the Arkansas Home Builders Association, to be
28 appointed by the president of the association;

29 (2) A member of the Arkansas Real Estate Commission, to be
30 appointed by a majority vote of the commission;

31 (3) A member of the Arkansas Realtors Association, to be
32 appointed by the president of the association;

33 (4) One (1) member who shall be a currently-serving or former
34 member of the board of a suburban improvement district or an officer or member
35 of an association of property owners created by and pursuant to state law and

1 organized for the purpose of maintaining common facilities, including sewage
2 disposal facilities, in unincorporated subdivisions in this state, to be named
3 by the Governor. However, in making the appointment, the Governor shall name
4 a person who has been a developer or a member or officer of the board of a
5 development company that has developed large unincorporated subdivisions in
6 two (2) or more counties in this state;

7 (5) Two (2) members of the Septic Tank Research Program of the
8 University of Arkansas, to be named by the President of the University of
9 Arkansas;

10 (6) The Director of the Division of Engineering, Department of
11 Health;

12 (7) The Program Administrator of General Sanitation, Division of
13 Sanitarian Services, Department of Health;

14 (8) The Director of the Division of Sanitarian Services,
15 Department of Health;

16 (9) The Director of the Arkansas Department Pollution Control and
17 Ecology or his designee;

18 (10) The Director of the Arkansas Soil and Water Conservation
19 Commission or his designee; and

20 (11) The State Geologist with the Arkansas Geological Commission
21 or his designee."

22

23 SECTION 2. All provisions of this act of a general and permanent nature
24 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
25 Revision Commission shall incorporate the same in the Code.

26

27 SECTION 3. If any provision of this act or the application thereof to
28 any person or circumstance is held invalid, such invalidity shall not affect
29 other provisions or applications of the act which can be given effect without
30 the invalid provision or application, and to this end the provisions of this
31 act are declared to be severable.

33 SECTION 4. All laws and parts of laws in conflict with this act are
34 hereby repealed.
