HOUSE BILL 1081

For An Act To Be Entitled

8 "AN ACT TO AUTHORIZE THE ARKANSAS GAME AND FISH COMMISSION
9 TO REQUIRE ARKANSAS RESIDENTS DESIRING TO HUNT UPLAND GAME
10 BIRDS TO PURCHASE A SPECIAL LICENSE AT AN ANNUAL FEE NOT
11 TO EXCEED FIVE DOLLARS; AND FOR OTHER PURPOSES."

13 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

14
15 SECTION 1. For the purposes of this Act the term "upland game birds"
16 means the following:

17 (a) order galliformes, family phasianidae, genus colinus, species
18 virginianus, bobwhite quail;

19 (b) order galliformes, family phasianidae, genus bonasa, species
20 umbellus, ruffed grouse;

21 (c) order galliformes, family phasianidae, genus phasianus, species
22 colchicus, ring-necked pheasant;

23 (d) order galliformes, family phasianidae, genus tympanuchus, species
24 pallidicinctus, lesser prairie-chicken;

25 (e) order galliformes, family phasianidae, genus meleagris, species
26 gallopavo, wild turkey;

27 (f) order columbiformes, family columbidae, genus zenaida, species
28 macroura, mourning dove.

30 SECTION 2. In addition to the resident annual hunting license fees
31 levied by the Arkansas Game and Fish Commission, the Commission may, by
32 regulation, provide that any Arkansas resident desiring to take upland game
33 birds must pay an annual special license fee not to exceed five dollars
34 (\$5.00). *Revenues derived from this Act shall be deposited into the State*
35 *Treasury as special revenues and credited to the "Game Protection Fund" to be*

1 used exclusively by the Arkansas Game and Fish Commission for habitat
2 restoration.

3

4 SECTION 3. Any person who has been issued a permanent resident hunting
5 license by the Arkansas State Game and Fish Commission shall be exempt from
6 the provisions of this act.

7

8 SECTION 4. All provisions of this Act of a general and permanent
9 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
10 Code Revision Commission shall incorporate the same in the Code.

11

12 SECTION 5. If any provision of this Act or the application thereof to
13 any person or circumstance is held invalid, such invalidity shall not affect
14 other provisions or applications of the Act which can be given effect without
15 the invalid provision or application, and to this end the provisions of this
16 Act are declared to be severable.

17

18 SECTION 6. All laws and parts of laws in conflict with this Act are
19 hereby repealed.
