13	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
14	
15	SECTION 1. Arkansas Code Annotated 16-17-108 is amended to read as
16	follows:
17	"16-17-108. Salaries of personnel and other requirements of various
18	municipal courts.
19	(a) The Arkadelphia/Clark County Municipal Judge shall receive an
20	annual salary of not less than nineteen thousand dollars (\$19,000) nor more
21	than twenty-four thousand dollars (\$24,000). The Arkadelphia/Clark County
22	Municipal Court Clerk shall receive an annual salary of not less than ten
23	thousand dollars (\$10,000) nor more than fifteen thousand dollars (\$15,000),
24	such salaries to be established annually by the Clark County Quorum Court.
25	Upon approval by the Clark County Quorum Court, the Arkadelphia/Clark County
26	Municipal Judge may appoint one (1) deputy municipal clerk to receive such
27	salary as established by the Clark County Quorum Court.
28	(b) The Ashdown Municipal Court Judge shall receive an annual salary of
29	not less than seventeen thousand two hundred dollars (\$17,200) nor more than
30	thirty thousand dollars (\$30,000) as determined by the governing body of the
31	City of Ashdown and the Quorum Court of Little River County. Such salary
32	shall be paid sixty-two percent (62%) by Little River County and thirty-eight
33	percent (38%) by the City of Ashdown unless otherwise agreed by the Quorum
34	Court of Little River County and the governing body of the City of Ashdown.
35	(c) The Ash Flat Municipal Court Judge shall receive an annual salary

1 of not less than six thousand dollars (\$6,000) nor more than twenty-one

- 2 thousand dollars (\$21,000), and the Ash Flat Municipal Court Clerk shall
- 3 receive an annual salary of not less than four thousand eight hundred dollars
- 4 (\$4,800) nor more than eight thousand dollars (\$8,000), as determined by the
- 5 Quorum Court of Sharp County, and to be paid by Sharp County.
- 6 (d) The Augusta Municipal Court Judge shall receive an annual salary of
- 7 not less than nine thousand dollars (\$9,000) nor more than ten thousand eight
- 8 hundred dollars (\$10,800), the city and the county to share the cost equally.
- 9 (e) The Batesville Municipal Court Judge shall receive an annual salary
- 10 of not less than twenty-four thousand dollars (\$24,000) nor more than thirty-
- 11 two thousand dollars (\$32,000) as determined by the governing body of
- 12 Batesville and the Quorum Court of Independence County.
- 13 (f) The Beebe Municipal Court Judge shall receive an annual salary of
- 14 not less than fifteen thousand dollars (\$15,000) nor more than eighteen
- 15 thousand dollars (\$18,000). The municipal court clerk shall receive an annual
- 16 salary of not less than fourteen thousand dollars (\$14,000), nor more than
- 17 sixteen thousand dollars (\$16,000).
- 18 (g) The Benton Municipal Court Judge shall receive an annual salary of
- 19 not less than seventeen thousand three hundred five dollars and sixty cents
- 20 (\$17,305.60) nor more than thirty-two thousand five hundred dollars (\$32,500),
- 21 and the court clerk shall receive an annual salary of not less than fourteen
- 22 thousand (\$14,000) nor more than twenty-two thousand five hundred dollars
- 23 (\$22,500). Such salaries shall be as determined by the governing body of the
- 24 City of Benton and the Saline County Quorum Court.
- 25 (h) The Benton County Municipal Court-West Judge shall receive an
- 26 annual salary of not less than seven thousand dollars (\$7,000) and not more
- 27 than seventeen thousand dollars (\$17,000) as determined by the Benton County
- 28 Quorum Court and the governing bodies of the cities of Gentry and Decatur.
- 29 One-half (1/2) of such salary is to be paid by Benton County, one-fourth (1/4)
- 30 of the salary is to be paid by Decatur, and one-fourth (1/4) of the salary is
- 31 to be paid by Gentry.
- 32 (i) The Bentonville Municipal Court Judge shall receive an annual
- 33 salary of not less than twenty-two thousand dollars (\$22,000) nor more than
- 34 twenty-four thousand dollars (\$24,000) as determined by the City Council of
- 35 Bentonville. The court clerk shall receive an annual salary of not less than

1 fifteen thousand dollars (\$15,000) nor more than seventeen thousand dollars

- 2 (\$17,000) as determined by the City Council of Bentonville. The deputy court
- 3 clerk shall receive an annual salary of not to exceed fourteen thousand
- 4 dollars (\$14,000) as determined by the City Council of Bentonville. The two
- 5 (2) clerks of the Bentonville Municipal Court shall each receive annual
- 6 salaries of not less than four thousand eight hundred dollars (\$4,800) nor
- 7 more than nine thousand dollars (\$9,000) as may be approved by the Benton
- 8 County Quorum Court and the governing body of the City of Bentonville.
- 9 (j) The Berryville Municipal Court Judge shall receive an annual salary
- 10 of not less than sixteen thousand dollars (\$16,000) and not more than twenty-
- 11 four thousand dollars (\$24,000).
- 12 (k) The Biscoe Municipal Court Judge shall receive an annual salary of
- 13 not less than three thousand nine hundred dollars (\$3,900) nor more than
- 14 thirteen thousand nine hundred dollars (\$13,900).
- 15 (1) The Blytheville Municipal Court Judge shall receive an annual
- 16 salary of not less than twenty-one thousand dollars (\$21,000) nor more than
- 17 twenty-five thousand five hundred dollars (\$25,500) as may be approved by the
- 18 Mississippi County Quorum Court and the governing body of the City of
- 19 Blytheville.
- 20 (m) The Booneville Municipal Court Judge shall receive an annual salary
- 21 of not less than six thousand dollars (\$6,000) nor more than twenty-five
- 22 thousand dollars (\$25,000), as may be determined by the City Council of the
- 23 City of Booneville and the Quorum Court of Logan County, and shall be payable
- 24 one-half (1/2) by the City of Booneville and one-half (1/2) by Logan County
- 25 and shall be paid in twelve (12) equal monthly installments.
- 26 (n) The Brinkley Municipal Court Judge shall receive an annual salary
- 27 of not less than ten thousand two hundred dollars (\$10,200) nor more than
- 28 twenty-one thousand dollars (\$21,000), and the Brinkley Municipal Court Clerk
- 29 shall receive an annual salary of not less than ten thousand four hundred
- 30 eighty-eight dollars (\$10,488) and not more than eighteen thousand dollars
- 31 (\$18,000).
- 32 (o) The Bryant Municipal Court Judge shall receive an annual salary of
- 33 not less than seventeen thousand five hundred dollars (\$17,500) nor more than
- 34 twenty-seven thousand five hundred dollars (\$27,500).
- 35 (p) The Cabot Municipal Court Judge shall receive an annual salary of

1 not less than ten thousand dollars (\$10,000) nor more than fifteen thousand

- 2 dollars (\$15,000) as may be determined by the governing body of the City of
- 3 Cabot.
- 4 (q) The Camden Municipal Court Judge shall receive an annual salary of
- 5 not less than twenty-seven thousand six hundred dollars (\$27,600) nor more
- 6 than thirty thousand dollars (\$30,000) to be paid by the City of Camden and
- 7 Ouachita County.
- 8 (r) The Carlisle Municipal Court Judge shall receive an annual salary
- 9 of not less than four thousand five hundred dollars (\$4,500) nor more than
- 10 fourteen thousand five hundred dollars (\$14,500).
- 11 (s) The Judge of the Municipal Court of Charleston shall receive an
- 12 annual salary of not less than nine thousand dollars (\$9,000) per year nor
- 13 more than ten thousand eight hundred dollars (\$10,800).
- 14 (t) The Clarendon Municipal Court Judge shall receive an annual salary
- 15 of not less than four thousand eight hundred dollars (\$4,800), and the
- 16 Clarendon Municipal Court Clerk shall receive an annual salary of not less
- 17 than eight thousand nine hundred eighty-eight dollars (\$8,988).
- 18 (u) The Clarksville Municipal Court Judge shall receive an annual
- 19 salary of not less than seventeen thousand dollars (\$17,000) nor more than
- 20 twenty-two thousand dollars (\$22,000). Such salary shall be determined by the
- 21 governing body of the City of Clarksville and the Johnson County Quorum Court,
- 22 with the City of Clarksville paying forty percent (40%) of the amount and
- 23 Johnson County paying sixty percent (60%) of the amount.
- 24 (v) The Clinton Municipal Court Judge shall receive an annual salary of
- 25 not less than six thousand dollars (\$6,000) nor more than twenty-four thousand
- 26 dollars (\$24,000), and the Municipal Court Clerk shall receive an annual
- 27 salary of not less than six thousand dollars (\$6,000) nor more than twelve
- 28 thousand dollars (\$12,000), and the deputy clerk shall receive an annual
- 29 salary of not less than two thousand dollars (\$2,000) nor more than four
- 30 thousand five hundred dollars (\$4,500).
- 31 (w) The Conway Municipal Court Judge shall receive an annual salary of
- 32 not less than thirty thousand dollars (\$30,000) nor more than thirty-eight
- 33 thousand dollars (\$38,000).
- 34 (x) The Judge of the Municipal Court of Corning, Piggott, and Rector
- 35 shall receive an annual salary of not less than seventeen thousand dollars

1 (\$17,000) nor more than twenty-five thousand dollars (\$25,000), to be paid, as

- 2 well as other current benefits, in equal monthly installments by Clay County;
- 3 fifty percent (50%) of the amount shall be reimbursed by the cities of
- 4 Corning, Piggott, and Rector at eighteen and one-half percent (18 1/2%),
- 5 eighteen and one-half percent (18 1/2%), and thirteen percent (13%),
- 6 respectively, to the county treasury. The clerks of the respective municipal
- 7 courts shall receive an annual salary of not less than four thousand five
- 8 hundred dollars (\$4,500), and not to exceed six thousand dollars (\$6,000),
- 9 one-half (1/2) of such salary to be paid by Clay County and the other one-half
- 10 (1/2) to be paid by the respective cities.
- 11 (y)(1) The Judge of the Municipal Court of Craighead County shall be a
- 12 full-time municipal judge and shall receive as compensation for services an
- 13 annual salary of not less than thirty-five thousand dollars (\$35,000) nor more
- 14 than forty-eight thousand dollars (\$48,000) as determined by the Quorum Court
- 15 of Craighead County and the governing body of the City of Jonesboro, to be
- 16 paid in equal monthly installments. The amount of said salary shall be
- 17 appropriated by ordinance adopted by the Quorum Court of Craighead County. The
- 18 amount of said salary and necessary expenses appropriated for said court shall
- 19 be apportioned among, and paid to the county from the respective cities of the
- 20 first and second class, incorporated towns and the government of Craighead
- 21 County a prorated amount based on the number of cases filed from each of such
- 22 towns, cities, and county during the preceding calendar year. Apportionment of
- 23 the costs of said court shall be by order of the municipal court upon
- 24 certification of the cases filed by the Clerk of the Municipal Court of
- 25 Craighead County.
- 26 (2) The Judge of the Municipal Court of Craighead County shall
- 27 maintain dockets and hold court, as deemed necessary, in each of the county
- 28 seats of Craighead County, and may establish dockets and hold court in such
- 29 other cities and towns in Craighead County as deemed necessary by ordinance
- 30 adopted by the Quorum Court of Craighead County.
- 31 (z) The Crossett Municipal Court Judge shall receive an annual salary
- 32 of not less than ten thousand eight hundred dollars (\$10,800) nor more than
- 33 twenty-four thousand dollars (\$24,000), and the municipal court clerk shall
- 34 receive an annual salary of not less than seven thousand dollars (\$7,000) nor
- 35 more than thirteen thousand dollars (\$13,000).

1 (aa) The DeWitt Municipal Court Judge shall receive an annual salary of

- 2 not less than eight thousand one hundred four dollars (\$8,104) nor more than
- 3 eighteen thousand one hundred four dollars, (\$18,104), and the municipal court
- 4 clerk shall receive an annual salary of not less than seven thousand five
- 5 hundred eleven dollars and ninety-six cents (\$7,511.96) nor more than
- 6 seventeen thousand five hundred eleven dollars and ninety-six cents
- 7 (\$17,511.96), and the deputy clerk shall receive an annual salary of not less
- 8 than five thousand four hundred seventy-seven dollars (\$5,477) nor more than
- 9 fifteen thousand four hundred seventy-seven dollars (\$15,477). Such salaries
- 10 shall be determined by the governing body of the City of DeWitt and the
- 11 Arkansas County Quorum Court and paid equally by the city and the county.
- 12 (bb) The DeQueen Municipal Court Judge shall receive an annual salary
- 13 of not less than twenty-one thousand dollars (\$21,000) nor more than thirty
- 14 thousand dollars (\$30,000). The DeQueen Municipal Court Clerk shall have an
- 15 annual salary of not less than fourteen thousand dollars (\$14,000). The
- 16 salaries provided for in this subsection are to be effective on January 1,
- 17 1991. The salaries, expenses, and operating costs of the Municipal Court of
- 18 the City of DeQueen shall be paid equally by the City of DeQueen and the
- 19 County of Sevier.
- 20 (cc) The DeValls Bluff Municipal Court Judge shall receive an annual
- 21 salary of not less than three thousand six hundred dollars (\$3,600) nor more
- 22 than thirteen thousand six hundred dollars (\$13,600).
- 23 (dd) The Des Arc Municipal Court Judge shall receive an annual salary
- 24 of not less than five thousand dollars (\$5,000) nor more than fifteen thousand
- 25 dollars (\$15,000).
- 26 (ee) The Dermott Municipal Court Judge shall receive an annual salary
- 27 of not less than sixteen thousand dollars (\$16,000) nor more than twenty
- 28 thousand dollars (\$20,000), and the court clerk shall receive an annual salary
- 29 of not less than twelve thousand dollars (\$12,000) nor more than sixteen
- 30 thousand dollars (16,000), provided, however, that the court clerk's position
- 31 shall be a full-time position.
- 32 (ff) The Dumas Municipal Court Judge shall receive an annual salary of
- 33 not less than sixteen thousand dollars (\$16,000) nor more than twenty
- 34 thousand dollars (\$20,000). Such salary shall be paid one-half (1/2) by the
- 35 Desha County Quorum Court and one-half (1/2) by the City of Dumas and shall be

1 determined by the Desha County Quorum Court and the governing body of the City

- 2 of Dumas. The municipal court clerk shall be employed and paid by the City of
- 3 Dumas at such salary the governing body shall determine.
- 4 (gg) The Elkins Municipal Court Judge shall receive an annual salary of
- 5 not less than six thousand dollars (\$6,000) nor more than twelve thousand
- 6 dollars (\$12,000).
- 7 (hh)(1) If a municipal court is established in Eudora, the judge shall
- 8 receive an annual salary of not less than sixteen thousand dollars (\$16,000)
- 9 nor more than twenty thousand dollars (\$20,000), and the clerk shall receive
- 10 an annual salary of not less than twelve thousand dollars (\$12,000) nor more
- 11 than sixteen thousand dollars (\$16,000).
- 12 (2) In lieu of the establishment of a municipal court in Eudora,
- 13 the governing body of the City of Eudora and the governing body of the City of
- 14 Lake Village are hereby authorized to enter into agreements whereby the
- 15 Municipal Court of Lake Village will hear and determine all matters which
- 16 would otherwise be heard by the City Court of Eudora or a municipal court if
- 17 established in Eudora. Such agreement may include the contribution to be made
- 18 by the City of Eudora to the salary of the Judge of the Lake Village Municipal
- 19 Court and to other operating costs of the court the day or days on which the
- 20 Lake Village Municipal Court will hear matters which would otherwise have been
- 21 heard by the Eudora City Court or by the Municipal Court of Eudora if such
- 22 were established, and such other matters as the governing body of Lake Village
- 23 and the governing body of Eudora shall determine. Provided further, that all

- 2 Municipal Court of Fayetteville, Washington County, Arkansas, may be increased
- 3 in such amounts as may be agreed by the Quorum Court of Washington County and
- 4 the governing body of the City of Fayetteville, by ordinances or resolutions
- 5 adopted by their respective bodies.
- 6 (kk) The Fordyce Municipal Court Judge shall receive an annual salary
- 7 of not less than twenty-four thousand dollars (\$24,000), and the clerks of
- 8 said court shall receive an annual salary of not less than fourteen thousand
- 9 dollars (\$14,000), as may be determined by the Fordyce City Council and the
- 10 Dallas County Quorum Court, and said salaries shall be paid by the City of
- 11 Fordyce and Dallas County in equal monthly installments.
- 12 (11) The Forrest City Municipal Court Judge shall receive an annual
- 13 salary of not less than twenty-six thousand dollars (\$26,000) nor more than
- 14 thirty-six thousand dollars (\$36,000) as may be set by the Quorum Court of St.
- 15 Francis County and the governing body of Forrest City.
- 16 (mm) The Fort Smith Municipal Court Judges shall receive an annual
- 17 salary of not less than forty-seven thousand dollars (\$47,000) nor more than
- 18 fifty-seven thousand dollars (\$57,000), and the municipal court clerks shall
- 19 receive an annual salary of not less than twenty-one thousand dollars
- 20 (\$21,000), nor more than thirty-one thousand dollars (\$31,000). The municipal
- 21 judges shall appoint a qualified elector to serve as municipal court clerk.
- 22 The salaries of the municipal judges and the municipal court clerks and any
- 23 special judges authorized by this subdivision and the operating expenses of
- 24 the Fort Smith Municipal Court shall be paid seventy percent (70%) by the City
- 25 of Fort Smith and thirty percent (30%) by Sebastian County. The municipal
- 26 judges shall be of good moral character, a resident and elector of the city
- 27 and the state, and shall possess the qualifications required by law for
- 28 circuit and chancery judges. In the event a municipal judge is ill, absent,
- 29 or temporarily disqualified, that municipal judge shall designate a member of
- 30 the bar regularly practicing in the court to serve in his place during the
- 31 illness, absence, or disqualification of the municipal judge, and he shall
- 32 have all the powers and authority of the municipal judge. The special judge
- 33 so appointed shall be paid one hundred dollars (\$100) for each day he served,
- 34 to be paid by the city and county.
- 35 (nn) The Greenwood District Municipal Court Judge shall receive an

1 annual salary of not less than twenty-two thousand dollars (\$22,000) nor more

- 2 than thirty-two thousand dollars (\$32,000) to be set by the Quorum Court of
- 3 Sebastian County, and the salaries of the court clerk and the clerk's deputies
- 4 shall be set by the Quorum Court of Sebastian County. The salaries shall be
- 5 paid ninety percent (90%) by Sebastian County and ten percent (10%) by the
- 6 City of Greenwood. In order to defray the expenses of operating the Greenwood
- 7 District Municipal Court, ninety percent (90%) of the Sebastian County net
- 8 fines, ten percent (10%) of the City of Greenwood net fines, and fifteen
- 9 percent (15%) of all other cities' net fines processed by the Greenwood
- 10 District Municipal Court may/shall be deposited in a bank account entitled
- 11 "Greenwood District Municipal Court Operating Fund" to be administered by the
- 12 Greenwood District Municipal Judge pursuant to a budget approved as follows:
- 13 The municipal judge shall submit a proposed annual budget to a committee
- 14 composed of the members of the quorum court that represents the Greenwood
- 15 District of Sebastian County. The committee shall approve the judge's budget
- 16 or formulate a reasonable budget which shall be approved by the Quorum Court
- 17 of Sebastian County unless found by a majority of the quorum court to be
- 18 clearly excessive. If funds provided from the fines as set out in this
- 19 subdivision above become insufficient, or excessive, the committee shall
- 20 adjust the percentage of fines on a pro rata basis to increase or decrease the
- 21 funds necessary to operate the court pursuant to the budget established in
- 22 this subdivision. The Judge of the Greenwood District Municipal Court shall
- 23 be bonded in accordance with 19-1-401 19-1-403.
- 24 (oo) The Hamburg Municipal Court Judge shall receive an annual salary
- 25 of not less than ten thousand eight hundred dollars (\$10,800) nor more than
- 26 twenty-four thousand dollars (\$24,000), and the municipal court clerk shall
- 27 receive an annual salary of not less than seven thousand dollars (\$7,000) nor
- 28 more than thirteen thousand dollars (\$13,000).
- 29 (pp) The Judge of the Hampton Municipal Court shall receive an annual
- 30 salary of not less than six thousand dollars (\$6,000) nor more than eighteen
- 31 thousand dollars (\$18,000), and the clerk of said court shall receive an
- 32 annual salary of not less than six thousand dollars (\$6,000) nor more than
- 33 eighteen thousand dollars (\$18,000), as may be determined by the Hampton City
- 34 Council and the Calhoun County Quorum Court, and such salaries shall be paid
- 35 by the City of Hampton and Calhoun County in equal monthly installments.

1 (qq) The Harrisburg Municipal Court Judge shall receive an annual

- 2 salary of not less than seven thousand two hundred dollars (\$7,200) nor more
- 3 than fifteen thousand dollars (\$15,000).
- 4 (rr) The Harrison Municipal Court Judge shall receive an annual salary
- 5 of not less than thirty thousand dollars (\$30,000) nor more than forty
- 6 thousand dollars (\$40,000).
- 7 (ss) The Hazen Municipal Court Judge shall receive an annual salary of
- 8 not less than six thousand four hundred dollars (\$6,400) nor more than sixteen
- 9 thousand four hundred dollars (\$16,400).
- 10 (tt) The Heber Springs Municipal Court Judge shall receive an annual
- 11 salary of not less than twelve thousand six hundred fifty-five dollars
- 12 (\$12,655) nor more than eighteen thousand dollars (\$18,000). Such salary
- 13 shall be set by and the payment thereof shall be apportioned between the
- 14 county and the city by agreement of the Cleburne County Quorum Court and the
- 15 governing body of the City of Heber Springs.
- 16 (uu) The Helena Municipal Court Judge shall receive an annual salary of
- 17 not less than seventeen thousand four hundred dollars (\$17,400) nor more than
- 18 twenty-two thousand eight hundred dollars (\$22,800). Such salary shall be
- 19 determined by the governing body of Helena and the Phillips County Quorum
- 20 Court with each responsible for paying one-half (1/2) of the salary.
- 21 (vv) The Hope Municipal Court Judge shall receive an annual salary of
- 22 not less than twenty-two thousand dollars (\$22,000) nor more than twenty-six
- 23 thousand four hundred dollars (\$26,400), and the clerk shall receive an annual
- 24 salary of not less than eleven thousand three hundred dollars (\$11,300) nor
- 25 more than twenty-one thousand three hundred dollars (\$21,300). The amount of
- 26 such salaries shall be determined by agreement between the governing body of
- 27 the City of Hope and the Quorum Court of Hempstead County.
- 28 (ww) The Hot Springs Municipal Court Judge shall receive an annual
- 29 salary of not less than forty-nine thousand dollars (\$49,000) nor more than
- 30 fifty-nine thousand dollars (\$59,000), and the court clerk shall receive an
- 31 annual salary of not less than twenty-two thousand dollars (\$22,000) nor more
- 32 than twenty-five thousand dollars (\$25,000).
- 33 (xx) The Huntsville Municipal Court Judge shall receive an annual
- 34 salary of not less than nine thousand six hundred dollars (\$9,600) nor more

- 21 (yyyy) The Waldron Municipal Court Judge shall receive an annual salary
- 22 of not less than fourteen thousand dollars (\$14,000) nor more than twenty
- 23 thousand dollars (\$20,000), and the clerk shall receive an annual salary of
- 24 not less than five thousand five hundred dollars (\$5,500) nor more than ten
- 25 thousand dollars (\$10,000). The salaries shall be subject to approval of the
- 26 Waldron City Council and the Scott County Quorum Court and shall be paid in
- 27 equal monthly installments, one-half (1/2) to be paid by the City of Waldron,
- 28 and one-half (1/2) to be paid by Scott County.
- 29 (zzzz) The Walnut Ridge Municipal Court Judge shall receive an annual

- 6 (ccccc) The West Helena Municipal Judge shall receive an annual salary
- 7 of not less than twelve thousand three hundred twelve dollars (\$12,312) nor
- 8 more than sixteen thousand eight hundred dollars (\$16,800), of which not less
- 9 than five hundred thirteen dollars (\$513) nor more than seven hundred dollars
- 10 (\$700) per month shall be paid by the City of West Helena, and of which not
- 11 less than five hundred thirteen dollars (\$513) nor more than seven hundred
- 12 dollars (\$700) per month shall be paid by Phillips County.
- 13 (ddddd)(1) The West Memphis Municipal Court Judge shall receive an
- 14 annual salary of not less than twenty-four thousand dollars (\$24,000) nor more

- 17 Quorum Court.

- 27 (\$2,300) nor more than three thousand dollars (\$3,000). The salary shall be
- 28 determined by the board of directors of the city of Wrightsville.
- 29 (fffff) The Wynne Municipal Court Judge shall receive an annual salary
- 30 of not less than twenty thousand dollars (\$20,000) nor more than twenty-five
- 31 thousand dollars (\$25,000). Said salary shall be as determined by the Cross
- 32 County Quorum Court. The Judge of the Wynne Municipal Court may appoint a
- 33 small claims referee to hear small claims cases in the Wynne Municipal Court.
- 34 If a referee is appointed, the small claims referee of the Wynne Municipal
- 35 Court shall receive a salary as fixed by the quorum court.

         SECTION 2. All provisions of this act of a general and permanent nature
 8 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
 9 Revision Commission shall incorporate the same in the Code.

         SECTION 3. If any provision of this act or the application thereof to
12 any person or circumstance is held invalid, such invalidity shall not affect
13 other provisions or applications of the act which can be given effect without
14 the invalid provision or application, and to this end the provisions of this
15 act are declared to be severable.

         SECTION 4. All laws and parts of laws in conflict with this act are
18 hereby repealed.

         SECTION 5. Emergency. It is hereby found and determined by the General
21 Assembly that the salaries currently prescribed by law for judges of the
22 various municipal courts in the State are inadequate to compensate the judges
23 of such courts for their services; that the effective and efficient operation
24 of the municipal courts in the State are essential to the administration of
25 justice and that this act is necessary to assure the effective and efficient
26 operation of such courts and should be given effect immediately. Therefore,
27 an emergency is hereby declared to exist and this act being necessary for the
28 preservation of the public peace, health and safety shall be in full force and
29 effect from and after its passage and approval.
