# A Bill

**HOUSE BILL 1395**

## For An Act To Be Entitled

8 "AN ACT TO CREATE A REFORESTATION PROGRAM IN ARKANSAS TO  
9 BE KNOWN AS PLANT THE FUTURE; TO ESTABLISH A REFORESTATION  
10 GOAL OF 10 MILLION ADDITIONAL TREES EACH YEAR UNTIL THE  
11 YEAR 2000; TO CREATE A STATE REFORESTATION TASK FORCE; TO  
12 ESTABLISH A REFORESTATION COMMITTEE IN EACH COUNTY OF THE  
13 STATE; AND FOR OTHER PURPOSES."

14  
15 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

16  
17       Whereas, the General Assembly of the State of Arkansas determines that  
18 Arkansas' forests are nationally and internationally significant; and

19       Whereas, Arkansas' forests provide habitat for thousands of animal and  
20 plant species many of which are rare or found only within the boundaries of  
21 the state; and

22       Whereas, the bottomland hardwood forests of the state are critical to  
23 the survival of waterfowl populations; and

24       Whereas, Arkansas forests are of great economic value and have a gross  
25 product of \$1.6 billion annually and provide employment for nearly 40,000  
26 Arkansans in the forest products industry earning up to \$758 million each  
27 year; and

28       Whereas, destruction of the earth's forests will lead to the extinction  
29 of millions of species; and

30       Whereas, a dramatic increase in atmospheric gases, particularly carbon  
31 dioxide, may raise global temperature 2 degrees to 10 degrees F in the next  
32 century; and

33       Whereas, trees remove carbon dioxide from the atmosphere, provide  
34 habitat for species, purify air by removing dust and other particles, produce  
35 oxygen, prevent erosion, reduce flooding, reduce energy use, provide food and

1 shade, create beauty and hide unsightly areas created by man, and literally  
2 keep life going on our planet.

3

4 SECTION 1. This act may be cited and referred to as the "Arkansas  
5 Reforestation Act of 1991."

6

7 SECTION 2. The Arkansas Reforestation Program is to be known  
8 hereinafter as PLANT THE FUTURE.

9

10 SECTION 3. It is the purpose of the State of Arkansas to establish a  
11 "no net loss policy" of forest land in the state; to reforest to the maximum  
12 extent possible the state's bottomland hardwood forests; and to direct state  
13 agencies and to encourage federal agencies to work together to carry forth the  
14 goals of this legislation. *In regard to private landowners the intent of this*  
15 *legislation is to foster voluntary cooperation with the state.*

16

17 SECTION 4. The program goals of PLANT THE FUTURE are:

18 (1) To plant 10 million trees in each of the next ten (10) years. The  
19 10 million figure is Arkansas' portion of offsetting the loss of 20 million  
20 acres of trees each year in the Amazon Basin and is in addition to the more  
21 than 75 million trees planted annually in the state;

22 (2) To increase the amount of forested land in Arkansas from the  
23 current 17 million acres to more than 18 million acres by the year 2000;

24 (3) To establish bottomland hardwood demonstration forests in the Delta  
25 to aid in educating landowners in the proper ways to regenerate and manage  
26 hardwood forest and to restore bottomland and wetland forests;

27 (4) To reforest lands taken out of agricultural production;

28 (5) To reforest corridors along lakes and streams;

29 (6) To develop forests in communities;

30 (7) To reforest borders of highways (greenways) between communities;

31 (8) To establish forested windbreaks and borders along cleared lands;

32 (9) To enhance and promote the state's forest economy.

33

34 SECTION 5. The Arkansas Forestry Commission shall have the following  
35 duties in addition to those otherwise prescribed by law:

36 (1) To develop a comprehensive reforestation program and to carry out

- 1 the program goals of PLANT THE FUTURE;
- 2 (2) To implement the no net loss policy of forest land;
- 3 (3) To establish a state reforestation task force to include
- 4 representation of appropriate state, federal, and private agencies and to
- 5 serve as the chair agency of the task force for coordination purposes;
- 6 (4) To assist the Arkansas Cooperative Extension Service to organize
- 7 and support county reforestation committees;
- 8 (5) To provide technical information and support for tree planting
- 9 projects within the county;
- 10 (6) To prepare an annual report for each of the ten (10) years of PLANT
- 11 THE FUTURE for the Governor and members of the General Assembly;
- 12 (7) *To promulgate rules or regulations pursuant to the Arkansas*
- 13 *Administrative Procedure Act, Arkansas Code 25-15-201 et seq., or guidelines*
- 14 *necessary for the administration and operation of PLANT THE FUTURE.*

15

16 SECTION 6. The Arkansas Cooperative Extension Service shall have the

17 following duties in addition to those otherwise prescribed by law:

- 18 (1) To establish a reforestation committee in each county of the state
- 19 and to work with the Arkansas Forestry Commission to organize and support the
- 20 county reforestation committees;
- 21 (2) To provide technical information and support for tree planting
- 22 projects within each county;
- 23 (3) To work through Cooperative Extension Service organizations and
- 24 clientele groups to foster tree planting activities within each county of the
- 25 state;
- 26 (4) To assist the Arkansas Forestry Commission in the preparation of an
- 27 annual report to the Governor and members of the General Assembly.

28

29 SECTION 7. CODE. All provisions of this Act of a general and permanent

30 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas

31 Code Revision Commission shall incorporate the same in the Code.

32

33 SECTION 8. SEVERABILITY. If any provision of this Act or the

34 application thereof to any person or circumstance is held invalid, such

35 invalidity shall not affect other provisions or applications of the Act which

1 can be given effect without the invalid provision or application, and to this  
2 end the provisions of this Act are declared to be severable.

3

4       *SECTION 9. This act shall not affect the rights of private landowners*  
5 *nor shall it require mandatory participation by private citizens and*  
6 *industries.*

7

8       *SECTION 10. This act shall be supplemental to all other laws and shall*  
9 *not be deemed to repeal or modify any other law.*
