## **For An Act To Be Entitled**

8 "AN ACT TO AMEND ARKANSAS CODE 10-3-206 TO PROVIDE THAT  
9 EACH OF THE TEN JOINT INTERIM COMMITTEES CREATED IN  
10 ARKANSAS CODE 10-3-203 SHALL MEET EVERY OTHER MONTH DURING  
11 THE INTERIM BETWEEN REGULAR SESSIONS UNLESS A MAJORITY OF  
12 THE MEMBERSHIP OF THE COMMITTEE SHALL, AT ANY REGULAR  
13 MEETING, VOTE TO NOT HOLD A REGULAR MEETING; AND FOR OTHER  
14 PURPOSES."

16 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

18 SECTION 1. Arkansas Code 10-3-206 is hereby amended to read as follows:  
19 "10-3-206. Meetings.

20 (1) Each of the ten (10) subject matter committees shall meet every  
21 other month during the interim between regular sessions of the General  
22 Assembly. The committees may meet at such other times during the interim as  
23 the respective committees deem necessary. Provided, any such committee may  
24 forego a regular monthly meeting upon majority vote of the membership of the  
25 committee.

26 (i) The Joint Interim Committee on Public Health, Welfare and  
27 Labor shall meet on the third Thursday of each odd numbered month at 10:00  
28 a.m.

29 (ii) The Joint Interim Committee on Revenue and Taxation shall  
30 meet on the third Thursday of each odd numbered month at 10:00 a.m.

31 (iii) The Joint Interim Committee on Public Transportation shall meet  
32 on the third Thursday of each odd numbered month at 10:00 a.m. (iv)

33 The Joint Interim Committee on Education shall meet on the third Thursday of  
34 each odd numbered month at 10:00 a.m.

35 (v) The Joint Interim Committee on Judiciary shall meet on the

1 third Thursday of each odd numbered month at 10:00 a.m.

2 (vi) The Joint Interim Committee on Agriculture and Economic  
3 Development shall meet on the third Thursday of each even numbered month at  
4 10:00 a.m.

5 (vii) The Joint Interim Committee on Insurance and Commerce shall  
6 meet on the third Thursday of each even numbered month at 10:00 a.m.

7 (viii) The Joint Interim Committee on State Agencies and  
8 Governmental Affairs shall meet on the third Thursday of each even numbered  
9 month at 10:00 a.m.

10 (ix) The Joint Interim Committee on City, County and Local  
11 Affairs shall meet on the third Thursday of each even numbered month at 10:00  
12 a.m.

13 (x) The Joint Interim Committee on Aging and Legislative  
14 Affairs shall meet on the third Thursday of each even numbered month at 10:00  
15 a.m.

16 (2) Chairmen of each of the ten (10) subject matter interim committees  
17 shall confer with the Director of the Bureau of Legislative Research in  
18 arranging special meeting dates for the committees in order to avoid  
19 conflicting committee meetings and in order to assure maximum utilization of  
20 available staff and facilities for meetings of the committees.

21 (3) If any committee shall find it necessary for the committee to meet  
22 in excess of twenty-four (24) days per biennium, it shall report the necessity  
23 for any additional meeting to the Legislative Council. If funds are available  
24 to hold additional meetings, the Council shall so advise the requesting  
25 committee.

26 (4) The respective joint interim committees are authorized to establish  
27 subcommittees as may be necessary or appropriate to enable the committees to  
28 effectively and efficiently carry out their respective functions and duties."  
29

30 SECTION 2. All provisions of this act of a general and permanent nature  
31 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
32 Revision Commission shall incorporate the same in the Code.

34 SECTION 3. If any provision of this act or the application thereof to  
35 any person or circumstance is held invalid, such invalidity shall not affect

1 other provisions or applications of the act which can be given effect without  
2 the invalid provision or application, and to this end the provisions of this  
3 act are declared to be severable.

5       SECTION 4. All laws and parts of laws in conflict with this act are  
6 hereby repealed.
