For An Act To Be Entitled

8 *"AN ACT TO AUTHORIZE EACH MEMBER OF THE GENERAL ASSEMBLY*
9 *TO ATTEND THE PRESESSION BUDGET HEARINGS CONDUCTED BY THE*
10 *LEGISLATIVE COUNCIL AND THE JOINT BUDGET COMMITTEE AND TO*
11 *RECEIVE PER DIEM AND MILEAGE FOR SUCH ATTENDANCE; TO*
12 *PROVIDE THAT THE CHAIRMAN OF THE LEGISLATIVE COUNCIL SHALL*
13 *CAUSE COPIES OF THE BUDGET HEARING AGENDAS TO BE FURNISHED*
14 *TO EACH MEMBER OF THE GENERAL ASSEMBLY IN ORDER THAT ALL*
15 *MEMBERS WILL BE ADVISED OF THE BUDGET REQUESTS TO BE HEARD*
16 *EACH DAY; AND FOR OTHER PURPOSES."*

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20 SECTION 1. Arkansas Code 10-3-218 is hereby amended to read as follows:

21 *"10-3-218. Budget Hearings - Attendance by members of the General*
22 *Assembly.*

23 *(a) During the presession budget hearings conducted by the Legislative*
24 *Council and the Joint Budget Committee preceding each regular biennial*
25 *session, the chairman of the Legislative Council shall cause copies of the*
26 *budget hearing agendas to be furnished to each member of the General Assembly,*
27 *in order that all members of the Senate and House of Representatives will be*
28 *advised of the times when such hearings are conducted and of the budget*
29 *requests to be heard or considered each day of the hearings.*

30 *(b) All members of the Senate and House of Representatives who will be*
31 *servicing in the upcoming regular biennial session of the General Assembly,*
32 *including the newly elected members of the Senate and House of*
33 *Representatives, shall be entitled to attend any or all biennial presession*
34 *budget hearings conducted by the Legislative Council and the Joint Budget*
35 *Committee and shall be entitled to receive per diem and mileage for attending*

1 such meetings at the same rate as is provided for attendance at meetings of
2 joint interim committees of the General Assembly.

4 SECTION 2. Arkansas Code 10-3-802(b)(1) is hereby amended to read as
5 follows:

6 "(1) Five (5) members of the Senate to be named by the Senate Committee
7 on Committees. Each Senate member is authorized to appoint a member of the
8 Senate to serve as his or her alternate on the committee; and"

10 SECTION 3. All provisions of this act of a general and permanent nature
11 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
12 Revision Commission shall incorporate the same in the Code.

13

14 SECTION 4. If any provision of this act or the application thereof to
15 any person or circumstance is held invalid, such invalidity shall not affect
16 other provisions or applications of the act which can be given effect without
17 the invalid provision or application, and to this end the provisions of this
18 act are declared to be severable.

19

20 SECTION 5. All laws and parts of laws in conflict with this act are
21 hereby repealed.
