HOUSE JOINT RESOLUTION

7 URGING THE CONGRESS OF THE UNITED STATES TO EFFECT
8 LEGISLATIVE AND/OR REGULATORY ALTERNATIVES WHICH WILL
9 PROVIDE ADEQUATE ADMINISTRATIVE FUNDS FOR EMPLOYMENT AND
10 UNEMPLOYMENT PROGRAMS IN ARKANSAS.

14 WHEREAS, federal funds appropriated for administration of the Employment
15 Security System nationwide have become increasingly insufficient; and

16

17 WHEREAS, adequate funds are available for appropriation from payroll
18 taxes collected by the IRS pursuant to the Federal Unemployment Tax Act
19 (FUTA), having a total balance of \$2.24 billion in the Employment Security
20 Administration Account (ESAA) at the end of FY 1990; and

22 WHEREAS, these funds, now idle, are dedicated to administration of the
23 Employment Security System; and

25 WHEREAS, these dedicated and available resources are a part of the
26 federal unified budget and are being withheld in order to mask the true size
27 of the federal deficit; and

29 WHEREAS, the Arkansas Employment Security Division serves local
30 populations, and the failure to appropriate adequate administrative funds
31 significantly reduces its ability to provide services to which unemployed
32 workers are entitled;

34 NOT THEREFORE,

35 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE SEVENTY-EIGHTH GENERAL

1 ASSEMBLY OF THE STATE OF ARKANSAS AND BY THE SENATE, A MAJORITY OF ALL MEMBERS
2 ELECTED TO EACH HOUSE AGREEING THERETO:

4 That the Congress of the United States is urged to appropriate adequate
5 resources to finance properly Employment Security programs and services the
6 states are mandated to administer; remove the Federal Unemployment Trust Fund
7 from calculation of the federal budget deficit; and, amend federal law to
8 exempt Unemployment Trust Funds from sequestration.

10 BE IT FURTHER RESOLVED, that the Chief Clerk of the House of
11 Representatives shall forward a copy of this resolution to the President of
12 the United States, the Secretary of Labor, the Chairman of the House Ways and
13 Means Committee; the Chairman of the Senate Finance Committee; the Chairman of
14 the House Budget Committee; the Chairman of the Senate Budget Committee and to
15 each member of the Arkansas Congressional Delegation.
