8 IN RESPECTFUL MEMORY OF MR. W. H. "BILL" STANCIL, AND IN
9 RECOGNITION OF HIS MANY CONTRIBUTIONS TO THE STATE AND HIS
10 LOCAL COMMUNITY.

12 WHEREAS, Mr. W. H. "Bill" Stancil of Fort Smith, Arkansas, died on
13 Tuesday, February 12, 1991; and

15 WHEREAS, Mr. Stancil was a former member of the House of Representatives
16 of the Arkansas General Assembly, having served in that capacity from 1971
17 through 1980; and

19 WHEREAS, during his tenure in the House of Representatives, Mr. Stancil
20 earned and received the highest respect and admiration of his colleagues in
21 the General Assembly and was instrumental in the enactment of some significant
22 and far-reaching legislation especially in the field of public education; and

24 WHEREAS, Mr. Stancil was a former Arkansas Tech and University of
25 Arkansas football player and was head football coach at Fort Smith Northside
26 High School from 1957 through 1969 and remained with the school as athletic
27 director until his death; and

29 WHEREAS, Mr. Stancil was recognized as an outstanding football coach and
30 as a person who was not only concerned with his players on the field but one
31 who showed great concern for young people and worked diligently to help those
32 in his care to prepare to deal with all aspects of life; and

34 WHEREAS, Mr. Bill Stancil will be truly missed by his colleagues in the
35 House of Representatives and by all those who had the privilege and pleasure
