## 7 **For An Act To Be Entitled**

8 "AN ACT TO AMEND SECTION 1, ITEMS 1 AND 3 OF ACT 113 OF  
9 THE FIRST EXTRAORDINARY SESSION OF 1989 TO INCREASE THE  
10 MAXIMUM ANNUAL SALARY RATE FOR THE NURSING EXECUTIVE  
11 DIRECTOR AND THE DIRECTOR OF NURSING PRACTICE IN  
12 FY 1990-91; AND FOR OTHER PURPOSES."

14 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

15

16 SECTION 1. Item (1) of Section 1 of Act 113 of the First Extraordinary  
17 Session of 1989 is hereby amended to read as follows:

18 "(1) 7117 NURSE BD NURSING EXEC DIRECTOR 1 \$34,335 \$38,338"

20 SECTION 2. Item (3) of Section 1 of Act 113 of the First Extraordinary  
21 Session of 1989 is hereby amended to read as follows:

22 "(3) 7122 NURSE BD DIR NURSING PRACTICE 1 \$21,533 \$29,538"

24 SECTION 3. CODE. All provisions of this Act of a general and permanent  
25 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas  
26 Code Revision Commission shall incorporate the same in the Code.

28 SECTION 4. SEVERABILITY. If any provision of this Act or the  
29 application thereof to any person or circumstance is held invalid, such  
30 invalidity shall not affect other provisions or applications of the Act which  
31 can be given effect without the invalid provision or application, and to this  
32 end the provisions of this Act are declared to be severable.

33

34 SECTION 5. GENERAL REPEALER. All laws and parts of laws in conflict  
35 with this Act are hereby repealed.

2 SECTION 6. EMERGENCY CLAUSE. It is hereby found and determined by the  
3 Seventy-Eighth General Assembly, that the salaries of the aforementioned  
4 positions are not commensurate with the requirements and duties of these  
5 positions; that it is essential that appropriate maximum annual salary rates  
6 for FY 1990-91 be set in order to ensure the continued service of qualified  
7 personnel; and that this Act raises the maximum annual salary rates for FY  
8 1990-91 thereby providing more appropriate rates for the positions listed in  
9 this Act . Therefore, an emergency is hereby declared to exist, and this Act  
10 being necessary for the immediate preservation of the public peace, health,  
11 and safety shall be in full force and effect from and after January 1, 1991.
