# A Bill

**SENATE BILL 253**

## For An Act To Be Entitled

8 "AN ACT TO AMEND ARKANSAS CODE ANN. TITLE 6, CHAPTER 50,  
9 TO ADD A NEW SUBCHAPTER 5, TO DIRECT THE VOCATIONAL AND  
10 TECHNICAL EDUCATIONAL DIVISION OF THE ARKANSAS DEPARTMENT  
11 OF EDUCATION TO ESTABLISH THE YOUTH APPRENTICESHIP/WORK-  
12 BASED LEARNING PROGRAM; AND FOR OTHER PURPOSES."

13  
14 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

15

16 SECTION 1. The Arkansas Code of 1987 Annotated is hereby amended to add  
17 the following:

18 "6-50-501. This subchapter may be cited as the Arkansas Youth  
19 Apprenticeship/Work-Based Learning Act of 1991.

20 6-50-502. Whereas workplace changes have profoundly altered and  
21 increased the skills required of workers and managers; and

22 Whereas schools are struggling to improve the basic skills of the school  
23 age population drawn increasingly from 'at risk' households where children  
24 tend to leave school early; and

25 Whereas many non-college bound youth, especially women and minorities,  
26 spend their first years after high school unemployed or job hopping from one  
27 low skills job to another, with a consequent loss in productivity and access  
28 to career-oriented learning; and

29 Whereas most new jobs that will be created in the 1990's will require  
30 some post-secondary education; and

31 Whereas the economic position of 'The Forgotten Half' -- non-college  
32 bound high school graduates -- is deteriorating with real earnings declining  
33 by 28% from 1973 to 1986, while the earnings of college graduates have risen;  
34 and

35 Whereas most employers in the U.S. lack a tradition of strong employee

1 training;

2           Now, therefore, the State of Arkansas has determined that the  
3 establishment of a Youth Apprenticeship Program can contribute significantly  
4 to addressing these problems by providing Arkansas' non-college bound young  
5 people with additional opportunities to develop meaningful job skills.

6           6-50-503 (a). The Vocational and Technical Education Division of the  
7 Arkansas Department of Education is hereby authorized and directed to develop  
8 and implement a Youth Apprenticeship/Work-Based Learning program to provide  
9 additional educational and training opportunities for non-college bound  
10 Arkansas high school students. The program should be based on the following  
11 fundamental principles:

12                   (1) Strong employer commitment and involvement;

13                   (2) Take young people at the end of the 10th grade through a  
14 three to four (3-4) year process connecting high school and the first year or  
15 two of postsecondary learning;

16                   (3) Provide high-quality supervised learning opportunities for  
17 students at the worksite;

18                   (4) Integrate academic and vocational teaching and learning in  
19 the classroom and at work;

20                   (5) Foster interactive, team based learning in the classroom;

21                   (6) Include curriculum on all aspects of the industry;

22                   (7) Use competency-based measures for evaluating student  
23 progress;

24                   (8) Provide both academic and occupational credentials;

25                   (9) Provide access and supports to non-traditional groups and  
26 explicitly address issues presented by diversity in society and the workplace.

27           (b) The industries and occupations selected for this program must offer  
28 entry-level jobs with good opportunities for career advancement into high  
29 skill, high wage jobs. The Division of Vocational and Technical Education,  
30 the Arkansas Apprenticeship Coordinating Steering Committee (AACSC) and local  
31 sites will take *joint responsibility for identifying these industries and*  
32 *occupations*. The AACSC will take responsibility for identifying  
33 'traditional' apprenticeship programs that are currently in place.

34           6-50-504. The Vocational and Technical Education Division of the  
35 Arkansas Department of Education shall implement during the 1991-93 biennium

1 at least five (5) demonstration youth apprenticeship programs. In designing  
2 and implementing such programs the Division shall require the selected  
3 demonstration projects to make a five (5) year commitment to the program's  
4 effective implementation and to match state funding with commitments from  
5 local participants including employers and unions, high schools, vocational  
6 and technical schools, community colleges, *technical colleges*, and other  
7 appropriate entities. State funding for the demonstration projects shall be  
8 from funds appropriated by the General Assembly to the Vocational and  
9 Technical Education Division for such purpose. *The award of funding for the*  
10 *demonstration projects authorized by this subchapter shall be made jointly by*  
11 *the State Board for Vocational Education and the State Board of Higher*  
12 *Education.*

13         6-50-505 (a). The State Board of Education may provide waivers of  
14 regulations adopted by either the General Education Division or the Vocational  
15 and Technical Educational Division when such waivers are necessary to  
16 accomplish the purposes of this subchapter, so long as such waivers will not  
17 weaken the quality of the educational opportunities provided.

18         (b) The Vocational and Technical Education Division shall also take the  
19 lead role in seeking the establishment of articulation agreements between high  
20 schools, vocational and technical schools,  
21 *and institutions of higher education*, with a goal of eliminating barriers to  
22 lifelong learning. *The resulting articulation agreements will need to be*  
23 *approved by the appropriate local and state boards of the participating school*  
24 *districts(s), post-secondary vocational and technical school(s), and*  
25 *institution(s) of higher education.*

26         (c) The State Board of Vocational and Technical Education is authorized  
27 to promulgate rules and regulations for the implementation of the program  
28 established by this subchapter."

29

30         SECTION 2. *Arkansas Code of 1987 Annotated, Title 6-52-207 is hereby*  
31 *amended to read as follows:*

32         "6-52-207. *Training programs generally.*

33

34         (a) *Pursuant to the provisions of this subchapter, the State Board for*  
35 *Vocational Education and the State Board of Higher Education shall jointly*

1 allocate state funds for the support of apprenticeship training programs that  
2 meet the criteria set forth in this subchapter.

3 (b) A program must be cosponsored by a public school district, an  
4 educational cooperative, a state postsecondary institution, a vo-tech school,  
5 a technical institute, or a two-year community college pursuant to a contract  
6 between the district or institution and an apprenticeship program sponsor.

7 (c) A program must be under the direction of an apprenticeship  
8 coordinator appointed by the apprenticeship program sponsor who shall perform  
9 the duties set forth in Section 6-52-208.

10 (d) Each apprentice participating in a program must be given a written  
11 apprenticeship agreement by the apprenticeship program sponsor stating the  
12 standards and conditions of his employment and training. The apprenticeship  
13 agreements are furnished by BAT.

14 (e) An apprentice may not be charged tuition or fees by a public school  
15 district or state postsecondary institution other than an administrative fee  
16 to cover the costs of processing his records which shall not exceed twenty-  
17 five dollars (\$25.00) for each course in which the apprentice is enrolled.  
18 The apprentice or the program sponsor may be required to furnish books and  
19 special equipment.

20 (f) Funding for a program, in addition to any other money available,  
21 shall be provided by the apprenticeship program sponsor pursuant to the terms  
22 of the contract referred to in subsection (b) of this section. The program  
23 sponsor may charge an apprentice or the employer of the apprentice tuition and  
24 fees to cover administrative costs incurred while the apprentice is registered  
25 with the program sponsor.

26 (g) Pursuant to the terms of the contract referred to in subsection (b)  
27 of this section, adequate facilities, personnel, and resources to effectively  
28 administer the apprenticeship training program in a manner consistent with the  
29 public's need for skilled workers and the apprentice's need for marketable  
30 skills in apprenticeable occupations must be provided.

31 (h) A program must be registered with the BAT and the Vocational and  
32 Technical Education Division."

33

34 SECTION 3. All provisions of this Act of a general and permanent nature  
35 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code

1 Revision Commission shall incorporate the same in the Code.

2

3 SECTION 4. If any provision of this Act or the application thereof to  
4 any person or circumstance is held invalid, such invalidity shall not affect  
5 other provisions or applications of the Act which can be given effect without  
6 the invalid provision or application, and to this end the provisions of this  
7 Act are declared to be severable.

8

9 SECTION 5. All laws and parts of laws in conflict with this Act are  
10 hereby repealed.
