To include "capacity or" previously omitted from Arkansas 25 26 Code § 5-37-208 in the legislative edition and to replace "if" with "and", 27 Arkansas Code § 5-37-208 is amended to read as follows: 2.8 "5-37-208. Criminal impersonation. (a) A person commits criminal impersonation if he does an act in his 30 pretended or assumed capacity or character with the purpose to injure or 31 defraud another person and he: 32 (1) Assumes a false identity; or (2) Pretends to be a representative of some person or organization; or 33 (3) Pretends to be an officer or employee of the government; or 34 (4) Pretends to have a handicap or disability.
