# A Bill

**SENATE BILL**

## For An Act To Be Entitled

8 "AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES AND  
9 OPERATING EXPENSES FOR THE STATE BOARD OF PAROLE AND  
10 COMMUNITY REHABILITATION FOR THE BIENNIAL PERIOD ENDING  
11 JUNE 30, 1993; AND FOR OTHER PURPOSES."

13 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

14  
15 SECTION 1. REGULAR SALARIES - OPERATIONS. There is hereby established  
16 for the State Board of Parole and Community Rehabilitation - Operations for  
17 the 1991-93 biennium, the following maximum number of regular employees whose  
18 salaries shall be governed by the provisions of the Uniform Classification and  
19 Compensation Act (Arkansas Code §§21-5-201 et seq.), or its successor, and all  
20 laws amendatory thereto. Provided, however, that any position to which a  
21 specific maximum annual salary is set out herein in dollars, shall be exempt  
22 from the provisions of said Uniform Classification and Compensation Act. All  
23 persons occupying positions authorized herein are hereby governed by the  
24 provisions of the Regular Salaries Procedures and Restrictions Act (Arkansas  
25 Code §21-5-101), or its successor.

 4 SECTION 2. APPROPRIATIONS - OPERATIONS. There is hereby appropriated,  
 5 to the State Board of Parole and Community Rehabilitation, to be payable from  
 6 the State General Services Fund Account, for personal services and operating  
 7 expenses of the State Board of Parole and Community Rehabilitation -  
 8 Operations for the biennial period ending June 30, 1993, the following:

 23 SECTION 3. All services, furnishings, equipment and office space  
 24 currently provided by the Department of Correction to the Board of Pardons and  
 25 Parole and the Commission on Community Based Rehabilitation shall continue to  
 26 be provided by the Department to the State Board of Parole and Community  
 27 Rehabilitation.

28  
 29 SECTION 4. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
 30 authorized by this Act shall be limited to the appropriation for such agency  
 31 and funds made available by law for the support of such appropriations; and  
 32 the restrictions of the State Purchasing Law, the General Accounting and  
 33 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
 34 Procedures and Restrictions Act, or their successors, and other fiscal control  
 35 laws of this State, where applicable, and regulations promulgated by the

1 Department of Finance and Administration, as authorized by law, shall be  
2 strictly complied with in disbursement of said funds.

4 SECTION 5. LEGISLATIVE INTENT. It is the intent of the General  
5 Assembly that any funds disbursed under the authority of the appropriations  
6 contained in this Act shall be in compliance with the stated reasons for which  
7 this Act was adopted, as evidenced by the Agency Requests, Executive  
8 Recommendations and Legislative Recommendations contained in the budget  
9 manuals prepared by the Department of Finance and Administration, letters, or  
10 summarized oral testimony in the official minutes of the Arkansas Legislative  
11 Council or Joint Budget Committee which relate to its passage and adoption.

13 SECTION 6. CODE. All provisions of this Act of a general and permanent  
14 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas  
15 Code Revision Commission shall incorporate the same in the Code.

17 SECTION 7. SEVERABILITY. If any provision of this Act or the  
18 application thereof to any person or circumstance is held invalid, such  
19 invalidity shall not affect other provisions or applications of the Act which  
20 can be given effect without the invalid provision or application, and to this  
21 end the provisions of this Act are declared to be severable.

22

23 SECTION 8. GENERAL REPEALER. All laws and parts of laws in conflict  
24 with this Act are hereby repealed.

25

26 SECTION 9. HEALTH PREMIUMS. The State Board of Parole and Community  
27 Rehabilitation shall not, during the 1992-93 fiscal year, spend more for  
28 health insurance per employee than the amount being contributed to the State  
29 Employees Health Insurance Program.

30

31 SECTION 10. EMERGENCY CLAUSE. It is hereby found and determined by the  
32 Seventy-Eighth General Assembly, that the Constitution of the State of  
33 Arkansas prohibits the appropriation of funds for more than a two (2) year  
34 period; that the effectiveness of this Act on July 1, 1991 is essential to the  
35 operation of the agency for which the appropriations in this Act are provided,

1 and that in the event of an extension of the Regular Session, the delay in the  
2 effective date of this Act beyond July 1, 1991 could work irreparable harm  
3 upon the proper administration and provision of essential governmental  
4 programs. Therefore, an emergency is hereby declared to exist and this Act  
5 being necessary for the immediate preservation of the public peace, health and  
6 safety shall be in full force and effect from and after July 1, 1991.
