7 **For An Act To Be Entitled**

8 "AN ACT TO PROVIDE FOR THE APPOINTMENT OF AN ADDITIONAL
9 MEMBER TO THE ARKANSAS STATE BOARD OF PHARMACY; AND FOR
10 OTHER PURPOSES."

12 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

13

14 SECTION 1. In addition to the members of the Arkansas State Board of
15 Pharmacy provided for in Arkansas Code 17-91-201, there shall, from and after
16 the effective date of this act, be appointed one (1) additional member of the
17 State Board of Pharmacy who shall be a licensed practicing pharmacist in this
18 state, to be appointed by the Governor upon the advice and recommendation of
19 the Pharmaceutical Section of the Arkansas Medical, Dental, and Pharmaceutical
20 Association. Said member shall be appointed for a term of five (5) years. In
21 the event a vacancy exists in said position due to death, resignation, or
22 other cause, a successor member to said position shall be appointed by the
23 Governor for the remainder of the unexpired portion of the term thereof in the
24 same manner as herein provided for the initial appointment. The additional
25 member of the Arkansas State *Pharmacy* Board, as provided for in this act,
26 shall qualify in the same manner, and shall be entitled to all rights and
27 privileges as a member of the board as authorized by law.

29 SECTION 2. All provisions of this act of a general and permanent nature
30 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
31 Revision Commission shall incorporate the same in the Code.

33 SECTION 3. If any provision of this act or the application thereof to
34 any person or circumstance is held invalid, such invalidity shall not affect
35 other provisions or applications of the act which can be given effect without

1 the invalid provision or application, and to this end the provisions of this
2 act are declared to be severable.

3

4 SECTION 4. All laws and parts of laws in conflict with this act are
5 hereby repealed.

6

7 SECTION 5. EMERGENCY. It is hereby found and determined by the General
8 Assembly that it is essential that the Arkansas State *Pharmacy* Board consist
9 of members who are representative of the major population elements of this
10 state; that the Arkansas Medical, Dental and Pharmaceutical Association is a
11 long standing organization of professionals in the state and that it is
12 appropriate that the membership of the State Board of Pharmacy be increased to
13 include one member appointed by the Governor from *three* (3) nominees submitted
14 by that organization; that this act is designed to accomplish this purpose and
15 should be given effect immediately. Therefore, an emergency is hereby
16 declared to exist and this act being necessary for the preservation of the
17 public peace, health and safety shall be in full force and effect from and
18 after its passage and approval.
