SENATE BILL

For An Act To Be Entitled

8 "AN ACT TO AMEND ARKANSAS CODE 27-23-110(a) AND 27-23-
9 111(b) (3) AS AMENDED BY ACT 164 OF 1991, TO EXEMPT PERSONS
10 APPLYING FOR A COMMERCIAL DRIVER LICENSE RESTRICTED TO
11 DRIVING A NONPROFIT DAY CARE CENTER BUS FROM PAYING AN
12 APPLICATION FEE; AND FOR OTHER PURPOSES."

14 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

15

16 SECTION 1. Arkansas Code 27-23-110(a) (8) as amended by Act 164 of 1991
17 is hereby amended to read as follows:

18 "(8) Any other information required by the Office of Driver Services.
19 The application must be accompanied by an application fee of sixty-one dollars
20 (\$61.00). The application fee shall not be required from a person who
21 requests that the license be restricted to the driving of a school bus, church
22 bus, nonprofit day care center bus, or bus operated by a public transit system
23 eligible to receive federal and state assistance under programs administered
24 through the Arkansas State Highway and Transportation Department or the United
25 States Department of Transportation; provided, however, that such person shall
26 be required to pay the noncommercial driver license fee."

27

28 SECTION 2. Arkansas Code 27-23-111(b) (3) as amended by Act 164 of 1991
29 is hereby amended to read as follows:

30 "(3) Endorsements and Restrictions.

31 'H' - authorizes the driver to drive a vehicle transporting hazardous
32 materials.

33 'K' - restricts the driver to vehicles not equipped with airbrakes.

34 'T' - authorizes driving double and triple trailers.

35 'P' - authorizes driving vehicles carrying passengers or carrying

1 passengers for hire.

2 'N' - authorizes driving tank vehicles.

3 'X' - represents a combination of hazardous materials and tank vehicle
4 endorsements.

5 'M' - authorizes the driver to drive a motorcycle.

6 'S' - restricts the driver to school buses, church buses, nonprofit day
7 care center buses, buses operated by public transit systems eligible to
8 receive federal and state assistance under programs administered through the
9 Arkansas State Highway and Transportation Department or the United States
10 Department of Transportation, and Class 'D' vehicles."

11

12 SECTION 3. All provisions of this act of a general and permanent nature
13 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
14 Revision Commission shall incorporate the same in the Code.

15

16 SECTION 4. If any provision of this act or the application thereof to
17 any person or circumstance is held invalid, such invalidity shall not affect
18 other provisions or applications of the act which can be given effect without
19 the invalid provision or application, and to this end the provisions of this
20 act are declared to be severable.

22 SECTION 5. All laws and parts of laws in conflict with this act are
23 hereby repealed.
