14	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

16	SECTION 1. There is hereby created and established on the books of the
17	Chief Fiscal Officer of the State, the State Treasurer and the State Auditor,
18	the "78th Session Projects Account" within the "General Improvement Fund",
19	into which shall be transferred and credited the respective monies as
20	hereinafter provided in this Act, to be used for providing financing, in the
21	manner set forth herein, for the various projects and purposes enumerated in
22	this Act to be financed from said account.
23	Immediately upon the effective date of this Act, or as soon thereafter
24	as is practical, the State Treasurer shall transfer and credit to the "78th
25	Session Projects Account" of the "General Improvement Fund", upon
26	certification of the amounts thereof by the Chief Fiscal Officer of the State,
27	the following:
28	(a) all unobligated and unallocated monies remaining in the "General
29	Improvement Fund" which are not required to finance projects to be financed
30	therefrom pursuant to appropriations enacted by the 77th General Assembly, or

32	"General Improvement Fund" by the 78th General Assembly.
33	(b) any unobligated or unallocated funds remaining in the "General
