HOUSE BILL 1042

For An Act To Be Entitled

7 "AN ACT TO MAKE AN APPROPRIATION TO PROVIDE SUPPLEMENTAL
8 SUPPORT FOR EXPENSES INCURRED IN FOLLOW-UP ACTIVITIES OF
9 THE YOUTH OPPORTUNITIES UNLIMITED PROGRAM OF HENDERSON
10 STATE UNIVERSITY FOR THE BIENNIAL PERIOD ENDING JUNE 30,
11 1993; AND FOR OTHER PURPOSES."

13 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

14
15 SECTION 1. APPROPRIATIONS - YOUTH OPPORTUNITIES UNLIMITED PROGRAM.
16 There is hereby appropriated, to Henderson State University, to be payable
17 from the Henderson State University Fund, for providing supplemental support
18 for expenses incurred in follow-up activities of the Youth Opportunities
19 Unlimited Program, the sum of \$160,000 for the biennial period ending June 30,
20 1993.

22 SECTION 2. FUNDING TRANSFER. Immediately upon the effective date of
23 this Act, the Chief Fiscal Officer of the State shall transfer on his books
24 and those of the State Treasurer the sum of \$160,000 or so much thereof that
25 is available, from the Tuberculosis Sanatorium Lease Fund to the Henderson
26 State University Fund to provide funds for the appropriation provided herein.

27
28 SECTION 3. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
29 authorized by this Act shall be limited to the appropriation for such agency
30 and funds made available by law for the support of such appropriations; and
31 the restrictions of the State Purchasing Law, the General Accounting and
32 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
33 Procedures and Restrictions Act, the Higher Education Expenditure Restrictions
34 Act, or their successors, and other fiscal control laws of this State, where
35 applicable, and regulations promulgated by the Department of Finance and

1 Administration, as authorized by law, shall be strictly complied with in
2 disbursement of said funds.

4 SECTION 4. LEGISLATIVE INTENT. It is the intent of the General
5 Assembly that any funds disbursed under the authority of the appropriations
6 contained in this Act shall be in compliance with the stated reasons for which
7 this Act was adopted, as evidenced by the Agency Requests, Executive
8 Recommendations and Legislative Recommendations contained in the budget
9 manuals prepared by the Department of Finance and Administration, letters, or
10 summarized oral testimony in the official minutes of the Arkansas Legislative
11 Council or Joint Budget Committee which relate to its passage and adoption.

13 SECTION 5. CODE. All provisions of this Act of a general and permanent
14 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
15 Code Revision Commission shall incorporate the same in the Code.

16

17 SECTION 6. SEVERABILITY. If any provision of this Act or the
18 application thereof to any person or circumstance is held invalid, such
19 invalidity shall not affect other provisions or applications of the Act which
20 can be given effect without the invalid provision or application, and to this
21 end the provisions of this Act are declared to be severable.

23 SECTION 7. GENERAL REPEALER. All laws and parts of laws in conflict
24 with this Act are hereby repealed.

26 SECTION 8. EMERGENCY CLAUSE. It is hereby found and determined by the
27 Seventy-Eighth General Assembly, meeting in 1st Extraordinary Session, that in
28 order to provide financial support for follow-up activities of the Henderson
29 State University Youth Opportunities Unlimited Program, an emergency is hereby
30 declared to exist, and this Act being necessary for the immediate preservation
31 of the public peace, health and safety shall be in full force and effect upon
32 passage and approval.
