HOUSE BILL 1078

For An Act To Be Entitled

8 "AN ACT TO INCREASE THE *SAFETY INSPECTION* FEE BY ONE
9 DOLLAR (\$1.00) WITH ONE-HALF OF THE INCREASE TO GO TO THE
10 INSPECTION STATION AND THE OTHER HALF TO THE ARKANSAS
11 STATE POLICE; AND FOR OTHER PURPOSES."

14 "TO INCREASE THE *SAFETY INSPECTION* FEE BY ONE DOLLAR
15 (\$1.00)."

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19 *SECTION 1. Arkansas Code 27-32-110(b)(3) is amended to read as follows:*

20 *"(3) The official certificates of inspection and approval shall be*
21 *obtained from the authority at a cost of two dollars (\$2.00) per certificate."*

23 *SECTION 2. Arkansas Code 27-32-112(b) is amended to read as follows:*

24 *"(b)(1) The fee for the inspection, including the issuance of the*
25 *certificate of approval, shall be four dollars and fifty cents (\$4.50), with*
26 *the exception of all motor trucks, trailers, semitrailers, and pole trailers*
27 *in excess of gross loaded weight of eight thousand pounds (8,000 lbs.).*

28 *(2) The fee for inspection, including the issuance of the certificate*
29 *of approval, for all motor trucks, trailers, semitrailers, and pole trailers*
30 *with a gross loaded weight in excess of eight thousand pounds (8,000 lbs.)*
31 *shall be under rules and regulations prescribed by the director but shall be*
32 *not less than four dollars and fifty cents (\$4.50) nor more than eighteen*
33 *dollars and fifty cents (\$18.50) per inspection."*

35 *SECTION 3. Arkansas Code 27-32-116(b) is amended to read as follows:*

1 "(b) Three-fourths (3/4ths) of the amount collected by the department
 2 for the purchase of certificates of inspection under § 27-32-110(b)(3) shall
 3 be remitted to the authority and the other one-fourth (1/4th) shall be
 4 deposited in the State Treasury as special revenues and credited to the State
 5 Police Fund. Three-fourths (3/4ths) of the amounts derived from the sale of
 6 certificates of inspection, whether held by the department or the authority,
 7 shall be cash funds of the authority, not subject to appropriation, and shall
 8 be used and applied by the authority only as provided in this section and
 9 §22-3-1225."

10

11 SECTION 4. All provisions of this act of a general and permanent nature
 12 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
 13 Revision Commission shall incorporate the same in the Code.

14

15 SECTION 5. If any provision of this act or the application thereof to
 16 any person or circumstance is held invalid, such invalidity shall not affect
 17 other provisions or applications of the act which can be given effect without
 18 the invalid provision or application, and to this end the provisions of this
 19 act are declared to be severable.

21 SECTION 6. All laws and parts of laws in conflict with this act are
 22 hereby repealed.
