# A Bill

**HOUSE BILL 1112**

## For An Act To Be Entitled

8 "AN ACT TO AMEND §24-11-802 TO CHANGE THE MEETING  
9 REQUIREMENTS OF THE FIREMEN\_S RELIEF AND PENSION FUND  
10 BOARD FOR ALL FIRST CLASS CITIES FROM MONTHLY TO  
11 QUARTERLY; AND FOR OTHER PURPOSES."

## Subtitle

14 "TO CHANGE THE FIREMEN\_S RELIEF AND PENSION FUND BOARD FOR  
15 ALL FIRST CLASS CITIES."

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19 SECTION 1. Arkansas Code §24-11-802 is hereby amended to read as  
20 follows:

21 "24-11-802. Board of trustees - Proceedings.

22 (a) The board shall hold such meetings as required by this section and  
23 upon the call of its president at such other times as the president deems  
24 necessary.

25 (b) It shall issue orders signed by the president and secretary to the  
26 persons entitled thereto for the amount of money ordered paid to the persons  
27 from the fund by the board, which order shall state for what purpose the  
28 payment is made.

29 (c) It shall keep a record of its proceedings, which record shall be a  
30 public record.

31 (d) At each meeting, it shall send to the treasurer of the city or town  
32 a written or printed list of all persons entitled to payment from the fund  
33 provided for in this subchapter. This list shall state the amount of the  
34 payment and for what granted and shall be certified to and signed by the  
35 president and secretary of the board and attested under oath.

1 (e) The treasurer of the city or town shall thereupon enter a copy of  
2 the list upon the book to be kept for that purpose, which book shall be known  
3 as *\_The Firemen's Relief and Pension Fund Book,\_* and the board shall direct  
4 payment of the amounts named therein to the persons entitled thereto out of  
5 those funds.

6 (f) A majority of all the members of the board shall constitute a  
7 quorum and shall have the power to transact business.

8 (g) No money belonging to the fund shall ever be disbursed for any  
9 purpose without a vote of a majority of all the members of the board of  
10 trustees, which shall be taken by the *\_yeas\_* and *\_nays,\_* and the vote of each  
11 member so voting shall be entered upon the proceedings of the board.

12 (h) The firemen's relief and pension fund board for towns and  
13 second-class cities shall meet on the first Monday of each quarter for a total  
14 of at least four (4) meetings per year. The firemen's relief and pension fund  
15 board for first-class cities *may meet monthly on the first Monday of each*  
16 *month, but shall meet at least quarterly on the first Monday of each quarter*  
17 *for a total of at least four (4) meetings per year.*

18 (i) The firemen's relief and pension fund board for first and  
19 second-class cities and incorporated towns shall have the option to designate  
20 a night other than Monday for their required meetings, which designation shall  
21 be contained in the minutes and records of the board meetings."  
22

23 SECTION 2. All provisions of this act of a general and permanent nature  
24 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
25 Revision Commission shall incorporate the same in the Code.  
26

27 SECTION 3. If any provision of this act or the application thereof to  
28 any person or circumstance is held invalid, such invalidity shall not affect  
29 other provisions or applications of the act which can be given effect without  
30 the invalid provision or application, and to this end the provisions of this  
31 act are declared to be severable.

33 SECTION 4. All laws and parts of laws in conflict with this act are  
34 hereby repealed.
