# **A Bill**

**HOUSE BILL 1321**

## **For An Act To Be Entitled**

8 "AN ACT TO AUTHORIZE THE CITY OF BOONEVILLE TO DONATE  
9 APPROXIMATELY ONE-HALF (1/2) ACRE OF CITY PROPERTY TO  
10 LOGAN COUNTY; AND FOR OTHER PURPOSES."

## **Subtitle**

13 "AUTHORIZE CITY OF BOONEVILLE TO DONATE APPROXIMATELY 1/2  
14 ACRE OF CITY PROPERTY TO LOGAN COUNTY."

16 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

18 SECTION 1. The City of Booneville is hereby authorized to donate and  
19 convey to Logan County the following described property:  
20 Part of the Southwest Quarter (SW 1/4) of the Northwest Quarter (NW 1/4) of  
21 Section 34, Township 6 North, Range 27 West, Logan County, Arkansas  
22 being described as follows:  
23 Commencing at the NW corner of the SE 1/4, NW 1/4; Thence S 89°23\_30" E along  
24 the south line of said forty, a distance of 696.18 feet to a point;  
25 Thence N 1°03\_02" E a distance of 39.64 feet to an iron pin set on the  
26 north right-of-way of Arkansas State Highway #10, and the point of  
27 beginning;  
28 Thence N 1°03\_02" E a distance of 160.00 feet to an iron pin set;  
29 Thence S 89°23\_30" E a distance of 160.00 feet to an iron pin set;  
30 Thence S 1°03\_02" W a distance of 160.00 feet to an iron pin set on the north  
31 right-of-way of Arkansas State Highway #10;  
32 Thence N 89°23\_30" W along said right-of-way, a distance of 160.00 feet to the  
33 Point of Beginning and containing 0.59 acres more or less.

1 SECTION 2. All provisions of this act of a general and permanent nature  
2 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
3 Revision Commission shall incorporate the same in the Code.

4  
5 SECTION 3. If any provision of this act or the application thereof to  
6 any person or circumstance is held invalid, such invalidity shall not affect  
7 other provisions or applications of the act which can be given effect without  
8 the invalid provision or application, and to this end the provisions of this  
9 act are declared to be severable.

10  
11 SECTION 4. All laws and parts of laws in conflict with this act are  
12 hereby repealed.

13  
14 SECTION 5. EMERGENCY. *It is hereby found and determined by the General*  
15 *Assembly that Logan County is in dire need of property owned by the City of*  
16 *Booneville which the city desires to donate to Logan County; that it is in the*  
17 *best interest of the citizens of Booneville and Logan County that the transfer*  
18 *of the property occur as soon as possible; and that such transfer cannot occur*  
19 *until this act becomes effective. Therefore, an emergency is hereby declared*  
20 *to exist, and this act being immediately necessary for the preservation of the*  
21 *public peace, health and safety, shall be in full force and effect from and*  
22 *after its passage and approval.*
