HOUSE BILL

For An Act To Be Entitled

8 "AN ACT TO AMEND ARKANSAS CODE 16-21-801(d) TO INCREASE
9 THE SALARY AND EXPENSES OF THE DEPUTY PROSECUTING ATTORNEY
10 FOR RANDOLPH COUNTY; AND FOR OTHER PURPOSES."

Subtitle

13 "TO INCREASE THE SALARY AND EXPENSES OF THE DEPUTY
14 PROSECUTING ATTORNEY FOR RANDOLPH COUNTY."

16 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

18 SECTION 1. Arkansas Code 16-21-801(d) is amended to read as follows:
19 "(d) The annual salary for the deputy prosecuting attorney for Randolph
20 County shall be a minimum of twelve thousand five hundred dollars (\$12,500)
21 and a maximum of twenty thousand dollars (\$20,000), to be paid by the county.
22 The Randolph County deputy prosecuting attorney shall receive an annual
23 expense allowance of a minimum of six thousand dollars (\$6,000) and a maximum
24 of ten thousand dollars (\$10,000), to be paid by the county. The salary and
25 expenses provided in this subsection shall apply retroactively to January 1,
26 1993."

28 SECTION 2. All provisions of this act of a general and permanent nature
29 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
30 Revision Commission shall incorporate the same in the Code.

32 SECTION 3. If any provision of this act or the application thereof to
33 any person or circumstance is held invalid, such invalidity shall not affect
34 other provisions or applications of the act which can be given effect without
35 the invalid provision or application, and to this end the provisions of this

1 act are declared to be severable.

3 SECTION 4. All laws and parts of laws in conflict with this act are
4 hereby repealed.

5

6 SECTION 5. EMERGENCY. It is hereby found and determined by the General
7 Assembly that the present law establishing the salary of deputy prosecuting
8 attorney for Randolph County is inadequate; that this act will give Randolph
9 County more flexibility in setting the salary for its deputy prosecuting
10 attorney; and that until this act goes into effect the county will not have
11 the necessary flexibility for establishing an adequate salary for the deputy
12 prosecuting attorney. Therefore, an emergency is hereby declared to exist and
13 this act being necessary for the immediate preservation of the public peace,
14 health and safety shall be in full force and effect from and after its passage
15 and approval.
