# A Bill

**HOUSE BILL**

## For An Act To Be Entitled

8 "AN ACT TO AMEND ARKANSAS CODE 22-3-1001 TO ENLARGE THE  
9 MEMBERSHIP OF THE WAR MEMORIAL STADIUM COMMISSION BY TWO  
10 (2) MEMBERS; TO ADJUST THE NUMBER OF MEMBERS NEEDED TO  
11 CALL A MEETING AND CONDUCT BUSINESS; AND FOR OTHER  
12 PURPOSES."

## Subtitle

14 "TO ENLARGE THE MEMBERSHIP OF THE WAR MEMORIAL STADIUM  
15 COMMISSION."

17  
18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19  
20 SECTION 1. Arkansas Code 22-3-1001(a) is amended to read as follows:

21 "(a) There is created a Stadium Commission consisting of ten (10)  
22 members to be appointed by the Governor with the advice and consent of the  
23 Senate. The commission shall have exclusive jurisdiction for the operation of  
24 the stadium known as War Memorial Stadium which shall be for the use of all  
25 the schools, colleges, and universities of the state under the supervision of  
26 the Stadium Commission."  
27

28 SECTION 2. Arkansas Code 22-3-1001(b) is amended to read as follows:

29 "(b) Each congressional district of the state shall be represented by  
30 membership on the commission, and the other six (6) members shall be from the  
31 state at large."  
32

33 SECTION 3. Arkansas Code 22-3-1001(j) is amended to read as follows:

34 "(j) All meetings of the commission shall be held on call by the  
35 chairman, or by any five (5) or more members, on advance notice to each member

1 and at such place as in each instance may suit the commission's convenience.  
2 All meetings shall be open to the public, and complete records of the  
3 proceedings shall be kept."

4

5 SECTION 4. Arkansas Code 22-3-1001(k) is amended to read as follows:

6 "(k) A quorum for the transaction of business at any meeting shall  
7 consist of not less than five (5) members, and such quorum shall have the  
8 power to act for the commission by an affirmative vote of a majority thereof,  
9 except that the affirmative vote of not less than five (5) members shall be  
10 requisite for the adoption of any motion or resolution involving the  
11 expenditure of funds."

12

13 SECTION 5. All provisions of this act of a general and permanent nature  
14 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
15 Revision Commission shall incorporate the same in the Code.

16

17 SECTION 6. If any provision of this act or the application thereof to  
18 any person or circumstance is held invalid, such invalidity shall not affect  
19 other provisions or applications of the act which can be given effect without  
20 the invalid provision or application, and to this end the provisions of this  
21 act are declared to be severable.

22

23 SECTION 7. All laws and parts of laws in conflict with this act are  
24 hereby repealed.
