14	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
15	
16	ARTICLE 1: GENERAL PROVISIONS
17	
18	§101. Short Title.
19	This Act shall be known and may be cited as the Small Business Entity
20	Tax Pass Through Act.
21	§102. Definitions.
22	As used in this Act, unless the context otherwise requires:
23	(a) "Articles of Organization" means Articles filed under §201, and
24	those Articles as amended and restated.
25	(b) "Corporation" means a corporation formed under the laws of any
26	state or foreign country including professional corporations or associations.
27	(c) "Court" includes every court having jurisdiction in the case.
28	(d) "Event of Dissociation" means an event that causes a Person to
29	cease to be a Member as provided in §802.
30	(e) "Foreign Limited Liability Company" means an organization that is:
31	(1) An unincorporated association;
32	(2) Organized under laws of a state other than the laws of this
33	state, or under the laws of any foreign country;
34	(3) Organized under a statute pursuant to which an association
35	may be formed that affords to each of its Members limited

- 1 liability with respect to the liabilities of the entity; and
- 2 (4) Not required to be registered or organized under any statute
- of this state other than this Act.
- 4 (f) "Limited Liability Company" or "Domestic Limited Liability Company"
- 5 means an organization formed under this Act.
- 6 (g) "Limited Liability Company Interest" or "Interest in the Limited
- 7 Liability Company" means the interest that can be assigned under §704 and
- 8 charged under §705.
- 9 (h) "Limited Partnership" means a limited partnership formed under the
- 10 laws of any state or foreign country.
- 11 (i) "Manager" or "Managers" means, with respect to a Limited Liability
- 12 Company that has set forth in its Articles of Organization that it is to be
- 13 managed by Managers, the Person or Persons designed in accordance with §401.
- 14 (j) "Member" or "Members" means a Person or Persons who have been
- 15 admitted to Membership in a Limited Liability Company as provided in §801 and
- 16 who have not ceased to be Members as provided in §802.
- 17 (k) "Operating Agreement" means the written agreement which shall be
- 18 entered into among all of the Members as to the conduct of the business and
- 19 affairs of a Limited Liability Company.
- 20 (1) "Person" means an individual, a general partnership, a Limited
- 21 Partnership, a Domestic or Foreign Limited Liability Company, a trust, an
- 22 estate, an association, a corporation, a custodian, a nominee and other
- 23 individual entity in its own or representative capacity, or any other legal
- 24 entity.
- 25 (m) "Professional Service" means any type of professional service which
- 26 may be legally performed only pursuant to a license or other legally mandated
- 27 personal authorization. For example: the personal service rendered by
- 28 certified public accountants, architects, engineers, dentists, doctors and
- 29 attorneys at law.
- 30 (n) "State" means a state, territory, or possession of the United
- 31 States, the District of Columbia, or the Commonwealth of Puerto Rico.
- 32 §103. Name.
- 33 (a) The name of each Limited Liability Company as set forth in its
- 34 Articles of Organization must contain the words "Limited Liability Company" or
- 35 "Limited Company" or the abbreviations "L.L.C.," "L.C.," "LLC," or "LC." The

- 1 word "Limited" may be abbreviated as "Ltd." and the word "company" may be
- 2 abbreviated as "Co."
- 3 (b) A Limited Liability Company name may not be the same or deceptively
- 4 similar to:
- 5 (1) The name of any Limited Liability Company, Limited
- 6 Partnership, or Corporation existing under the laws of this state
- 7 or authorized to transact business in this State; or
- 8 (2) Any name reserved under §104.
- 9 (c) The provisions of subsection (b) shall not apply if the applicant
- 10 files with the Secretary of State either of the following:
- 11 (1) The written consent of the holder of a reserved or registered
- 12 name to use a deceptively similar name if one or more words are
- 13 added, altered, or deleted to make the name distinguishable from
- 14 the reserved or registered name; or
- 15 (2) A certified copy of a final decree of a court of competent
- 16 jurisdiction establishing the prior right of the applicant to the
- 17 use of the name in this State.
- 18 (d) The name of a Limited Liability Company which performs Professional
- 19 Service shall in addition contain the words "Professional Limited Liability
- 20 Company" or "Professional Limited Company" or the abbreviations "P.L.L.C.,"
- 21 "P.L.C.," "PLLC," "PLC," and the words "Limited" and "Company" may be
- 22 abbreviated as "Ltd." or "Co." and may not contain the name of any person who
- 23 is not a Member, except that the name of a deceased former Member or deceased
- 24 Member of a predecessor organization may continue to be included in the name.
- 25 §104. Reservation of Name.
- 26 (a) The exclusive right to use a name may be reserved by:
- 27 (1) Any Person intending to organize a Limited Liability Company
- and to adopt that name;
- 29 (2) Any Limited Liability Company or any Foreign Limited
- 30 Liability Company registered in this state that intends to adopt
- 31 that name:
- 32 (3) Any Foreign Limited Liability Company intending to register
- in this State and to adopt that name; or
- 34 (4) Any Person intending to organize a Foreign Limited Liability
- 35 Company and to have it registered in this State and to adopt that

- 1 name.
- 2 (b) The reservation shall be made by filing with the Secretary of State
- 3 an application, executed by the applicant, to reserve a specified name. If
- 4 the Secretary of State finds that the name is available for use by a Domestic
- 5 or Foreign Limited Liability Company, the Secretary of State shall reserve the
- 6 name of the exclusive use of the applicant for a period of 120 days from and
- 7 after the date the application is filed with the Secretary of State.
- 8 (c) The holder of a reserved Limited Liability Company name may renew
- 9 the reservation for two (2) successive periods of 120 days each from the date
- 10 of the first renewal.
- 11 (d) The right to the exclusive use of a reserved name may be
- 12 transferred to another Person by filing with the Secretary of State a notice
- 13 of the transfer, executed by the applicant for whom the name was reserved, and
- 14 specifying the name to be transferred and the name and address of the
- 15 transferee. The transfer shall not extend the term during which the name is
- 16 reserved.
- 17 §105. Registered Office, Registered Agent and Service of Process.
- 18 (a) A Limited Liability Company shall continuously maintain in this
- 19 State:
- 20 (1) A registered office that may, but need not, be the same as
- 21 its place of business; and
- 22 (2) A registered agent for service of process on the Limited
- 23 Liability Company that is an individual resident of this State, a
- Limited Liability Company, a Foreign Limited Liability Company
- 25 authorized to transact business in this State, or a corporation
- 26 formed under the laws of or authorized to transact business in
- this State.
- 28 (3) A copy of the Operating Agreement shall be maintained at the
- 29 registered office at all times.
- 30 (b) Unless the registered agent signed the document making the
- 31 appointment, the appointment of a registered agent or a successor registered
- 32 agent on whom process may be served is not effective until the agent delivers
- 33 a statement in writing to the Secretary of State accepting the appointment.
- 34 (c) A Limited Liability Company may change its registered office or
- 35 registered agent, or both, by delivering to the Secretary of State a statement

- 1 setting forth:
- 2 (1) The name of the Limited Liability Company.
- 3 (2) The address of its current registered office.
- 4 (3) If the address of its registered office is to be changed, the
- 5 address to which the registered office is to be changed.
- 6 (4) The name and address of its current registered agent.
- 7 (5) If its registered agent or the registered agent's address is
- 8 to be changed, the name and address of its successor registered
- 9 agent or the registered agent's new address.
- 10 (d) The change of address of the registered office or registered agent
- 11 is effective on delivery of the statement to the Secretary of State. The
- 12 appointment of a new registered agent is effective on delivery of the
- 13 statement to the Secretary of State and on receipt by the Secretary of State
- 14 of evidence that the new registered agent has accepted appointment pursuant to
- 15 subsection (b).
- 16 (e) A registered agent of a Limited Liability Company may resign as
- 17 registered agent by delivering a written notice of resignation, executed in
- 18 duplicate, to the Secretary of State. The Secretary of State shall mail a
- 19 copy of the notice to the Limited Liability Company at its registered office.
- 20 The appointment of the registered agent terminates thirty days after receipt
- 21 of the notice by the Secretary of State or on the appointment of a successor
- 22 registered agent, whichever occurs first.
- 23 (f) If a registered agent changes its address to another place in this
- 24 State, it may change the address by delivering a statement to the Secretary of
- 25 State as required by subsection (c), except that the statement need be signed
- 26 only by the registered agent. The statement shall recite that a copy of it
- 27 has been mailed to the Limited Liability Company.
- 28 §106. Nature of Business; Powers.
- 29 (a) A Limited Liability Company may be organized under this Act for any
- 30 lawful purpose including the performance of Professional Services and related
- 31 activities. If the purpose for which a Limited Liability Company is organized
- 32 or its activities make it subject to a special provision of law, the Limited
- 33 Liability Company shall also comply with that provision.
- 34 (b) A Limited Liability Company shall possess and may exercise all
- 35 powers and privileges granted by this act or by any other law or by its

- 1 Operating Agreement, together with any powers incidental thereto, so far as
- 2 such powers and privileges are necessary or convenient to the conduct,
- 3 promotion or attainment of the business, purposes or activities of the Limited
- 4 Liability Company.
- 5 § 107. Service of Process.
- 6 (a) Service of legal process, notice or demand required or permitted by
- 7 law to be served upon any Domestic or Foreign Limited Liability Company shall
- 8 be made on the registered agent of the Domestic or Foreign Limited Liability
- 9 Company in the State of Arkansas, as provided by law.
- 10 (b) In cases where legal process cannot by due diligence serve the
- 11 process in any manner provided for by subsection (a) of this section, it shall
- 12 be lawful to serve the process against a Domestic or Foreign Limited Liability
- 13 Company upon the Secretary of State, and such service shall be as effectual
- 14 for all intents and purposes as if made in any of the ways provided for in
- 15 subsection (a) hereof. In the event that service is effected through the
- 16 Secretary of State in accordance with this subsection, the Secretary of State
- 17 shall forthwith notify the Domestic or Foreign Limited Liability Company by
- 18 letter, certified mail, return receipt requested, directed to the Domestic or
- 19 Foreign Limited Company at its address as it appears on the records relating
- 20 to such Limited Liability Company on file with the Secretary of State or, if
- 21 no such address appears, at its last Registered Office. Such letter shall
- 22 enclose a copy of the process and any other papers served on the Secretary of
- 23 State pursuant to this subsection. It shall be the duty of the plaintiff in
- 24 the event of such service to serve process and any other papers in duplicate,
- 25 to notify the Secretary of State that service is being effected pursuant to
- 26 this subsection, and to pay the Secretary of State the sum of twenty-five
- 27 dollars (\$25.00) for the use of the State of Arkansas, which sum shall be
- 28 taxed as part of the costs in the proceeding if the plaintiff shall prevail
- 29 therein. The Secretary of State shall maintain an alphabetical record of any
- 30 such service setting forth the name of the plaintiff and defendant, the title,
- 31 docket number and nature of the proceeding in which process has been served
- 32 upon him, the fact that service has been effected pursuant to this subsection,
- 33 the return date thereof, and the day and hour when the service was made. The
- 34 Secretary of State shall not be required to retain such information for a
- 35 period longer than five (5) years from his receipt of the service of process.

- 1 (c) Nothing herein contained limits or affects the rights to serve
- 2 process in any other manner now or hereafter provided by law. These
- 3 provisions are an extension of and not a limitation upon rights otherwise
- 4 existing for service of legal process upon nonresidents.
- 5 ARTICLE 2: FORMATION
- 6 §201. Formation.
- 7 One or more Persons may form a Limited Liability Company by signing or
- 8 causing to be signed Articles of Organization and delivering the signed
- 9 Articles to the Secretary of State for filing. The Person or Persons who sign
- 10 the Articles of Organization causing the formation of a Limited Liability
- 11 Company need not be Members of the Limited Liability Company at the time of
- 12 formation or after formation has occurred.
- 13 §202. Articles of Organization
- 14 The Articles of Organization shall set forth:
- 15 (a) A name for the Limited Liability Company that satisfies the
- 16 requirements of §103;
- 17 (b) The address of the registered office and the name and business
- 18 residence, or mailing address of the registered agent required to be
- 19 maintained by §105;
- 20 (c) The latest date upon which the Limited Liability Company is to
- 21 dissolve; and
- 22 (d) If management of the Limited Liability Company is vested in a
- 23 Manager or Managers, a statement to that effect.
- 24 §203. Effect of Delivery or Filing of Articles of Organization.
- 25 (a) Unless delayed effective date is recited in the Articles of
- 26 Organization, A Limited Liability Company is formed when the Articles of
- 27 Organization are delivered to the Secretary of State for filing, even if the
- 28 Secretary of State is unable at the time of delivery to make the determination
- 29 required for filing by §1301. If the Articles of Organization, as delivered
- 30 to the Secretary of State, do not conform to the filing provisions of this Act
- 31 and are not brought into conformance within the time period prescribed by
- 32 §1301, the existence of the Limited Liability Company terminates at the end of
- 33 such time period.
- 34 (b) Each copy of the Articles of Organization stamped "filed" and
- 35 marked with the filing date is conclusive evidence that all conditions

- 1 precedent required to be performed by the organizers have been complied with
- 2 and that the Limited Liability Company has been legally organized and formed
- 3 under this Act.
- 4 §204. Amendment of Articles of Organization; Restatement.
- 5 (a) The Articles of Organization of a Limited Liability Company may be
- 6 amended by filing Articles of Amendment with the Secretary of State. The
- 7 Articles of Amendment shall set forth:
- 8 (1) The name of the Limited Liability Company;
- 9 (2) The date the Articles of Organization were filed; and
- 10 (3) The amendment to the Articles of Organization.
- l1 (b) The Articles of Organization may be amended in any respects as may
- 12 be desired, so long as the Articles of Organization as amended contain only
- 13 provisions that may be lawfully contained in Articles of Organization at the
- 14 time of making the amendment.
- 15 (c) Articles of Organization may be restated at any time. Restated
- 16 Articles of Organization shall be filed with the Secretary of State and shall
- 17 be specifically designated as such in the heading and shall state either in
- 18 the heading or in an introductory paragraph the Limited Liability Company's
- 19 present name and, if it has been changed, all of its former names and the date
- 20 of the filing of its Articles of Organization.
- 21 ARTICLE 3: RELATIONS OF MEMBERS AND MANAGERS
- 22 TO PERSONS DEALING WITH THE LIMITED LIABILITY COMPANY
- 23 §301. Agency Power of Members and Managers.
- 24 (a) Except as provided in subsection (b), every Member is an agent of
- 25 the Limited Liability Company for the purpose of its business or affairs, and
- 26 the act of any Member, including, but not limited to, the execution in the
- 27 name of the Limited Liability Company of any instrument, for apparently
- 28 carrying on in the usual way the business or affairs of the Limited Liability
- 29 Company of which he is a Member, binds the Limited Liability Company, unless
- 30 the Member so acting has, in fact, no authority to act for the Limited
- 31 Liability Company in the particular matter, and the Person with whom the
- 32 Member is dealing has knowledge of the fact that the Member has no such
- 33 authority.
- 34 (b) If the Articles of Organization provide that management of the
- 35 Limited Liability Company is vested in a Manager or Managers:

- 1 (1) No Member solely by reason of being a Member, is an agent of
- 2 the Limited Liability Company; and
- 3 (2) Every Manager is an agent of the Limited Liability Company
- for the purpose of its business or affairs, and the act of any
- 5 Manager, including, but not limited to, the execution in the name
- 6 of the Limited Liability Company of any instrument, for apparently
- 7 carrying on in the usual way the business or affairs of the
- 8 Limited Liability Company of which he is a Manager binds the
- 9 Limited Liability Company, unless the Manager so acting has, in
- 10 fact, no authority to act for the Limited Liability Company in the
- 11 particular matter, and the Person with whom the Manager is dealing
- has knowledge of the fact that the Manager has no such authority.
- 13 (c) An act of a Manager or a Member which is not apparently for the
- 14 carrying on in the usual way the business or affairs of the Limited Liability
- 15 Company does not bind the Limited Liability Company unless authorized in
- 16 accordance with an Operating Agreement, at the time of the transaction or any
- 17 other time.
- 18 (d) No act of a Manager or Member in contravention of a restriction on
- 19 authority shall bind the Limited Liability Company to Persons having knowledge
- 20 of the restriction.
- 21 §302. Admissions by Members and Managers.
- 22 (a) Except as provided in subsection (b), an admission or
- 23 representation made by any Member concerning the business or affairs of a
- 24 Limited Liability Company within the scope of his authority as provided for by
- 25 this Act is evidence against the Limited Liability Company.
- 26 (b) If the Articles of Organization provide that management of the
- 27 Limited Liability Company is vested in a Manager or Managers:
- 28 (1) An admission or representation made by a Manager concerning
- 29 the business or affairs of a Limited Liability Company within the
- 30 scope of the Manager's authority as provided for by this Act is
- 31 evidence against the Limited Liability Company; and
- 32 (2) The admission or representation of any Member, acting solely
- in the capacity of a Member, shall not constitute evidence against
- 34 the Limited Liability Company.
- 35 §303. Limited Liability Company Charged with Knowledge of or Notice to

- 1 Member or Manager.
- 2 (a) Except as provided in subsection (b), notice to any Member of any
- 3 matter relating to the business or affairs of the Limited Liability Company,
- 4 and the knowledge of the Member acting in the particular matter, acquired
- 5 while a Member or known at the time of becoming a Member, and the knowledge of
- 6 any other Member who reasonably could and should have communicated the
- 7 knowledge to the acting Member, operate as notice to or knowledge of the
- 8 Limited Liability Company, except in the case of a fraud on the Limited
- 9 Liability Company committed by or with the consent of that Member.
- 10 (b) If the Articles of Organization provide that management of the
- 11 Limited Liability Company is vested in a Manager or Managers:
- 12 (1) Notice to any Manager of any matter relating to the business
- or affairs of the Limited Liability Company, and the knowledge of
- 14 the Manager acting in the particular matter, acquired while a
- 15 Manager or known at the time of becoming a Manager, and the
- 16 knowledge of any other Manager who reasonably could and should
- 17 have communicated the knowledge to the acting Manager, operate as
- 18 notice to or knowledge of the Limited Liability Company, except in
- 19 the case of a fraud on the Limited Liability Company committed by
- or with the consent of that Manager; and
- 21 (2) Notice to or knowledge of any Member of a Limited Liability
- 22 Company while the Member is acting solely in the capacity of a
- 23 Member is not notice to or knowledge of the Limited Liability
- 24 Company.
- 25 §304. Liability of Members to Third Parties.
- 26 Except for the personal liability for acts or omissions of those
- 27 providing Professional Service as set forth in §308, a Person who is a Member,
- 28 Manager, agent or employee of a Limited Liability Company is not liable for a
- 29 debt, obligation or liability of the Limited Liability Company, whether
- 30 arising in contract, tort or otherwise or for the acts or omissions of any
- 31 other Member, Manager, agent or employee of the Limited Liability Company.
- 32 §305. Parties to Actions.
- 33 A Member of a Limited Liability Company is not a proper party to a
- 34 proceeding by or against a Limited Liability Company, by reason of being a
- 35 Member of the Limited Liability Company, except where the object of the

- 1 proceeding is to enforce a Member's right against or liability to the Limited
- 2 Liability Company or as otherwise provided in an Operating Agreement.
- 3 §306. Limited Liability Company May Render Professional Service;
- 4 Nonprofessional Employees and Agents; Members and Managers Need Not be
- 5 Employees, Etc.
- 6 No Limited Liability Company organized under this chapter may render
- 7 Professional Service within this State except through its Members, employees
- 8 of its Members, Managers, employees and agents who are duly licensed or
- 9 otherwise legally authorized to render those professional services. However,
- 10 this provision shall not be interpreted to preclude clerks, secretaries,
- 11 bookkeepers, technicians and other assistants who are not usually and
- 12 ordinarily considered by custom and practice to be rendering Professional
- 13 Service to the public for which a license or other legal authorization is
- 14 required from acting as employees, Managers or agents of a professional
- 15 limited liability company.
- 16 §307. Limited Liability Company May Qualify As Executor, Administrator
- 17 or in Other Fiduciary Capacity.
- 18 A Limited Liability Company engaged in the practice of law, as a part of
- 19 the practice of law, may act as an executor, trustee or administrator of an
- 20 estate, guardian for an infant, or in any other fiduciary capacity. Any
- 21 Member, employee of a Member, Manager, employee or agent of a Limited
- 22 Liability Company engaged in the practice of law who is duly licensed as an
- 23 attorney in this State may perform necessary fiduciary responsibilities on
- 24 behalf of the Limited Liability Company.
- 25 §308. Professional Relationship Personal Liability.
- 26 All individuals rendering Professional Service may be personally liable
- 27 for any results of that individual's acts or omissions. No Member, employee
- 28 of a Member, Manager, or employee of a Limited Liability Company shall be
- 29 personally liable for the acts or omission of any other Member, employee of a
- 30 Member, Manager, or employee of the Limited Liability Company.
- § 309. Liability of LIC to Third Parties.
- 32 Notwithstanding the limitations on liability contained herein for
- 33 Members and Managers, a Limited Liability Company shall be liable to third
- 34 parties for its valid obligations.
- § 310. Execution of Documents.

- 1 (a) Unless otherwise provided in any other section of this Act, any
- 2 document required by this Act to be filed with the Secretary of State shall be
- 3 executed:
- 4 (1) By any manager if management of the Limited Liability Company is
- 5 vested in one or more Managers;
- 6 (2) By any Member if management of the Limited Liability Company is
- 7 reserved to the Members;
- 8 (3) If the Limited Liability Company has not been formed, by the
- 9 Person or Persons forming the Limited Liability Company; or
- 10 (4) If the Limited Liability Company is in the hands of a
- 11 receiver, trustee, or other court-appointed fiduciary, by that
- 12 fiduciary.
- 13 (b) The Person executing the document shall sign it and state beneath
- 14 or opposite his signature the Person's name and the capacity in which he
- 15 signs.
- 16 (c) The Person executing the document may do so as an attorney-in-fact.
- 17 Powers of attorney relating to the execution of the document need not be
- 18 provided to or filed with the Secretary of State.
- 19 §311. Filing With The Secretary of State.
- 20 (a) The original signed copy, together with a duplicate copy that may
- 21 be either signed, photocopied, or conformed copy, of the Articles of
- 22 Organization or any other document required to be filed pursuant to this Act,
- 23 shall be delivered to the Secretary of State. If the Secretary of State
- 24 determines that the documents conform to the filing provisions of this Act, it
- 25 shall, when all required filing fees have been paid:
- 26 (1) Endorse on each signed original and duplicate copy the word
- 27 "filed" and the date and time of the document's acceptance for
- 28 filing;
- 29 (2) Retain the signed original in the Secretary of State's files;
- 30 and
- 31 (3) Return the duplicate copy to the Person who filed it or the
- 32 Person's representative.
- 33 (b) If at the time any documents are delivered for filing, the
- 34 Secretary of State is unable to make the determination required for filing by
- 35 subsection (a) the documents are deemed to have been filed at the time of

- 1 delivery if the Secretary of State subsequently determines that:
- 2 (1) The documents as delivered conform to the filing provisions
- 3 of this Act; or
- 4 (2) The documents have been brought into conformance within
- 5 twenty days after notification of nonconformance is given by the
- 6 Secretary of State to the Person who delivered the documents for
- filing or the Person's representative.
- 8 (c) If the filing and determination requirements of this Act are not
- 9 satisfied within the time prescribed in subsection (b)(2), the documents shall
- 10 not be filed.
- 11 ARTICLE 4: RIGHTS AND DUTIES OF MEMBERS AND MANAGERS.
- 12 §401. Management.
- 13 (a) Unless the Articles of Organization indicate that management of the
- 14 Limited Liability Company is vested in a Manager or Managers, or unless an
- 15 Operating Agreement vests management of the Limited Liability Company in a
- 16 Manager or Managers, management of the business or affairs of the Limited
- 17 Liability Company shall be vested in the Members. Subject to any provisions
- 18 in an Operating Agreement or this Act restricting or enlarging the management
- 19 rights and duties of any Person or group or class of Persons, the Members
- 20 shall have the right and authority to manage the affairs of the Limited
- 21 Liability Company and to make all decisions with respect thereto.
- 22 (b) If the Articles of Organization indicate that management of the
- 23 Limited Liability Company is vested in a Manager or Managers, or unless an

- 28 provided in an Operating Agreement, Managers:
- 29 (1) Shall be designated, appointed, elected, removed or replaced by a
- 30 vote, approval or consent of more than one-half by number of the Members;
- 31 (2) Need not be Members of the Limited Liability Company or
- 32 natural Persons; and
- 33 (3) Unless they are sooner removed or sooner resign, shall hold
- 34 office until their successors shall have been elected and
- 35 qualified.

- 1 §402. Duties of Managers and Members.
- 2 Unless otherwise provided in an Operating Agreement:
- 3 (a) A Member or Manager shall not be liable, responsible or accountable
- 4 in damages or otherwise to the Limited Liability Company or to the Members of
- 5 the Limited Liability Company for any action taken or failure to act on behalf
- 6 of the Limited Liability Company unless the act or omission constitutes gross
- 7 negligence or willful misconduct.
- 8 (b) Every Member and Manager must account to the Limited Liability
- 9 Company and hold as trustee for it any profit or benefit derived by that
- 10 Person without the consent of more than one-half by number of the
- 11 disinterested Managers or Members, or other Persons participating in the
- 12 management of the business or affairs of the Limited Liability Company, from
- 13 (1) any transaction connected with the conduct or winding up of the Limited
- 14 Liability Company; or (2) any use by the Member or Manager of its property,
- 15 including, but not limited to, confidential or proprietary information of the
- 16 Limited Liability Company or other matters entrusted to the Person as a result
- 17 of his status as Manager or Member.
- 18 (c) One who is a Member of a Limited Liability Company in which
- 19 management is vested in Managers under §401 and who is not a Manager shall
- 20 have no duties to the Limited Liability Company or to the other Members solely
- 21 by reason of acting in the capacity of a Member.
- 22 §403. Voting.
- 23 (a) Unless otherwise provided in an Operating Agreement or this Act,
- 24 and subject to subsection (b), the affirmative vote, approval or consent of
- 25 more than one-half by number of the Members, if management of the Limited
- 26 Liability Company is vested in the Members, or of the Managers if the
- 27 management of the Limited Liability Company is vested in Managers, shall be
- 28 required to decide any matter connected with the business of the Limited
- 29 Liability Company.
- 30 (b) Unless otherwise provided in writing in an Operating Agreement, the
- 31 affirmative vote, approval or consent of all Members shall be required to:
- 32 (1) Amend a written Operating Agreement; or
- 33 (2) Authorize a Manager or Member to do any act on behalf of the
- 34 Limited Liability Company that contravenes a written Operating
- 35 Agreement, including any written provision thereof which expressly

- 1 limits the purpose, business or affairs of the Limited Liability
- 2 Company or the conduct thereof.
- 3 §404. Limitation of Liability and Indemnification of Members and
- 4 Managers.
- 5 An Operating Agreement which is in writing may:
- 6 (a) Eliminate or limit the Personal liability of a Member or Manager
- 7 for monetary damages for breach of any duty provided for in §402; and
- 8 (b) Provide for indemnification of a Member or Manager for judgments,
- 9 settlements, penalties, fines, or expenses incurred in a proceeding to which a
- 10 Person is a party because the Person is or was a Member or Manager.
- 11 §405. Records and Information.
- 12 (a) Unless otherwise provided in writing in an Operating Agreement, a
- 13 Limited Liability Company shall keep at its principal place of business the
- 14 following:
- 15 (1) A current and a past list, setting forth the full name and
- last known mailing address of each Member and Manager, if any, set
- forth in alphabetical order;
- 18 (2) A copy of the Articles of Organization and all amendments
- 19 thereto, together with executed copies of any powers of attorney
- 20 pursuant to which the Articles of Amendment have been executed.
- 21 (3) Copies of the Limited Liability Company's federal, state and
- 22 local income tax returns and financial statements, if any, for the
- 23 three most recent years or, if those returns and statements were
- not prepared for any reason, copies of the information and
- 25 statements provided to, or which should have been provided to, the
- 26 Members to enable them to prepare their federal, state and local
- 27 tax returns for the period;
- 28 (4) Copies of any effective written Operating Agreements, and all
- 29 amendments thereto, and copies of any written Operating Agreements
- no longer in effect;
- 31 (5) Unless contained in writing in an Operating Agreement:
- 32 (i) A writing, if any, setting forth the amount of cash and a
- 33 statement of the agreed value of other property or services
- 34 contributed by each Member and the times at which or events
- upon the happening of which any additional contributions are

- to be made by each Member;
- 2 (ii) A writing, if any, stating events upon the happening of
- 3 which the Limited Liability Company is to be dissolved and
- 4 its affairs wound up; and
- 5 (iii) Other writings, if any, prepared pursuant to a requirement
- in an Operating Agreement.
- 7 (b) Upon reasonable request, a Member may, at the Member's own expense,
- 8 inspect and copy during ordinary business hours any Limited Liability Company
- 9 record, wherever the record is located.
- 10 (c) Members, if the management of the Limited Liability Company is
- 11 vested in the Members, or Managers, if management of the Limited Liability
- 12 Company is vested in Managers, shall render, to the extent the circumstances
- 13 render it just and reasonable, true and full information of all things
- 14 affecting the Members to any Member and to the legal representative of any
- 15 deceased Member or of any Member under legal disability.
- 16 (d) Failure of the Limited Liability Company to keep or maintain any of
- 17 the records or information required pursuant to this section shall not be
- 18 grounds for imposing liability on any Member or Manager for the debts and
- 19 obligations of the Limited Liability Company.
- 20 ARTICLE 5: FINANCE
- 21 §501. Contributions to Capital.
- 22 A Limited Liability Company interest may be issued in exchange for
- 23 property, services rendered, or a promissory note or other obligation to
- 24 contribute cash or property or to perform services.
- §502. Liability for Contributions.
- 26 (a) A promise by a Member to contribute to the Limited Liability
- 27 Company is not enforceable unless set forth in a writing signed by the Member.
- 28 (b) Unless otherwise provided in an Operating Agreement, a Member is
- 29 obligated to the Limited Liability Company to perform any enforceable promise
- 30 to contribute cash or property or to perform services, even if the Member is
- 31 unable to perform because of death, disability or other reason.
- 32 (c) If a Member does not make the required contribution of property or
- 33 services, the Member is obligated, at the option of the Limited Liability
- 34 Company, to contribute cash equal to that portion of value of the stated
- 35 contribution that has not been made.

- 1 (d) Unless otherwise provided in an Operating Agreement, the obligation
- 2 of a Member to make a contribution may be compromised only with the unanimous
- 3 consent of the Members.
- 4 (e) Only a creditor of a Limited Liability Company who extends credit
- 5 in reliance on an obligation to contribute, or otherwise acts in reliance on
- 6 that obligation to contribute after the Member signs a writing which reflects
- 7 the obligation to contribute pursuant to subsection (d) may enforce any
- 8 obligation to contribute.
- 9 §503. Sharing of Profits.
- 10 Unless otherwise provided in writing in an Operating Agreement, each
- 11 Member shall be repaid that Member's contributions to capital and share
- 12 equally in the profits and assets remaining after all liabilities, including
- 13 those to Members, are satisfied.
- 14 ARTICLE 6: DISTRIBUTIONS AND WITHDRAWAL
- 15 §601. Sharing of Interim Distributions.
- 16 Except as otherwise provided in §§602 and 905, distributions of cash or
- 17 other assets of a Limited Liability Company shall be shared among the Members
- 18 and among classes of Members in the manner provided in writing in an Operating
- 19 Agreement. If an Operating Agreement does not so provide in writing each
- 20 Member shall share equally in any distribution. A Member is entitled to
- 21 receive distributions described in this section from a Limited Liability
- 22 Company to the extent and at the times or upon the happening of the events
- 23 specified in an Operating Agreement or at the times determined by the Members
- 24 or Managers pursuant to §403.
- 25 §602. Distributions on an Event of Dissociation.
- 26 Upon the occurrence of an Event of Dissociation under §802 which does
- 27 not cause dissolution, other than an Event of Dissociation described in
- 28 §802(a)(3)(ii), a dissociating Member is entitled to receive any distribution
- 29 which the Member was entitled to receive prior to the Event of Dissociation.
- 30 If an Operating Agreement does not provide the amount of or a method for
- 31 determining the distribution to a dissociating Member, the Member shall
- 32 receive within a reasonable time after dissociation, the fair value of the
- 33 Member's interest in the Limited Liability Company as of the date of
- 34 dissociation based upon the Member's right to share in distributions from the
- 35 Limited Liability Company.

- 1 §603. Distribution in Kind.
- 2 Unless otherwise provided in an Operating Agreement:
- 3 (a) A Member, regardless of the nature of the Member's contribution,
- 4 has no right to demand and receive any Distribution from the Limited Liability
- 5 Company in any form other than cash; and
- 6 (b) A Member may not be compelled to accept from the Limited Liability
- 7 Company a distribution of any asset in kind to the extent that the percentage
- 8 of the asset distributed to the Member exceeds the percentage that the Member
- 9 would have shared in a cash distribution equal to the value of the property at
- 10 the time of distribution.
- 11 §604. Right to Distribution.
- 12 At the time a Member becomes entitled to receive a distribution, the
- 13 Member has the status of, and is entitled to all remedies available to, a
- 14 creditor of the Limited Liability Company
- 15 with respect to that distribution.
- 16 ARTICLE 7: OWNERSHIP AND TRANSFER OF PROPERTY
- 17 §701. Ownership of Limited Liability Company Property.
- 18 (a) Property transferred to or otherwise acquired by a Limited
- 19 Liability Company is property of the Limited Liability Company and not of the
- 20 Members individually.
- 21 (b) Property may be acquired, held and conveyed in the name of the
- 22 Limited Liability Company. Any interest in real property may be acquired in
- 23 the name of the Limited Liability Company and title to any interest so
- 24 acquired shall vest in the Limited Liability Company rather than in the
- 25 Members individually.
- 26 §702. Transfer of Real Property.
- 27 (a) If the Articles of Organization provide that management of the
- 28 Limited Liability Company is vested in a Manager or Managers:
- 29 (1) Title to property of the Limited Liability Company that is
- 30 held in the name of the Limited Liability Company may be transferred by an
- 31 instrument of transfer executed by any Manager in the name of the Limited
- 32 Liability Company; and
- 33 (2) A Member, solely by reason of being a Member, shall not have
- 34 authority to transfer property of the Limited Liability Company.
- 35 (b) If the Articles of Organization do not provide that management is

- 1 vested in a manager or managers then property of the Limited Liability Company
- 2 held in the name of the Limited Liability Company may be transferred by an
- 3 instrument of transfer executed by any Member in the name of the Limited
- 4 Liability Company.
- 5 (c) Property of the Limited Liability Company that is held in the name
- 6 of one or more Members or Managers with an indication in the instrument
- 7 transferring the property to them of their capacity as Members or Managers of
- 8 a Limited Liability Company or of the existence of a Limited Liability
- 9 Company, if the name of the Limited Liability Company is not indicated, may be
- 10 transferred by an instrument of transfer executed by the Persons in whose name
- 11 title is held.
- 12 (d) Property transferred under subsections (b) and (c) may be recovered
- 13 by the Limited Liability Company only if it proves that the person executing
- 14 the instrument had no authority to do so, and the initial transferee had
- 15 knowledge of the lack of authority unless the property has been transferred by
- 16 the initial transferee or a Person claiming through the initial transferee to
- 17 a subsequent transferee who gives value without having notice that the Person
- 18 who executed the instrument of initial transfer lacked authority to bind the
- 19 Limited Liability Company.
- 20 (e) Property of the Limited Liability Company held in the name of one
- 21 or more Persons other than the Limited Liability Company without an indication
- 22 in the instrument transferring title to the property to them of their capacity
- 23 as Members or Managers of a Limited Liability Company or of the existence of a
- 24 Limited Liability Company, may be transferred free of any claims of the
- 25 Limited Liability Company or the Members by the Persons in whose name title is
- 26 held to a transferee who gives value without having notice that it is property
- 27 of the Limited Liability Company.
- 28 §703. Nature of Limited Liability Company Interest.
- 29 A Limited Liability Company Interest is personal property.
- 30 §704. Assignment of Interest.
- 31 (a) Unless otherwise provided in writing in an Operating Agreement:
- 32 (1) A Limited Liability Company Interest is assignable in whole
- 33 or in part;
- 34 (2) An assignment entitles the assignee to receive, to the extent
- assigned, only the distributions to which the assignor would be

- 1 entitled;
- 2 (3) An assignment of a Limited Liability Company Interest does
- 3 not dissolve the Limited Liability Company or entitle the assignee
- 4 to participate in the management and affairs of the Limited
- 5 Liability Company or to become or exercise any rights of a Member;
- 6 (4) Until the assignee of a Limited Liability Company Interest
- 7 becomes a Member, the assignor continues to be a Member and to
- 8 have the power to exercise any rights of a Member, subject to the
- 9 Member's right to remove the assignor pursuant to §802(a)(3)(ii);
- 10 (5) Until an assignee of a Limited Liability Company Interest
- 11 becomes a Member, the assignee has no liability, if any, as a
- 12 Member solely as a result of the assignment; and
- 13 (6) The assignor of a Limited Liability Company Interest is not
- 14 released from his liability as a Member solely as a result of the
- 15 assignment.
- 16 (b) An Operating Agreement may provide that a Member's Limited
- 17 Liability Company Interest may be evidenced by a certificate of Limited
- 18 Liability Company Interest issued by the Limited Liability Company and may
- 19 also provide for the assignment or transfer of any interest represented by the
- 20 certificate.
- 21 §705. Rights of Judgment Creditor.
- 22 On application to a court of competent jurisdiction by any judgment
- 23 creditor of a Member, the court may charge the Member's Limited Liability
- 24 Company Interest with payment of the unsatisfied amount of judgment with
- 25 interest. To the extent so charged, the judgment creditor has only the rights
- 26 of an assignee of the Member's Limited Liability Company Interest. This Act
- 27 does not deprive any Member of the benefit of any exemption laws applicable to
- 28 his Limited Liability Company Interest.
- 29 §706. Right of Assignee to Become a Member.

- 9 (c) Whether or not an assignee of a Limited Liability Company Interest
- 10 becomes a Member, the assignor is not released from his liability, if any, to
- 11 the Limited Liability Company under §502.
- 12 (d) Unless otherwise provided in writing in an Operating Agreement, a
- 13 Member who assigns his entire Limited Liability Company Interest ceases to be
- 14 a Member or to have the power to exercise any rights of a Member when the
- 15 assignee becomes a Member with respect to the entire assigned interest.
- 16 §707. Powers of Estate of a Deceased or Incompetent Member.
- 17 If a Member who is an individual dies or a court of competent
- 18 jurisdiction adjudges the Member to be incompetent to manage his Person or
- 19 property, the Member's executor, administrator, guardian, conservator or other
- 20 legal representative shall have all of the rights of an assignee of the
- 21 Member's interest.
- 22 ARTICLE 8: ADMISSION AND WITHDRAWAL OF MEMBERS
- §801. Admission of Members.
- 24 (a) Subject to subsection (b), a Person may become a Member in a
- 25 Limited Liability Company:
- 26 (1) In the case of a Person acquiring a Limited Liability Company

- 32 Interest, as provided in §706.
- 33 (b) The effective time of admission of a Member to a Limited Liability
- 34 Company shall be the later of:
- 35 (1) The date the Limited Liability Company is formed; or

1 The time provided in an Operating Agreement or, if no such 2. time is provided therein, then when the Person's admission is 3 reflected in the records of the Limited Liability Company. §802. - 1 (b) The Members may provide in writing in an Operating Agreement for
- 2 other events the occurrence of which shall result in a Person ceasing to be a
- 3 Member of the Limited Liability Company.
- 4 (c) Unless an Operating Agreement provides in writing that a Member has
- 5 no power to withdraw by voluntary act from a Limited Liability Company, the
- 6 Member may do so at any time by giving 30 days' written notice to the other
- 7 Members, or such other notice as is provided for in an Operating Agreement.
- 8 If the Member has the power to withdraw but the withdrawal is a breach of an
- 9 Operating Agreement, or the withdrawal occurs as a result of otherwise
- 10 wrongful conduct of the Member, the Limited Liability Company may recover from
- 11 the withdrawing Member damages for breach of the Operating Agreement or as a
- 12 result of the wrongful conduct, including the reasonable costs of obtaining

- 25 in the Articles of Organization or an Operating Agreement;
- 26 (b) The written consent of all Members;
- 27 (c) An Event of Dissociation of a Member, unless (1) the business of
- 28 the Limited Liability Company is continued by the consent of all the remaining
- 29 Members on or before the 90th day following the occurrence of any such event
- 30 or (2) otherwise provided in writing in an Operating Agreement; or
- 31 (d) Entry of a decree of judicial dissolution under §902.
- 32 §902. Judicial Dissolution.
- On application by or for a Member, a Chancery Court may decree
- 34 dissolution of a Limited Liability Company whenever it is not reasonably
- 35 practicable to carry on the business of the Limited Liability Company in

- 1 conformity with the Operating Agreement.
- 2 §903. Winding Up.
- 3 Unless otherwise provided in writing in an Operating Agreement:
- 4 (a) The business or affairs of the Limited Liability Company may be
- 5 wound up:
- 6 (1) By the Members or Managers who have authority to manage the
- 7 Limited Liability Company prior to dissolution pursuant to §401;
- 8 or
- 9 (2) If one or more of such Members or Managers have engaged in
- 10 wrongful conduct, or upon other cause shown, by a Chancery Court
- 11 on application of any Member or any Member's legal representative
- or assignee.
- 13 (b) The Persons winding up the business or affairs of the Limited
- 14 Liability Company may, in the name of, and for and on behalf of, the Limited
- 15 Liability Company:
- 16 (1) Prosecute and defend suits;
- 17 (2) Settle and close the business of the Limited Liability
- 18 Company;
- 19 (3) Dispose of and transfer the property of the Limited Liability
- 20 Company;
- 21 (4) Discharge the liabilities of the Limited Liability Company;
- 22 and
- 23 (5) Distribute to the Member's any remaining assets of the
- 24 Limited Liability Company.
- 25 §904. Agency Power of Managers or Members After Dissolution.
- 26 (a) Except as provided in subsections (c), (d) and (e), after
- 27 dissolution of the Limited Liability Company, each of the Members having
- 28 authority to wind up the Limited Liability Company's business and affairs can
- 29 bind the Limited Liability Company:
- 30 (1) By any act appropriate for winding up the Limited Liability
- 31 Company's affairs or completing transactions unfinished at
- 32 dissolution; and
- 33 (2) By any transaction that would have bound the Limited
- 34 Liability Company if it had not been dissolved, if the other party
- to the transaction does not have notice of the dissolution.

- 1 (b) The filing of the Articles of Dissolution shall be presumed to
- 2 constitute notice of dissolution for purposes of subsection (a)(2).
- 3 (c) An act of a Member which is not binding on the Limited Liability
- 4 Company pursuant to subsection (a) is binding if it is otherwise authorized by
- 5 the Limited Liability Company.
- 6 (d) An act of a Member which would be binding under subsection (a) or
- 7 would be otherwise authorized but which is in contravention of a restriction
- 8 on authority shall not bind the Limited Liability Company to Persons having
- 9 knowledge of the restriction.
- 10 (e) If the Articles of Organization vest management of the Limited
- 11 Liability Company in Managers, a Manager shall have the authority of a Member
- 12 provided for in subsection (a), and no Member shall have such authority if the
- 13 Member is acting solely in the capacity of a Member.
- 14 §905. Distribution of Assets.
- 15 Upon the winding up of a Limited Liability Company, the assets shall be
- 16 distributed as follows:
- 17 (a) Payment, or adequate provision for payment, shall be made to
- 18 creditors, including, to the extent permitted by law, Members who are
- 19 creditors in satisfaction of liabilities of the Limited Liability Company;
- 20 (b) Unless otherwise provided in writing in an Operating Agreement, to
- 21 Members or former Members in satisfaction of liabilities for distributions
- 22 under §§601 and 602; and
- 23 (c) Unless otherwise provided in writing in an Operating Agreement, to
- 24 Members and former Members first for the return of their contribution and
- 25 second in proportion to the Members' respective rights to share in
- 26 distributions from the Limited Liability Company prior to dissolution.
- 27 §906. Articles of Dissolution.
- 28 After the dissolution of the Limited Liability Company pursuant to §901,
- 29 the Limited Liability Company may file Articles of Dissolution with the
- 30 Secretary of State which set forth:
- 31 (a) The name of the Limited Liability Company;
- 32 (b) The date of filing of its Articles of Organization and all
- 33 amendments thereto;
- 34 (c) The reason for filing the Articles of Dissolution;
- 35 (d) The effective date (which shall be a date certain) of the Articles

- 1 of Dissolution if they are not to be effective upon the filing; and
- 2 (e) Any other information the Members or Managers filing the
- 3 certificate shall deem proper.
- 4 §907. Known Claims Against Dissolved Limited Liability Company.
- 5 (a) Upon dissolution, a Limited Liability Company may dispose of the
- 6 known claims against it by filing Articles of Dissolution pursuant to §906 and
- 7 following the procedures described in this section.
- 8 (b) The Limited Liability Company shall notify its known claimants in
- 9 writing of the dissolution at any time after the effective date of
- 10 dissolution. The written notice must:
- 11 (1) Describe information that must be included in a claim;
- 12 (2) Provide a mailing address where a claim may be sent;
- 13 (3) State the deadline, which may not be fewer than 120 days
- 14 after the later of the date of the written notice or the filing of
- 15 Articles of Dissolution pursuant to §906, by which the Limited
- 16 Liability Company must receive the claim;
- 17 (4) State that the claim will be barred if not received by the
- 18 deadline; and
- 19 (5) Provided that any claim not responded to by the Limited Liability
- 20 Company within thirty (30) days after receipt shall be deemed to have been
- 21 rejected.
- 22 (c) A claim against the Limited Liability Company is barred:
- 23 (1) If a claimant who was given written notice under subsection
- 24 (b) does not deliver the claim to the Limited Liability Company by
- 25 the deadline;
- 26 (2) If a claimant whose claim was rejected by the Limited
- 27 Liability Company does not commence a proceeding to enforce the
- 28 claim within 90 days after the date of the rejection notice or
- 29 deemed rejection.
- 30 (d) For purposes of this section, "claim" does not include a contingent
- 31 liability or a claim based on an event occurring after the effective date of
- 32 dissolution.
- 33 §908. Unknown Claims Against Dissolved Limited Liability Company.
- 34 (a) A Limited Liability Company may publish notice of its dissolution
- 35 pursuant to this section which requests that Persons with claims against the

- 1 Limited Liability Company present them in accordance with the notice.
- 2 (b) The notice must:
- 3 (1) Be published once in a newspaper of general circulation in
- 4 the county where the Limited Liability Company's principal office
- 5 (or, if none in this state, its registered office) is located;
- 6 (2) Describe the information that must be included in a claim and
- 7 provide a mailing address where the claim may be sent; and
- 8 (3) State that a claim against the Limited Liability Company will
- 9 be barred unless a proceeding to enforce the claim is commenced
- 10 within the earlier of five years after the publication of the
- 11 notice, or the expiration of the applicable period of limitations
- 12 otherwise provided under law.
- 13 (c) If the Limited Liability Company publishes a newspaper notice in
- 14 accordance with subsection (b) and files Articles of Dissolution pursuant to
- 15 §906, the claim of each of the following claimants is barred unless the
- 16 claimant commences a proceeding to enforce the claim against the Limited
- 17 Liability Company within the earlier of the applicable period of limitations
- 18 otherwise provided under law or five years after the later of the publication
- 19 date of the newspaper notice or the filing of the Articles of Dissolution:
- 20 (1) A claimant who did not receive written notice under §907; or
- 21 (2) A claimant whose claim is contingent or based on an event
- occurring after the effective date of dissolution.
- 23 (d) A claim may be enforced under this section:
- 24 (1) Against the Limited Liability Company, to the extent of its
- 25 undistributed assets; or
- 26 (2) If the assets have been distributed in liquidation, against a
- 27 Member of the Limited Liability Company to the extent of his pro
- 28 rata share of the claim or the assets of the Limited Liability
- 29 Company distributed to him in liquidation, whichever is less, but
- 30 a Member's total liability for all claims under this section may
- 31 not exceed the total amount of assets distributed to him in
- 32 liquidation.
- 33 ARTICLE 10: FOREIGN LIMITED LIABILITY COMPANIES
- 34 §1001. Law Governing.
- 35 Subject to the Constitution of this State, the laws of the State of

- 1 other jurisdiction under which a Foreign Limited Liability Company is
- 2 organized shall govern its organization and internal affairs and the liability
- 3 and authority of its Managers and Members. A Foreign Limited Liability
- 4 Company may not be denied registration by reason of any difference between
- 5 those laws and the laws of this State.
- 6 §1002. Registration.
- Before transacting business in this State, a Foreign Limited Liability
- 8 Company shall register with the Secretary of State by submitting to the
- 9 Secretary of State an original signed copy of an Application for Registration
- 10 as a Foreign Limited Liability Company, together with a duplicate copy that
- 11 may be either a signed, photocopied, or conformed copy, executed by a Person
- 12 with authority to do so under the laws of the state or other jurisdiction of
- 13 its formation. The Application shall set forth:
- 14 (a) The name of the Foreign Limited Liability Company and, if
- 15 different, the name under which it proposes to transact business in this
- 16 State;
- 17 (b) The state or other jurisdiction where formed, and date of its
- 18 formation;
- 19 (c) The name and address of a registered agent for service of process
- 20 required to be maintained by §105;
- 21 (d) A statement that the Secretary of State is appointed the agent of
- 22 the Foreign Limited Liability Company for service of process if the Foreign
- 23 Limited Liability Company fails to appoint or maintain a registered agent in
- 24 satisfaction of the requirements of §105;
- 25 (e) The address of the office required to be maintained in the state or
- 26 other jurisdiction of its formation by the laws of that state or jurisdiction
- 27 or, if not so required, of the principal office of the Foreign Limited
- 28 Liability Company; and
- 29 (f) A statement evidencing that the Foreign Limited Liability Company
- 30 is a "Foreign Limited Liability Company" as defined in §101(f).
- 31 §1003. Issuance of Registration.
- 32 (a) If the Secretary of State finds that an Application for
- 33 Registration conforms to the provisions of this article and all requisite fees
- 34 have been paid, the Secretary shall:
- 35 (1) Endorse on each signed original and duplicate copy the word

- 1 "filed" and the date and time of its acceptance for filing;
- 2 (2) Retain the signed original in the Secretary of State's files;
- 3 and
- 4 (3) Return the duplicate copy to the Person who filed it or the
- 5 Person's representative.
- 6 (b) If the Secretary of State is unable to make the determination
- 7 required for filing by subsection (a) at the time any documents are delivered
- 8 for filing, the documents are deemed to have been filed at the time of
- 9 delivery if the Secretary of State subsequently determines that:
- 10 (1) The documents as delivered conform to the filing provisions
- of this Act; or
- 12 (2) Within twenty days after notification of nonconformance is
- 13 given by the Secretary of State to the Person who delivered the
- 14 documents for filing or the Person's representative, the documents
- 15 are brought into conformance.
- 16 (c) If the filing and determination requirements of this Act are not
- 17 satisfied within the time prescribed in subsection (b)(2), the documents shall
- 18 not be filed.
- 19 §1004. Name.
- 20 No Certificate of Registration shall be issued to a Foreign Limited
- 21 Liability Company unless the name of such company satisfies the requirements
- 22 of §103. If the name under which a Foreign Limited Liability Company is
- 23 registered in the jurisdiction of its formation does not satisfy the
- 24 requirements of §103, to obtain or maintain a Certificate of Registration the
- 25 Foreign Limited Liability Company may use a designated name that is available,
- 26 and which satisfies the requirements of §103.
- 27 §1005. Amendments.
- 28 (a) The Application for Registration of a Foreign Limited Liability
- 29 Company is amended by filing Articles of Amendment with the Secretary of State
- 30 signed by a Person with authority to do so under the laws of the state or
- 31 other jurisdiction of its formation. The Articles of Amendment shall set
- 32 forth:
- 33 (1) The name of the Foreign Limited Liability Company;
- 34 (2) The date the original Application for Registration was filed;
- 35 and

- 1 (3) The amendment to the Application for Registration.
- 2 (b) The Application for Registration may be amended in any way,
- 3 provided that the Application for Registration as amended contains only
- 4 provisions that may be lawfully contained in an Application for Registration
- 5 at the time of the amendment.
- 6 §1006. Cancellation of Registration.
- 7 (a) A Foreign Limited Liability Company authorized to transact business
- 8 in this State may cancel its registration upon procuring from the Secretary of
- 9 State a Certificate of Cancellation. In order to procure such certificate,
- 10 the Foreign Limited Liability Company shall deliver to the Secretary of State
- 11 an Application for Cancellation, which shall set forth:
- 12 (1) The name of the Foreign Limited Liability Company and the
- state or other jurisdiction under the laws of which it is formed;
- 14 (2) That the Foreign Limited Liability Company is not transacting
- business in this State;
- 16 (3) That the Foreign Limited Liability Company surrenders its
- 17 Certificate of Registration to transact business in this State;
- 18 (4) That the Foreign Limited Liability Company revokes the
- 19 authority of its registered agent for service of process in this
- 20 State and consents that service of process in any action, suit, or
- 21 proceeding based upon any cause of action arising in this State
- 22 during the time the Foreign Limited Liability Company was
- authorized to transact business in this State may thereafter be
- 24 made on such Foreign Limited Liability Company by service thereof
- upon the Secretary of State; and
- 26 (5) An address to which a Person may mail a copy of any process
- 27 against the Foreign Limited Liability Company.
- 28 (b) The Application for Cancellation shall be in the form and manner
- 29 designated by the Secretary of State and shall be executed on behalf of the
- 30 Foreign Limited Liability Company by a Person with authority to do so under
- 31 the laws of the state or other jurisdiction of its formation, or, if the
- 32 Foreign Limited Liability Company is in the hands of a receiver, trustee, or
- 33 other court-appointed fiduciary, by that fiduciary.
- 34 (c) A cancellation does not terminate the authority of the Secretary of
- 35 State to accept service of process on the Foreign Limited Liability Company

- 1 with respect to causes of action arising out of the doing of business in this 2 State.
- 3 §1007. Transaction of Business Without Registration.
- 4 (a) A Foreign Limited Liability Company transacting business in this
- 5 State may not maintain an action, suit, or proceeding in a court of this State
- 6 until it has registered in this State.
- 7 (b) The failure of a Foreign Limited Liability Company to register in
- 8 this State does not:
- 9 (1) Impair the validity of any contract or act of the Foreign
- 10 Limited Liability Company;
- 11 (2) Affect the right of any other party to the contract to
- maintain any action, suit or proceeding on the contract; or
- 13 (3) Prevent the Foreign Limited Liability Company from defending
- 14 any action, suit, or proceeding in any court of this State.
- 15 (c) A Foreign Limited Liability Company, by transacting business in
- 16 this State without registration, appoints the Secretary of State as its agent
- 17 for service of process with respect to a cause of action arising out of the
- 18 transaction of business in this State.
- 19 (d) A Foreign Limited Liability Company which transacts business in
- 20 this State without registration shall be liable to the State for the years or
- 21 parts thereof during which it transacted business in this State without
- 22 registration in an amount equal to all fees which would have been imposed by
- 23 this Act upon that Foreign Limited Liability Company had it duly registered,
- 24 and all penalties imposed by this Act. The Attorney General may bring
- 25 proceedings to recover all amounts due this state under the provisions of this
- 26 section.
- 27 (e) A Foreign Limited Liability Company which transacts business in
- 28 this State without registration shall be subject to a civil penalty, payable
- 29 to the State, not to exceed \$5,000.00 for each twelve (12) month period or
- 30 part thereof, beginning with the date it began transacting business in this
- 31 State and ending on the date it becomes registered.
- 32 (f) The civil penalty set forth in subsection (e) may be recovered in
- 33 an action brought within a court by the Attorney General. Upon a finding by
- 34 the court that a Foreign Limited Liability Company has transacted business in
- 35 this State in violation of this Act, the court shall issue, in addition to the

- 1 imposition of a civil penalty, an injunction restraining further transactions
- 2 of the business of the Foreign Limited Liability Company and the further
- 3 exercise of any Limited Liability Company's rights and privileges in this
- 4 State. The Foreign Limited Liability Company shall be enjoined from
- 5 transacting business in this State until all civil penalties plus any interest
- 6 and court costs which the court may assess have been paid and until the
- 7 Foreign Limited Liability Company has otherwise complied with the provisions
- 8 of this article.
- 9 (g) A Member or Manager of a Foreign Limited Liability Company is not
- 10 liable for the debts and obligations of the Limited Liability Company solely
- 11 because the Limited Liability Company transacted business of this State
- 12 without registration.
- 13 §1008. Transactions Not Constituting Transacting Business.
- 14 (a) The following activities of a Foreign Limited Liability Company,
- 15 among others, do not constitute transacting business within the meaning of
- 16 this article:
- 17 (1) Maintaining, defending, or settling any proceeding;
- 18 (2) Holding meetings of its Members or Managers or carrying on
- any other activities concerning its internal affairs;
- 20 (3) Maintaining bank accounts;
- 21 (4) Maintaining offices or agencies for the transfer, exchange
- 22 and registration of the Foreign Limited Liability Company's own
- 23 securities or interests or maintaining trustees or depositories
- 24 with respect to those securities or interests;
- 25 (5) Selling through independent contractors;
- 26 (6) Soliciting or obtaining orders, whether by mail or through
- 27 employees or agents or otherwise, if the orders require acceptance
- outside this State before they become contracts;
- 29 (7) Creating or acquiring indebtedness, mortgages, and security
- interests in real or personal property;
- 31 (8) Securing or collecting debts or enforcing mortgages and
- 32 security interests in property securing debts;
- 33 (9) Owning, without more, real or personal property;
- 34 (10) Conducting an isolated transaction that is completed within
- 35 thirty (30) days and that is not one in the course of repeated

- transactions of a like nature; or
- 2 (11) Transacting business in interstate commerce.
- 3 (b) The Foreign Limited Liability Company shall not be considered to be
- 4 transacting business solely because it:
- 5 (1) Owns a controlling interest in a corporation that is
- 6 transacting business;
- 7 (2) Is a limited party of a limited partnership that is
- 8 transacting business; or
- 9 (3) Is a Member or Manager of a Limited Liability Company or
- 10 Foreign Limited Liability Company that is transacting business.
- 11 (c) This section does not apply in determining the contacts or
- 12 activities that may subject a Foreign Limited Liability Company to service of
- 13 process or taxation in this State or to other law, or to regulation under any
- 14 other law of this State.
- 15 ARTICLE 11: SUITS BY AND AGAINST THE LIMITED LIABILITY COMPANY
- 16 §1101. Suits By and Against the Limited Liability Company.
- Suit may be brought by or against a Limited Liability Company in its own
- 18 name.
- 19 §1102. Authority to Sue on Behalf of Limited Liability Company.
- 20 Unless otherwise provided in an Operating Agreement, a suit on behalf of
- 21 the Limited Liability Company may be brought only in the name of the Limited
- 22 Liability Company by:
- 23 (a) One or more Members of a Limited Liability Company, whether or not
- 24 an Operating Agreement vests management of the Limited Liability Company in
- 25 one or more Managers, who are authorized to sue by the vote of more than one
- 26 half by number of the Members eligible to vote thereon, unless the vote of all
- 27 Members shall be required pursuant to §403(b), provided that in determining
- 28 the vote required under §403, the vote of any Member who has an interest in
- 29 the outcome of the suit that is adverse to the interest of the Limited
- 30 Liability Company shall be excluded; or
- 31 (b) One or more Managers of a Limited Liability Company, if an
- 32 Operating Agreement vests management of the Limited Liability Company in one
- 33 or more Managers, who are authorized to do so by the vote required pursuant to
- 34 §403 of the Members eligible to vote thereon, provided that in determining
- 35 such required vote, the vote of any Manager who has an interest in the outcome

- 1 of the suit that is adverse to the interest of the Limited Liability Company
- 2 shall be excluded.
- 3 §1103. Effect of Lack of Authority to Sue.
- 4 The lack of authority of a Member or Manager to sue on behalf of the
- 5 Limited Liability Company may not be asserted as a defense to an action by the
- 6 Limited Liability Company or by the Limited Liability Company as a basis for
- 7 bringing a subsequent suit on the same cause of action.
- 8 ARTICLE 12: MERGER AND CONSOLIDATION
- 9 §1201. Merger or Consolidation.
- 10 (a) Unless otherwise provided in writing in an Operating Agreement, and
- 11 subject to any law applicable to business entities other than Limited
- 12 Liability Companies, one or more Limited Liability Companies may merge or
- 13 consolidate with or into one or more other business entities with the Limited
- 14 Liability Company or other business entity as the merger or consolidation
- 15 agreement shall provide being the surviving or resulting Limited Liability
- 16 Company or other business entity.
- 17 (b) Rights or securities of or interests in a business entity that is a
- 18 party to the merger or consolidation may be exchanged for or converted into
- 19 cash, property, obligations, rights or securities of or interests in the
- 20 surviving or resulting business entity or of any other business entity;
- 21 (c) As used in this Article 12, "business entity" or "business
- 22 entities" shall mean Domestic and Foreign Limited Liability Companies and
- 23 Corporations.
- 24 §1202. Approval of Merger or Consolidation.
- 25 (a) Unless otherwise provided in writing in an Operating Agreement, a
- 26 Limited Liability Company that is a party to a proposed merger or
- 27 consolidation shall approve the merger or consolidation agreement by the
- 28 consent of more than one-half by number of the Members.
- 29 (b) Each corporation and Foreign Limited Liability Company that is a
- 30 party to a proposed merger or consolidation shall approve the merger or
- 31 consolidation in the manner and by the vote required by the laws applicable to
- 32 such business entity.
- 33 (c) Each business entity that is a party to the merger or consolidation
- 34 shall have such rights to abandon the merger as are provided for in the merger
- 35 or consolidation agreement or in the laws applicable to the business entity.

- 1 §1203. Articles of Merger of Consolidation.
- 2 (a) The business entity surviving or resulting from the merger or
- 3 consolidation shall deliver to the Secretary of State Articles of Merger or
- 4 Consolidation executed by each constituent entity setting forth:
- 5 (1) The name and jurisdiction of formation or organization of
- 6 each business entity which is to merge or consolidate;
- 7 (2) That an Agreement of Merger or Consolidation has been
- 8 approved and executed by each business entity which is a party to
- 9 the merger or consolidation;
- 10 (3) The name of the surviving or resulting business entity;
- 11 (4) The future effective date of the merger or consolidation
- 12 (which shall be a date or time certain) if it is not to be
- 13 effective upon the filing of the Articles of Merger or
- 14 Consolidation;
- 15 (5) That the Agreement of Merger or Consolidation is on file at a
- 16 place of business of the surviving or resulting business entity,
- and the address of that place of business;
- 18 (6) That a copy of the Agreement of Merger or Consolidation will
- 19 be furnished by the surviving or resulting business entity, on
- 20 request and without cost, to any Person holding an interest in any
- 21 business entity which is to merge or consolidate; and
- 22 (7) If the surviving or resulting entity is not a business entity
- 23 organized under the laws of this State, a statement that such
- 24 surviving or resulting business entity:
- 25 (i) Agrees that it may be served with process in this State in
- any proceeding for enforcement of any obligation of any
- 27 business entity party to the merger or consolidation that
- 28 was organized under the laws of this State, as well as for
- 29 enforcement of any obligation of the surviving business
- 30 entity or the new business entity arising from the merger or
- 31 consolidation; and
- 32 (ii) Appoints the Secretary of State as its agent for service of
- process in any such proceeding, and the surviving business
- 34 entity or the new business entity shall specify the address
- 35 to which a copy of the process shall be mailed to it by the

- 1 Secretary of State.
- 2 (b) A merger or consolidation takes effect upon the later of the
- 3 effective date of the filing of the Articles of Merger or Consolidation or the
- 4 date set forth in the Articles of Merger or Consolidation.
- 5 (c) The Articles of Merger or Consolidation shall be executed by a
- 6 Limited Liability Company that is a party to the merger or consolidation in
- 7 the manner provided for in §204, and shall be filed with the Secretary of
- 8 State in the manner provided for in §205.
- 9 (d) Articles of Merger or Consolidation shall constitute Articles of
- 10 Dissolution for a Limited Liability Company which is not the surviving or
- 11 resulting business entity in the merger or consolidation.
- 12 (e) An Agreement of Merger or Consolidation approved in accordance with
- 13 §1202 may effect any amendment to an Operating Agreement or effect the
- 14 adoption of a new Operating Agreement for a Limited Liability Company if it is
- 15 the surviving or resulting Limited Liability Company in the merger or
- 16 consolidation. An approved Agreement of Merger or Consolidation may also
- 17 provide that the Operating Agreement of any constituent Limited Liability
- 18 Company to the merger or consolidation (including a Limited Liability Company
- 19 formed for the purpose of consummating a merger or consolidation) shall be the
- 20 Operating Agreement of the surviving or resulting Limited Liability Company,
- 21 any amendment to an Operating Agreement or adoption of a new Operating
- 22 Agreement made pursuant to this subsection (e) shall be effective at the
- 23 effective time or date of the merger or consolidation. The provisions of this
- 24 subsection shall not be construed to limit the accomplishment of a merger or
- 25 of any of the matters referred to herein by any other means provided for in an
- 26 Operating Agreement or other agreement or as otherwise permitted by law.
- 27 §1204. Effects of Merger or Consolidation.
- 28 A merger or consolidation has the following effects:
- 29 (a) The business entities that are parties to the Merger or
- 30 Consolidation Agreement shall be a single entity, which, in the case of a
- 31 merger shall be the entity designated in the Plan of Merger as the surviving
- 32 entity, and, in the case of a consolidation, shall be the new entity provided
- 33 for in the Plan of Consolidation;
- 34 (b) Each party to the merger or consolidation agreement, except the
- 35 surviving entity or the new entity, shall cease to exist;

- 1 (c) The surviving entity or the new entity shall thereupon and
- 2 thereafter possess all the rights, privileges, immunities, and powers of each
- 3 constituent entity and shall be subject to all the restrictions, disabilities,
- 4 and duties of each of such constituent entities to the extent such rights,
- 5 privileges, immunities, powers, franchises, restrictions, disabilities, and
- 6 duties are applicable to the type of business entity that is the surviving
- 7 entity or the new entity;
- 8 (d) All property, real, personal and mixed, and all debts due on
- 9 whatever account, including promises to make capital contributions and
- 10 subscriptions for shares, and all other choses in action, and all and every
- 11 other interest of or belonging to or due to each of the constituent entities
- 12 shall be vested in the surviving entity or the new entity without further act
- 13 or deed;
- 14 (e) The title to all real estate and any interest therein, vested in
- 15 any such constituent entity shall not revert or be in any way impaired by
- 16 reason of such merger or consolidation;
- 17 (f) The surviving entity or the new entity shall thenceforth be liable
- 18 for all liabilities and obligations of each of the constituent entities so
- 19 merged or consolidated, and any claim existing or action or proceeding pending
- 20 by or against any such constituent entity may be prosecuted as if such merger
- 21 or consolidation had not taken place, or the surviving entity or the new
- 22 entity may be substituted in the action;
- 23 (g) Neither the rights of creditors nor any liens on the property of
- 24 any constituent entity shall be impaired by the merger or consolidation;
- 25 (h) The interests in a Limited Liability Company or shares or other
- 26 interests in a corporation that are to be converted or exchanged into
- 27 interests, shares or other securities, cash, obligations or other property
- 28 under the terms of the Merger or Consolidation Agreement are so converted, and
- 29 the former holders thereof are entitled only to the rights provided in the
- 30 Merger or Consolidation Agreement or the rights otherwise provided by law.
- 31 ARTICLE 13: MISCELLANEOUS
- 32 §1301. Filing Requirements.
- 33 (a) A document must satisfy the requirements of this section, and of

- (1) The original signed copy, together with a duplicate copy that may either be a signed, photocopied or conformed copy, of any document required to be filed pursuant to this Act, shall be delivered to the Secretary of State. When the Secretary of State determines that the documents conform to the filing provisions of this Act, it shall, when all required filing fees, tax, license fee, or penalty required by this chapter or other law has been paid;
 - (i) Endorsed on each signed original and duplicate copy the word "filed" and the date and time of the documents acceptance for filing;

19	(a) A Domestic or Foreign Limited Liability Company may correct a

24	(b) A document is corrected:
25	(1) By preparing articles of correction that:

28	(ii) Specify the incorrect statement and the reason it is
29	incorrect or the manner in which the execution was defective; and
30	(iii) Correct the incorrect statement or defective execution; and
31	(2) By delivering the articles to the Secretary of State for filing.
32	(c) Articles of correction are effective on the effective date of the
33	document they correct except as to persons relying on the uncorrected document
34	and adversely affected by the correction. As to those persons, articles of
35	correction are effective when filed.

- 1 §1304. Appeal from Secretary of State's refusal to file document.
- 2 (a) If the Secretary of State refused to file a document delivered to
- 3 this office for filing, the Domestic or Foreign Limited Liability Company may
- 4 appeal the refusal within thirty (30) days after the return of the document to
- 5 the Pulaski County Circuit Court. The appeal is commenced by petitioning the
- 6 court to compel filing the document and by attaching to the petition the
- 7 document and the Secretary of State's explanation of his refusal to file.
- 8 (b) The court may summarily order the Secretary of State to file the
- 9 document or take other action the court considers appropriate.
- 10 (c) The court's final decision may be appealed as in other civil
- 11 proceedings.
- 12 §1305. Evidentiary Effect of Copy of Filed Document.
- 13 A certificate attached to a copy of a document filed by the Secretary of
- 14 State, bearing his signature (which may be in facsimile) and the seal of this
- 15 state, is conclusive evidence that the original document is on file with the
- 16 Secretary of State.
- 17 §1306. Certificate of Existence.
- 18 (a) Anyone may apply to the Secretary of State to furnish a
- 19 certificate of existence for a domestic Limited Liability Company or a
- 20 certificate of authorization for a foreign Limited Liability Company.
- 21 (b) A certificate of existence or authorization sets forth:
- 22 (1) The domestic Limited Liability Company name or the foreign Limited
- 23 Liability Company's corporate name used in this state;
- 24 (2) That:
- 25 (i) The domestic Limited Liability Company is duly formed under
- 26 the laws of this state, the date of its formation, and the period
- of its duration; or

- 9 §1307. Penalty for Signing False Documents.
- 10 (a) A person commits an offense if he signs a document he knows is
- 11 false in any material respect with intent that the document be delivered to
- 12 the Secretary of State for filing.
- 13 (b) An offense under this section is a Class C misdemeanor.
- 14 §1308. Powers of Secretary of State.
- 15 The Secretary of State has the power reasonably necessary to perform the
- 16 duties required of him by this chapter.
- 17 §1309. Definition of Knowledge.
- 18 A Person has "knowledge" of a fact within the meaning of this Act not
- 19 only when he has actual knowledge thereof, but also when he has knowledge of
- 20 such other facts as in the circumstances shows bad faith.
- 21 §1310. Rules of Construction.
- 22 (a) It is the policy of this Act to give maximum effect to the
- 23 principle of freedom of contract and to the enforceability of Operating
- 24 Agreements.
- 25 (b) Unless displaced by particular provisions of this Act, the
- 26 principles of law and equity supplement this Act.
- 27 (c) Rules that statutes in derogation of the common law are to be
- 28 strictly construed shall have no application to this Act.
- 29 (d) Neither this Act nor any amendment of this Act shall be construed
- 30 so as to impair the obligations of any contract existing when the Act or
- 31 amendment goes into effect, nor to affect any action or proceedings begun or
- 32 right accrued before the Act or amendment takes effect.
- §1311. Severability. If any provision of this Act or its application
- 34 to any Person or circumstance is held invalid, the invalidity does not affect
- 35 other provisions or applications of this Act which can be given effect without

- 1 the invalid provision or application. To this end, the provisions of this Act 2 are severable.
- 3 §1312. Interstate Application.
- 4 A Limited Liability Company organized and existing under this Act may
- 5 conduct its business, carry on its operations and have and exercise the powers
- 6 granted by this Act in any state or foreign country.
- 7 §1313. Tax Status.
- 8 Every Limited Liability Company having two or more Members shall make a
- 9 return for each taxable year as required for every partnership pursuant to ACA
- 10 § 26-51-802. The income and expenses of every Limited Liability Company
- 11 having only one Member shall be reported on the Member's income tax return.
- 12 §1314. Governing Law.
- 13 (a) The liability of Members, Managers, employees and agents of a
- 14 Limited Liability Company organized and existing under this Act shall at all
- 15 times be determined solely and exclusively by this Act and the laws of this
- 16 State.
- 17 (b) If a conflict arises between the law of this State and the laws of
- 18 any other jurisdiction with regard to the liability of a Member, Manager,
- 19 employee or agent of a Limited Liability Company organized and existing under
- 20 this Act for the debts, obligations and liabilities of the Limited Liability
- 21 Company, or for the acts or omissions of another Member, Manager, employee, or
- 22 agent of the Limited Liability Company, this Act and the laws of this State
- 23 shall govern in determining such liability.
- 24 §1315. Full Faith and Credit.
- 25 It is the intent of the legislature that the legal existence of Limited
- 26 Liability Companies organized under this Act be recognized outside the
- 27 boundaries of this State and that, subject to any reasonable requirement of
- 28 registration, a domestic Limited Liability Company transacting business
- 29 outside this State be granted full faith and credit under Section 1 of Article
- 30 IV of the Constitution of the United States.

- 32 §1316. REPEALER
- 33 All laws and parts of laws in conflict with the provisions of this Act
- 34 are hereby repealed. Furthermore, the laws of this State relating to the
- 35 establishment and regulation of Professional Service are hereby amended and

1 superseded to the extent such laws are inconsistent as to form of organization 2 with the provisions of this Act, and are deemed amended to permit the 3 provisions of Professional Service within this State by Limited Liability 4 Companies. By way of example and not by way of limitation of the foregoing, 5 Arkansas Code Annotated §17-12-702 presently applies to persons, partnerships, 6 and corporations and shall hereafter be deemed to apply to persons, 7 partnerships, corporations, and limited liability companies. a 9 §1317. All provisions of this act of a general and permanent nature are 10 amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code 11 Revision Commission shall incorporate the same in the Code. 12 §1318. EMERGENCY CLAUSE 13 It is hereby found and determined by the Seventy-Ninth General Assembly 15 that there is a public need for adoption of this Act, and that the immediate 16 passage of this Act is necessary.
