For An Act To Be Entitled

8 "AN ACT TO SET ASIDE EACH FISCAL YEAR *TEN PERCENT (10%)* OR
9 TWO AND ONE HALF MILLION DOLLARS (\$2,500,000), WHICHEVER
10 IS GREATER, OF THE COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS
11 AVAILABLE TO THE ARKANSAS INDUSTRIAL DEVELOPMENT
12 COMMISSION FOR SENIOR CITIZEN CENTERS; AND FOR OTHER
13 PURPOSES."

Subtitle

16 "TO SET ASIDE EACH FISCAL YEAR *10%* OR \$2,500,000 OF THE
17 COMMUNITY DEVELOPMENT BLOCK GRANT FUND FOR SENIOR CITIZEN
18 CENTERS."

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21

22 SECTION 1. *Ten percent (10%)* or two and one half million dollars
23 (\$2,500,000), whichever is greater, of the federal funds received by the
24 Arkansas Industrial Development Commission for Community Development Block
25 Grants shall each fiscal year be awarded to local entities of government who
26 apply for grants for the purpose of constructing, renovating, expanding and
27 equipping Senior Citizen Centers in Arkansas Communities. All incorporated
28 cities and county governments, including the nine (9) entitlement cities
29 shall be eligible to participate in applying for and receiving grants for this
30 purpose.

31

32 SECTION 2. Upon certification to the Chief Fiscal Officer of the State
33 from the Arkansas Industrial Development Commission that the funds referred to
34 in Section 1 have been received, the Chief Fiscal Officer of the State shall
35 each fiscal year transfer on his books and those of the State Treasurer, the

1 amount of appropriations and funds so certified to the Department of Human
2 Services, Division of Aging and Adult Services and shall be used solely for
3 the purpose of awarding grants for the constructing, renovating, expanding,
4 and equipping Senior Citizen Centers.

5

6 SECTION 3. All provisions of this act of a general and permanent nature
7 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
8 Revision Commission shall incorporate the same in the Code.

9

10 SECTION 4. If any provision of this act or the application thereof to
11 any person or circumstance is held invalid, such invalidity shall not affect
12 other provisions or applications of the act which can be given effect without
13 the invalid provision or application, and to this end the provisions of this
14 act are declared to be severable.

15

16 SECTION 5. All laws and parts of laws in conflict with this act are
17 hereby repealed.
