# A Bill

**HOUSE BILL 1478**

## **For An Act To Be Entitled**

8 "AN ACT TO AUTHORIZE THE ADJUTANT GENERAL TO DEVELOP AND  
9 IMPLEMENT CIVILIAN JUVENILE STUDENT TRAINING PROGRAMS; AND  
10 FOR OTHER PURPOSES."

## **Subtitle**

13 "AN ACT TO AUTHORIZE THE ADJUTANT GENERAL TO DEVELOP AND  
14 IMPLEMENT CIVILIAN JUVENILE STUDENT TRAINING PROGRAMS."

16 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

18 SECTION 1. (a) The Adjutant General may, at his discretion and with  
19 such funds as may be appropriated by the General Assembly, or with such funds  
20 as may be provided by the United States, develop and implement civilian  
21 juvenile student training programs, for the purpose of providing training,  
22 education, health, welfare, rehabilitative and other services to juveniles.

23 (b) The Adjutant General is authorized to enter into agreements,  
24 contracts, and memorandums of understanding with other state, federal and  
25 local agencies, other persons, firms and corporations, and the juvenile courts  
26 of this state for purposes of providing training, education, health, welfare,  
27 rehabilitative and other services to juveniles participating in such programs  
28 as may be implemented by the Adjutant General.

29 (c) The Adjutant General may promulgate and issue such rules,  
30 regulations, and other guidelines as may be necessary and proper to carry out  
31 the purposes and provisions of this act.

32  
33 SECTION 2. All provisions of this act of a general and permanent nature  
34 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
35 Revision Commission shall incorporate the same in the Code.

SECTION 4. All laws and parts of laws in conflict with this act are hereby repealed.
