HOUSE BILL 1632

For An Act To Be Entitled

8 "AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES AND
9 OPERATING EXPENSES FOR THE DEPARTMENT OF FINANCE AND
10 ADMINISTRATION - REVENUE SERVICES DIVISION WHICH SHALL BE
11 SUPPLEMENTAL AND IN ADDITION TO THOSE FUNDS APPROPRIATED
12 BY ACT 1121 OF 1991 AND ACT 17 OF THE FIRST EXTRAORDINARY
13 SESSION OF 1992, FOR THE REMAINDER OF THE BIENNIAL PERIOD
14 ENDING JUNE 30, 1993; AND FOR OTHER PURPOSES."

Subtitle

17 "AN ACT FOR THE DEPARTMENT OF FINANCE AND ADMINISTRATION -
18 REVENUE SERVICES DIVISION SUPPLEMENTAL APPROPRIATION."

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22 SECTION 1. APPROPRIATIONS. There is hereby appropriated, to the
23 Department of Finance and Administration - Revenue Services Division, to be
24 payable from the State Central Services Fund, for personal services and
25 operating expenses of the Department of Finance and Administration - Revenue
26 Services Division which shall be supplemental and in addition to those funds
27 appropriated in Section 3 of Act 1121 of 1991 and Section 1 of Act 17 of the
28 First Extraordinary Session of 1992, for the remainder of the biennial period
29 ending June 30, 1993, the following:

11 SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
12 authorized by this Act shall be limited to the appropriation for such agency
13 and funds made available by law for the support of such appropriations; and
14 the restrictions of the State Purchasing Law, the General Accounting and
15 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
16 Procedures and Restrictions Act, or their successors, and other fiscal control
17 laws of this State, where applicable, and regulations promulgated by the
18 Department of Finance and Administration, as authorized by law, shall be
19 strictly complied with in disbursement of said funds.

21 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General
22 Assembly that any funds disbursed under the authority of the appropriations
23 contained in this Act shall be in compliance with the stated reasons for which
24 this Act was adopted, as evidenced by the Agency Requests, Executive
25 Recommendations and Legislative Recommendations contained in the budget
26 manuals prepared by the Department of Finance and Administration, letters, or
27 summarized oral testimony in the official minutes of the Arkansas Legislative
28 Council or Joint Budget Committee which relate to its passage and adoption.

30 SECTION 4. CODE. All provisions of this Act of a general and permanent
31 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
32 Code Revision Commission shall incorporate the same in the Code.

33

34 SECTION 5. SEVERABILITY. If any provision of this Act or the
35 application thereof to any person or circumstance is held invalid, such

1 invalidity shall not affect other provisions or applications of the Act which
2 can be given effect without the invalid provision or application, and to this
3 end the provisions of this Act are declared to be severable.

4

5 SECTION 6. GENERAL REPEALER. All laws and parts of laws in conflict
6 with this Act are hereby repealed.

7

8 SECTION 7. EMERGENCY CLAUSE. It is hereby found and determined by the
9 Seventy-Ninth General Assembly meeting in Regular Session, that funds provided
10 by the Seventy-Eighth General Assembly for the operations of the Department of
11 Finance and Administration - Revenue Services Division are, due to unforeseen
12 circumstances, insufficient for the Department of Finance and Administration -
13 Revenue Services Division to continue to provide essential governmental
14 services; that the provisions of this act will provide the necessary monies
15 for the Department of Finance and Administration - Revenue Services Division
16 to continue such services; and that a delay in the effective date of this Act
17 could work irreparable harm upon the proper administration and provision of
18 essential governmental programs. Therefore, an emergency is hereby declared
19 to exist and this Act being necessary for the immediate preservation of the
20 public peace, health and safety shall be in full force and effect from and
21 after the date of its passage and approval.
