## 7 **For An Act To Be Entitled**

8 "AN ACT TO AMEND ARKANSAS CODE ANNOTATED 14-56-413 TO  
9 REQUIRE THE APPROVAL OF EXTRA-TERRITORIAL ZONING  
10 ORDINANCES PASSED BY CITIES WITH A POPULATION OF ONE  
11 HUNDRED FIFTY THOUSAND (150,000) OR MORE BY *THE QUORUM*  
12 *COURT*; AND FOR OTHER PURPOSES."

## 14 **Subtitle**

15 "AN ACT TO REQUIRE THE APPROVAL OF EXTRA-TERRITORIAL  
16 ZONING ORDINANCES PASSED BY CITIES WITH A POPULATION OF  
17 150,000 OR MORE BY *THE QUORUM COURT*."

18

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20

21 SECTION 1. Arkansas Code Annotated 14-56-413 is amended to read as  
22 follows:

23 "14-56-413. Territorial jurisdiction.

24 (a) (1) (A) The territorial jurisdiction of the legislative body of the  
25 city having a planning commission, for the purpose of this subchapter, shall  
26 be exclusive and shall include all land lying within three (3) miles of the  
27 corporate limits.

28 (B) If the corporate limits of two (2) or more  
29 municipalities of the first or second class are less than ten (10) miles  
30 apart, the limits of their respective territorial jurisdictions shall be a  
31 line equidistant between them, or as agreed on by the respective  
32 municipalities.

33 (2) (A) Cities now having eight thousand (8,000) population or  
34 more and situated on navigable streams shall have the authority to administer  
35 and enforce planning and zoning ordinances outside their corporate limits as

1 follows:

(i) For cities of eight thousand (8,000) to fifty thousand (50,000) population, the jurisdictional area will be one (1) mile beyond the corporate limits;

11 (b) No city with a population in excess of one  
12 hundred fifty thousand (150,000) persons and which is situated on a navigable  
13 stream shall exercise any zoning authority *more than two (2) miles* inside the  
14 boundaries of the county wherein it is located without the approval of the  
15 quorum court of said county *nor* outside the boundaries of the county wherein  
16 it is located without the approval of the quorum court of the county wherein  
17 the city is not located and the approval of the governing bodies of all other  
18 cities having zoning authority over the area.

19 (B) The city populations will be based on the latest  
20 available United States census data.

21 (C) The provisions of this subdivision (a)(2) shall not  
22 restrict the powers of any city currently exercising the authority authorized  
23 under this subdivision.

24 (b) (1) The planning commission shall designate the area within the  
25 territorial jurisdiction for which it will prepare plans, ordinances, and  
26 regulations.

29

30 SECTION 2. All provisions of this act of a general and permanent nature  
31 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
32 Revision Commission shall incorporate the same in the Code.

33

34 SECTION 3. If any provision of this act or the application thereof to  
35 any person or circumstance is held invalid, such invalidity shall not affect

1 other provisions or applications of the act which can be given effect without  
2 the invalid provision or application, and to this end the provisions of this  
3 act are declared to be severable.

5 SECTION 4. All laws and parts of laws in conflict with this act are  
6 hereby repealed.
