For An Act To Be Entitled

8 "AN ACT TO OFFICIALLY DESIGNATE THE ROUTE ALONG U.S.
9 HIGHWAY 67 AND SCENIC HIGHWAY 7 BETWEEN HOPE, ARKANSAS,
10 BILL CLINTON_S BIRTHPLACE, AND HOT SPRINGS, ARKANSAS, THE
11 PRESIDENT_S BOYHOOD HOME AS _THE HIGHWAY OF HOPE_; AND FOR
12 OTHER PURPOSES."

Subtitle

15 "DESIGNATING THE ROUTE BETWEEN HOPE, ARKANSAS, AND HOT
16 SPRINGS, ARKANSAS, AS _THE HIGHWAY OF HOPE_."

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19

20 SECTION 1. Hereafter, the route along U.S. Highway 67 and Scenic
21 Highway 7 between Hope, Arkansas, and Hot Springs, Arkansas, regularly
22 traveled by the Honorable Bill Clinton, 48th President of the United States,
23 during his childhood, is hereby designated "The Highway of Hope".

24

25 SECTION 2. The Arkansas Highway and Transportation Department shall
26 erect appropriate signs along U. S. Highway 67 and Scenic Highway 7 between
27 Hope, Arkansas, and Hot Springs, Arkansas, designating it as "The Highway of
28 Hope".

29

30 SECTION 3. It is the intent and purpose of this act to encourage
31 visitors to the state to venture off the interstate highways and to enjoy more
32 of Arkansas_ scenic beauty and experience the culture found along its
33 highways. It is further the intent and purpose of this act to request the
34 Arkansas Highway and Transportation Department to erect appropriate signs
35 along the route described and to thereby assist small communities along the

1 route to develop tourism.

2

3 SECTION 4. All provisions of this act of a general and permanent nature
4 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
5 Revision Commission shall incorporate the same in the Code.

6

7 SECTION 5. If any provision of this act or the application thereof to
8 any person or circumstance is held invalid, such invalidity shall not affect
9 other provisions or applications of the act which can be given effect without
10 the invalid provision or application, and to this end the provisions of this
11 act are declared to be severable.

12

13 SECTION 6. All laws and parts of laws in conflict with this act are
14 hereby repealed.
