HOUSE BILL

For An Act To Be Entitled

8 "AN ACT TO ESTABLISH THE CAPITOL BUILDING CONSTRUCTION
9 COMMITTEE; TO PRESCRIBE THE AUTHORITY AND RESPONSIBILITY
10 OF THE COMMITTEE; AND FOR OTHER PURPOSES."

Subtitle

13 "CREATING THE CAPITOL CONSTRUCTION COMMITTEE."

15 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

17 SECTION 1. There is hereby created the Capitol Building Construction
18 Committee. The committee shall consist of the Secretary of State, who shall
19 be chairman, the President Pro Tempore of the Senate or his designee, the
20 Speaker of the House of Representatives or his designee, and one Senate member
21 and one House member of the Legislative Facilities Committee selected by the
22 committee.

24 SECTION 2. It shall be the responsibility of the committee to review
25 all proposed construction, renovation or repair in or to the State Capitol
26 Building which involves a total cost of seven thousand five hundred dollars
27 (\$7,500) or more.

29 SECTION 3. No office or agency, except the Secretary of State, shall
30 undertake any construction, renovation or repair in or to the Capitol Building
31 which involves a total cost of seven thousand five hundred dollars (\$7,500) or
32 more unless the proposed project is first submitted to the committee for
33 review and approval.

34 The committee shall review the proposed construction, renovation or
35 repair for the purpose of assuring that the architectural integrity of the

1 building will not be jeopardized, that structural damage will not occur, that
2 the project will not result in interruption of utility services or other
3 services to the various agencies housed in the Capitol Building and that the
4 proposed construction, renovation or repair will not otherwise be detrimental
5 to the Capitol Building or to the agencies housed in the building.

7 SECTION 4. All provisions of this act of a general and permanent nature
8 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
9 Revision Commission shall incorporate the same in the Code.

10

11 SECTION 5. If any provision of this act or the application thereof to
12 any person or circumstance is held invalid, such invalidity shall not affect
13 other provisions or applications of the act which can be given effect without
14 the invalid provision or application, and to this end the provisions of this
15 act are declared to be severable.

16

17 SECTION 6. All laws and parts of laws in conflict with this act are
18 hereby repealed.
