HOUSE BILL 2037

For An Act To Be Entitled

8 "AN ACT TO AMEND ARKANSAS CODE 5-4-323 RELATING TO THE
9 REQUIREMENT THAT PERSONS CONVICTED OF CERTAIN OFFENSES
10 MAKE GOOD FAITH EFFORTS TO EARN A HIGH SCHOOL DIPLOMA OR
11 GED CERTIFICATE AS A CONDITION OF SUSPENSION OF SENTENCE
12 OR PROBATION; AND FOR OTHER PURPOSES."

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Arkansas Code 5-4-323 as amended by Act 343 of 1993, is
22 amended to read as follows:

23 "5-4-323. Additional conditions - High school diploma or GED
24 certificate.

25 (a) (1) (A) As an additional requirement for suspension of sentence or
26 probation, the court shall require any person who is convicted of a felony or
27 Class A misdemeanor to make a good faith effort towards completion of a high
28 school diploma or a General Education Development (GED) certificate unless the
29 person has already achieved the diploma or certificate.

30 (B) Such requirement shall be implemented only upon the
31 acceptance of the person by the administrative head of the school or program.

32 (C) If no appropriate school or program can be found, the
33 requirement is of no effect.

34 (2) The court, after consultation with the school or program,
35 shall determine the appropriate documentation for those individuals

1 participating under the provisions of this section and shall report all
2 documentation of program participation on a quarterly basis to the
3 Administrative Office of the Courts who shall then report to the Governor's
4 Commission on Adult Literacy.

5 (b) The court shall not revoke a suspension of sentence or probation
6 because of the person's inability to achieve the degree or certificate but
7 shall revoke a suspension or probation if the person fails to make a good
8 faith effort to achieve the degree or certificate.

9 (c) A good faith effort means the person has been enrolled in a
10 program of instruction and is attending school.

11 (d) Any person who fails to make a good faith effort to comply with a
12 court order issued pursuant to this section shall be guilty of an unclassified
13 misdemeanor and shall be punished by a fine of at least one hundred dollars
14 (\$100) but not more than one thousand dollars (\$1,000)."

15

16 SECTION 2. All provisions of this act of a general and permanent nature
17 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
18 Revision Commission shall incorporate the same in the Code.

19

20 SECTION 3. If any provision of this act or the application thereof to
21 any person or circumstance is held invalid, such invalidity shall not affect
22 other provisions or applications of the act which can be given effect without
23 the invalid provision or application, and to this end the provisions of this
24 act are declared to be severable.

25

26 SECTION 4. All laws and parts of laws in conflict with this act are
27 hereby repealed.
