# A Bill

**HOUSE BILL**

## **For An Act To Be Entitled**

8 "AN ACT TO INCREASE THE OFFICIAL CERTIFICATE OF INSPECTION  
9 FEE BY ONE DOLLAR (\$1.00) AND THE SAFETY INSPECTION FEE BY  
10 ONE DOLLAR FIFTY CENTS (\$1.50) WITH THE PROCEEDS OF THE  
11 OFFICIAL CERTIFICATE OF INSPECTION FEE TO GO TO THE  
12 ARKANSAS NATURAL AND CULTURAL RESOURCES COUNCIL TO BE USED  
13 TO PAY PRINCIPAL AND INTEREST ON ANY EXISTING OR FUTURE  
14 BOND INDEBTEDNESS OF THE COUNCIL; AND FOR OTHER PURPOSES."

## **Subtitle**

17 "TO INCREASE THE CERTIFICATE OF INSPECTION FEE BY ONE  
18 DOLLAR (\$1.00) AND THE SAFETY INSPECTION FEE BY ONE DOLLAR  
19 FIFTY CENTS (\$1.50)."

21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22  
23 SECTION 1. (a) In addition to the fee levied under Arkansas Code  
24 Annotated §27-32-110(b)(3), there is levied an additional fee of one dollar  
25 (\$1) for an official certificate of inspection and approval to be collected in  
26 the same manner and at the same time as is prescribed by law for collection of  
27 the fee levied under Arkansas Code Annotated §27-32-110(b)(3).

28 (b) All amounts collected pursuant to this act for the purchase of  
29 certificates of inspection shall be deposited in the State Treasury as special  
30 revenues and shall be credited to the Arkansas Natural and Cultural Resources  
31 Grants and Trust Fund to be used by the Council to pay principal and interest  
32 on any existing or future bond indebtedness of the Council.

33  
34 SECTION 2. Arkansas Code Annotated §27-32-112(b) is amended to read as  
35 follows:

1           "(b)(1) The fee for the inspection, including the issuance of the  
2 certificate of approval, shall be five dollars (\$5.00), with the exception of  
3 all motor trucks, trailers, semitrailers, and pole trailers in excess of gross  
4 loaded weight of eight thousand pounds (8,000 lbs.).

5           (2) The fee for inspection, including the issuance of the certificate of  
6 approval, for all motor trucks, trailers, semitrailers, and pole trailers with  
7 a gross loaded weight in excess of eight thousand pounds (8,000 lbs.) shall be  
8 under rules and regulations prescribed by the director but shall be not less  
9 than five dollars (\$5.00) nor more than twenty-five dollars (\$25.00) per  
10 inspection."

12           SECTION 3. All provisions of this act of a general and permanent nature  
13 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
14 Revision Commission shall incorporate the same in the Code.

16           SECTION 4. If any provision of this act or the application thereof to  
17 any person or circumstance is held invalid, such invalidity shall not affect  
18 other provisions or applications of the act which can be given effect without  
19 the invalid provision or application, and to this end the provisions of this  
20 act are declared to be severable.

21

22           SECTION 5. All laws and parts of laws in conflict with this act are  
23 hereby repealed.

25           SECTION 6. EMERGENCY. It is hereby found and determined by the General  
26 Assembly that the provisions of this act are of critical importance to the  
27 state's ability to continue the duties, responsibilities, and functions of the  
28 Arkansas Natural and Cultural Resources Council. Therefore, an emergency is  
29 declared to exist, and this act being immediately necessary for the  
30 preservation of the public peace, health, and safety shall be in full force  
31 and effective from and after its passage and approval.
