8	"AN ACT TO ESTABLISH A COMPREHENSIVE FIRE SERVICES OFFICE
9	TO MANAGE, COORDINATE AND ADMINISTER THOSE PUBLIC SAFETY
10	FUNCTIONS RELATED TO STATE RESPONSIBILITIES FOR FIRE
11	PREVENTION, FIRE TRAINING, FIRE MITIGATION, STANDARDS AND
12	CERTIFICATIONS, AND OTHER FUNCTIONS RELATED TO FIRE
13	FIGHTING BY STATE, COUNTY AND MUNICIPAL GOVERNMENTS AND TO
14	ENSURE THE MOST EFFECTIVE AND ECONOMICAL USE OF PERSONNEL,
15	EQUIPMENT AND RESOURCES IN FIRE SERVICES TO PROTECT THE
16	HEALTH, SAFETY, AND WELFARE OF THE CITIZENS OF ARKANSAS
17	AND THEIR PROPERTY, PRIVATE AND PUBLIC, FROM THE RAVAGES
18	OF ACCIDENTAL OR UNCONTROLLED FIRES AND OTHER RELATED
19	SERVICES; AND FOR OTHER PURPOSES."

21	Subtitle
22	"ARKANSAS COMPREHENSIVE FIRE PROTECTION ACT OF 1993."
23	
24	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
25	
26	SECTION 1. Short title. This act may be cited as the "Arkansas
27	Comprehensive Fire Protection Act of 1993."
28	
29	SECTION 2. Policy and Purpose. Because of the existing and increasing
30	occurrence of fires that damage and destroy the public and private property of
31	the citizens of Arkansas and because of the increase in population and
32	structures that form the residences, businesses and institutions of this
33	state, its business, industrial and environmental resources and threaten the
34	safety, health and welfare of its citizens, it is hereby found and declared to
35	be necessary:

- 1 (1) to facilitate the cooperation and efficient coordination of the
- 2 current state functions related to fire prevention, training and management
- 3 through the Office of Fire Protection Services for more effective and
- 4 economical use of existing personnel, equipment, facilities and resources;
- 5 (2) to provide a fire services management system to be responsive to
- 6 local government for current and future fire services needs related to
- 7 continued population and economic growth;
- 8 (3) to direct the designation of fire protection services liaisons
- 9 within each affected state department or agency and each local government;
- 10 (4) to prepare, develop, formulate, and engage in a comprehensive
- 11 program for the orderly coordination, cooperation and development of fire
- 12 protection service resources of the State of Arkansas and its local
- 13 governments, to be referred to as the Arkansas Fire Protection Service
- 14 Resources Plan.

- 16 SECTION 3. Definitions. As used in this act, unless the context
- 17 otherwise requires:
- 18 (1) "Fire services" means those functions of fire fighting, fire
- 19 prevention, fire mitigation, fire training, and fire administration performed
- 20 by rural or municipal, volunteer or paid professional fire fighters and fire
- 21 departments created in accordance with the laws of the State of Arkansas.
- 22 (2) "Fire prevention" means, but is not limited to, those actions taken
- 23 directly, or indirectly by an entity of state, county or municipal government
- 24 to prevent the occurrence of fire whether the result of accident or through
- 25 arson.
- 26 (3) "Fire mitigation" means, but is not limited to, those activities
- 27 designed to lessen the impact of fire upon structures, persons or the natural
- 28 environment.
- 29 (4) "Fire training" refers to those teaching, educational, or training
- 30 activities conducted to improve the ability of an individual, or a fire
- 31 department, to contain, suppress or otherwise reduce the danger incurred from
- 32 fire, and includes not only technical training on the use of equipment and
- 33 resources for fire suppression, but those administrative, training, fiscal and
- 34 other programs designed to enhance an individual s or a fire department s
- 35 ability to perform its assigned duties.

- 1 (5) "Adjunct services" as used in this act refers to those activities 2 related to, or performed by, fire service agency such as hazardous/toxic
- 3 materials response and recovery, search and rescue, and such other functions
- 4 as may be assigned, or reasonably expected of local fire service agency.
- 5 (6) "Local government" means a county, city of the first class, city of
- 6 the second class, or an incorporated town, a fire protection district, a
- 7 subordinate service district of a county, or an improvement district organized
- 8 to provide fire services or any other fire department created in accordance
- 9 with the laws of the State of Arkansas.

- 11 SECTION 4. State Office of Fire Protection Services.
- 12 (a) The State Office of Fire Protection Services, as established by Act
- 13 280 of 1993, shall have the following duties and functions:
- 14 (1) to be responsible to carry out the administrative functions and
- 15 directives of the Fire Protection Services Board and manage those activities
- 16 prescribed for the Board under the provisions of Act 833 of 1991;
- 17 (2) to act as coordinator of the activities for the programs and
- 18 functions prescribed under this act;
- 19 (3) to act as point of contact for the State of Arkansas concerning
- 20 federal, state and local fire service related programs.
- 21 (4) to advise and direct the designation of fire service liaisons
- 22 within each affected state department or agency and each local government;
- 23 (5) to prepare, publish, and keep current a listing of the various fire
- 24 service agencies of the State and its local governments and the fire fighting,
- 25 prevention, training, mitigation, and adjunct services they are trained and
- 26 equipped to perform;
- 27 (6) to facilitate and coordinate the preparation, formulation, and
- 28 development of the Arkansas Fire Service Resources Plan, a comprehensive plan
- 29 for the orderly coordination, cooperation and development of fire service
- 30 resources of the State of Arkansas and its local governments.
- 31 (b) The State Office of Fire Protection Services shall have such
- 32 professional, technical, secretarial, and administrative, and secretarial
- 33 employees and may make the expenditures within the appropriation therefor made
- 34 available to it from whatever sources for the purpose of fire service
- 35 coordination as may be necessary to carry out the functions of this act.

- 1 (c) The State Office of Fire Protection Services shall coordinate the
- 2 activities prescribed under this act and shall cooperate with and receive
- 3 cooperation from the following fire service agencies of the State of Arkansas:
- 4 (1) The State Fire Marshal, who is responsible for providing the
- 5 services and functions related to the investigation of arson and enforcement
- 6 of arson laws, fire safety, public awareness and such other functions as may
- 7 be specified by law for the office.
- 8 (2) The Arkansas Fire Training Academy, which shall provide such
- 9 fire services and adjunct training and education services as required to
- 10 ensure the maximum possible professionalism and competence of fire fighters in
- 11 Arkansas.
- 12 (3) The Rural Fire Protection Service of the Arkansas Forestry
- 13 Commission, which shall provide refurbished and repaired vehicles and other
- 14 equipment for fire fighting operations and provides technical assistance and
- 15 guidance to rural fire protection districts.
- 16 (d) All state agencies involved in fire services, including the State
- 17 Fire Marshal, the Arkansas Fire Training Academy, and the Rural Fire
- 18 Protection Service, and all fire service agencies of local governments shall
- 19 cooperate to the fullest extent possible with the State Office of Fire
- 20 Protection Services in the performance of their duties and functions under
- 21 this act.

- 23 SECTION 5. Arkansas Fire Advisory Board.
- 24 (a) There shall be established by this act the Arkansas Fire Advisory
- 25 Board, which shall be merged with the existing Fire Protection Services Board
- 26 created in Act 837 of 1987, Arkansas Code § 20-22-803. The Arkansas Fire
- 27 Advisory Board shall consist of thirteen (13) members comprised as follows:
- 28 (1) nine (9) members of the Fire Protection Services Board who
- 29 shall be appointed and whose terms shall be as provided for in Act 837 of
- 30 1987, Arkansas Code § 20-22-803; and
- 31 (2) four (4) members consisting of two (2) persons representing
- 32 municipal fire services and two (2) persons representing rural volunteer fire
- 33 services, who shall be appointed by the Governor for a term of three (3) years
- 34 and whose terms shall be staggered so one (1) serves an initial term of one
- 35 (1) year, one (1) serves an initial term of two (2) years, and two (2) serve

- 1 initial terms of three (3) years; and
- 2 (3) one (1) member who is the Director, State Office of Emergency
- 3 Services and who shall serve as chairman of the Board.
- 4 (b) The Advisory Board shall advise the Director, State Office of
- 5 Emergency Services and the Administrator, Office of Fire Protection Services
- 6 on matters concerning the training, certification and standards related to
- 7 fire services in the State of Arkansas and advise the Office of Fire
- 8 Protection Services in the development and formulation of the Arkansas Fire
- 9 Service Resources Plan.
- 10 (c) The Advisory Board shall periodically review and evaluate current
- 11 and proposed national and international activities related to the improvement
- 12 and upgrading of fire services to ensure the State maintains the maximum
- 13 possible standards of fire protection for its citizens and standards for
- 14 training for its fire fighters.

- 16 SECTION 6. Arkansas Fire Protection Service Resources Plan.
- 17 (a) The State Office of Fire Protection Services shall facilitate and
- 18 coordinate, with the cooperation and assistance of the fire service agencies
- 19 listed in Section 4 (c) of this act, the development and formulation of a
- 20 comprehensive program for the orderly coordination, cooperation and
- 21 development resources of the State of Arkansas and its local governments, to
- 22 be referred to as the Arkansas Fire Protection Service Resources Plan. The
- 23 Arkansas Fire Protection Service Resources Plan shall include plans:
- 24 (1) for providing fire services in the various rural areas of
- 25 this state which do not have available the benefits or services of an
- 26 organized or voluntary fire fighting program;
- 27 (2) for updating and improving fire services in urban, suburban,
- 28 and rural areas which have fire services, but need improvements, and to assist
- 29 existing organized or volunteer fire fighting services in making those
- 30 improvements;
- 31 (3) on the type, needs, and means to procure fire fighting
- 32 vehicles and equipment for fire service agencies of local governments;
- 33 (4) on developing training programs designed to instruct and
- 34 train fire fighters at the State Fire Training Academy to be employed or used
- 35 by both urban and rural organized and volunteer fire service agencies;

- 1 (5) to coordinate the efforts of all State and local government
- 2 fire service agencies for the purpose of making maximum use of the services
- 3 and resources for the prevention and mitigation of injury and damage caused by
- 4 fire and other hazards;
- 5 (6) to measure the prompt and effective response to fires and
- 6 other hazards and disasters;
- 7 (7) to identify areas particularly vulnerable to fire and hazards
- 8 and other disasters; and
- 9 (8) to make recommendations for improvements in the fire
- 10 fighting, prevention, training, mitigation, and adjunct services for State and
- 11 local fire service agencies.
- 12 (b) In coordinating the preparation and revision of the Arkansas Fire
- 13 Protection Service Resources Plan, the Office of Fire Protection Services
- 14 shall seek the advice and assistance of and cooperate with State agencies,
- 15 including the State Fire Marshal, the Arkansas Fire Training Academy, and the
- 16 Rural Fire Protection Service, and all fire service agencies of local
- 17 governments, and business, labor, industry, agriculture, civic and volunteer
- 18 organizations, and community leaders.
- 19 (c) The Arkansas Fire Protection Service Resources Plan or any part
- 20 thereof may be incorporated in regulations of the State Office of Fire
- 21 Protection Services, the Office of Emergency Services or executive orders
- 22 which have the force and effect of law.

- 24 SECTION 7. State and local government agencies Liaison officers.
- 25 (a) It is directed by this act that the head of each State agencies
- 26 with fire services, including the State Fire Marshal, the Arkansas Fire
- 27 Training Academy, and the Rural Fire Protection Service, and all fire service
- 28 agencies of local governments shall appoint a member or members of his staff
- 29 as fire service liaison officer or officers to act on his behalf in
- 30 coordinating and insuring the agency's capability to fulfill its role in fire
- 31 service activities.
- 32 (b) It will be the responsibilities of this officer to:
- 33 (1) maintain close and continuous liaison with the State Office
- 34 of Fire Protection Services as applicable;
- 35 (2) prepare agency operations plan in cooperation with this act

- 1 and with the State Office of Fire Protection Services;
- 2 (3) submit a list of the various fire fighting, prevention,
- 3 training, mitigation, and adjunct services the agency is trained and equipped
- 4 to perform;
- 5 (4) maintain files of agency resources to include personnel,
- 6 facilities, and equipment available for fire service and adjunct service
- 7 operations;
- 8 (5) submit a semiannual report to the office of the various fire
- 9 fighting, prevention, training, mitigation, and adjunct services the agency is
- 10 trained and equipped to perform;
- 11 (6) insure that the agency can respond promptly and cooperatively
- 12 with other agencies in any fire fighting situations or major emergency
- 13 situation under the procedures cooperatively agreed to in the Arkansas Fire
- 14 Protection Service Resources Plan and coordinated by the State Office of Fire
- 15 Protection Services; and
- 16 (7) perform other related functions necessary to carry out the
- 17 purpose of this act.
- 18 (c) Nothing in the foregoing shall be interpreted as relieving or
- 19 otherwise abridging the responsibility and authority of any State or local
- 20 agency directors in carrying out the fire service and adjunct service
- 21 operations for which their agencies are solely responsible.

- 23 SECTION 8. Utilization of existing services and facilities.
- All fire service agencies of the State, including the State Fire
- 25 Marshal, the Arkansas Fire Training Academy, and the Rural Fire Protection
- 26 Service, and all fire service agencies of local governments shall, to the
- 27 maximum extent practicable, utilize services, facilities, equipment and
- 28 personnel of their existing departments, offices and agencies to carry out the
- 29 provisions of this act.

30

- 31 SECTION 9. All provisions of this act of a general and permanent nature
- 32 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
- 33 Revision Commission shall incorporate the same in the Code.

35 SECTION 10. If any provision of this act or the application thereof to

1 any person or circumstance is held invalid, such invalidity shall not affect
 2 other provisions or applications of the act which can be given effect without
 3 the invalid provision or application, and to this end the provisions of this
 4 act are declared to be severable.
         SECTION 11. All laws and parts of laws in conflict with this act are
 7 hereby repealed.
 8
 9
         SECTION 12. Emergency. It is hereby found and determined by the
10 Seventy-Ninth General Assembly of the State of Arkansas that the Office of
11 Fire Protection Services needs to coordinate the current state functions
12 related to fire prevention, training and management to more effectively and
13 economically use existing personnel, equipment, facilities and resources; that
14 a fire services management system which is responsive to local government for
15 current and future fire services needs to be related to continued population
16 and economic growth; that the State of Arkansas needs to develop and formulate
17 a comprehensive plan for the orderly management and development of fire
18 protection service resources of the State of Arkansas and its local
19 governments; and that this act is designed to accomplish these functions and
20 should be given effect immediately. Therefore, an emergency is hereby
21 declared to exist, and this act being necessary for the immediate
22 preservation of the public peace, health, and safety, shall be in full force
23 and effect from and after its passage and approval.
