15 WHEREAS, Dr. Guy U. Robinson faithfully served the community of Dumas,
16 Arkansas as a family practitioner for forty-four (44) years before his death
17 on February 5, 1993;

19 WHEREAS, Dr. Robinson was a charter member of the American Academy of
20 Family Practice, a past president of the Arkansas Academy of Family Practice
21 and an active member of the Arkansas Medical Society;

23 WHEREAS, Dr. Robinson's extensive civic service included terms as
24 presidents of the Dumas School Board, the Dumas Lion's Club and the Dumas
25 Chamber of Commerce;

27 WHEREAS, Dr. Robinson also distinguished himself with service to his
28 community as an alderman on the Dumas City Council, as a Boy Scout
29 committeeman and as a Mason;

31 WHEREAS, Dr. Robinson invested thirty (30) years of his life as a
32 medical officer in the United States Army and Arkansas National Guard where he
33 rose to the rank of Colonel and was awarded the Commendation Medal; and

35 WHEREAS, Dr. Robinson exemplified the best in the medical profession and

1 in his commitment to service to his community, his state and his nation,
