25 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE SEVENTY-NINTH GENERAL  
26 ASSEMBLY OF THE STATE OF ARKANSAS:

28 SECTION 1. The Chairman of the House Rules Committee is requested to  
29 appoint six (6) members of the Rules Committee and the Speaker of the House of  
30 Representatives is requested to appoint six (6) members of the House, with at  
31 least four (4) members serving their first or second term in the House, to an  
32 ad hoc committee to study the House rules and any rule changes that might be  
33 necessary as a result of the term limitation amendment and report to the  
34 entire House on or before March 1, 1993.
